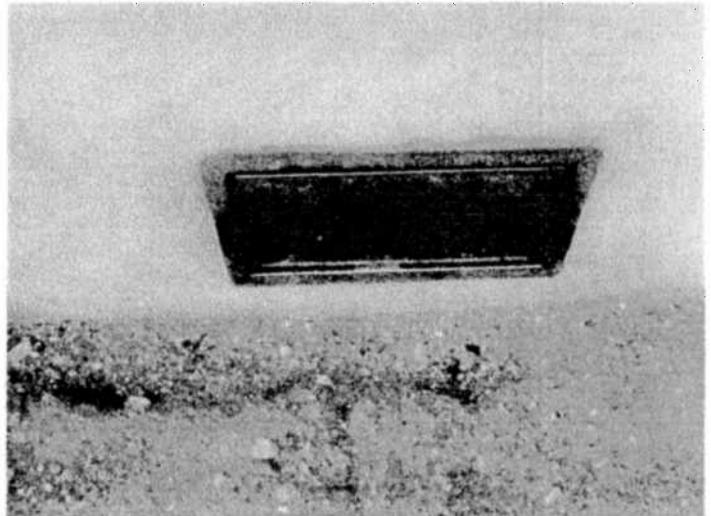

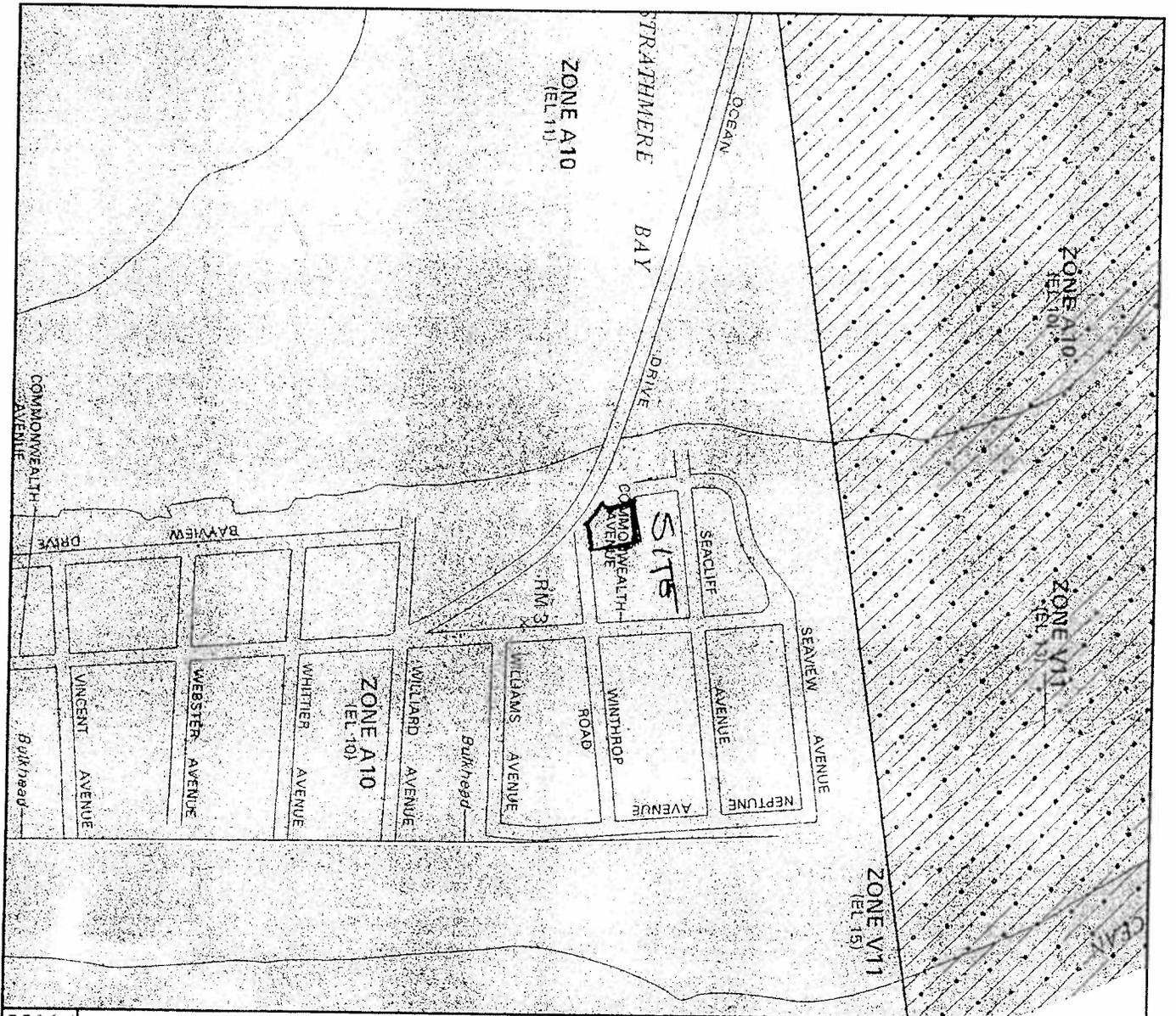
Rear View
