**APPROVAL OF MINUTES - **July 12, 2010 Regular Meeting and
Closed Session Minutes****

Motion was made by Jay Newman, seconded by Frank Conrad to approve the Regular Meeting and Closed Session Minutes as submitted. During roll call vote, all five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Kristine Gabor: Reported that she is working with Paul Dietrich, Superintendent of Public works on several ideas for Amanda’s Field. She also reported that an inspection of the Fort Nuwi Playground by Township Playground Inspectors revealed significant damage due to natural wear and tear of the wood with portions of it being temporarily closed for those repairs. At this time only the toddler swing portion of the playground needs to be closed during the repair.

Frank Conrad: Reported that the Tuckahoe Merchants Annual Canoe and Kayak race is set for August 1, 2010 beginning at 11:00 AM.

Jay Newman: Reported on the severe rainstorms that occurred last night and that although there were power outages there was no significant damage from the storms. He also reported that the Township sent an ambulance to Ocean City on Saturday to assist during the Night in Venice Boat Parade.

Mayor Palombo: reported on the positive reception received for the new program instituted this summer that posts an EMT at the Lifeguard Station in Strathmere after hours to assist the

Rescue Squad with calls on and off the beach. The program is working out very well and has assisted on several calls.

OTHER REPORTS

Daniel J. Young, Municipal Attorney: Reported on a letter received from the Business Administrator of the Upper Township School District. They requested that the Committee consider a resolution to support their efforts to allow the Upper Township School Board members that presently sit on the Ocean City School District Board to be allowed to vote on internal matters on that Board (the Ocean City Board). Motion was made by Curtis Corson, seconded by Frank Conrad to authorize a resolution in support of that request. During roll call vote four Committee members voted in the affirmative. Jay Newman abstained. Mr. Young also reported that he had two items for Closed session that being a Personnel matter, and a Contract Negotiation item for Land Sale Appraiser.

Paul Dietrich, Municipal Engineer: Gave an update on a meeting scheduled in August with ISO specialists to inspect the Township's Flood Plan Management records. This is the final step in submitting the application for the Township to get into the CRS (Community Rating System) which should give us a better rating and result in lower flood insurance costs. Mr. Dietrich further reported that Dept. of Public Works Dept. employees Christopher Thomas and Thomas Woolly have completed the required classes for Certified Public Works Manager required to sit for the state exam in the fall.

ORDINANCE NO. 006-2010

AN ORDINANCE VACATING A PORTION OF THAT PAPER STREET KNOWN AS
THE ALLEY IN BLOCK 827 ADJACENT TO LOT 3, WITHIN THE TOWNSHIP OF
UPPER, COUNTY OF CAPE MAY AND STATE OF NEW JERSEY

WHEREAS, N.J.S.A. 40:67-1 authorizes the Governing Body of a municipality to adopt an Ordinance, among other things, to vacate any street, highway, lane, alley, square, place or park, or any part thereof, dedicated to public use but not accepted by the municipality, whether or not the same, or any portion, has been actually opened or improved; and

WHEREAS, Jeffrey S. Rue, Christine F. Rue, Robert J. Fagan, Sr. and Rose L. Fagan are the owners of Block 827, Lots 2 and 3 and have requested that the Township vacate a portion of a certain street described in this Ordinance and have agreed to pay the costs incurred by the Township to vacate said alley; and

WHEREAS, the Township Committee has duly considered the matter and it appears reasonable to agree to the request since there is no present or foreseeable need or intention to utilize said roadway; and

WHEREAS, it is deemed to be in the public interest to vacate a portion of Atlantic Avenue within the Township of Upper, as hereinafter provided.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

WHEREAS, the Township Committee has determined it is in the best interests of the Township that the function of maintaining the Township's athletic fields and courts, parks, playgrounds and recreational facilities shall be incorporated as part of the Department of Public Works; and

There shall also be working foreman/assistant supervisors consisting of Supervising Equipment Operator, Supervising Carpenter, Supervising Maintenance Repairer and Supervisor Recreation Maintenance, who will be responsible for supervising work crew(s) as assigned by the Road Supervisor and/or Assistant Road Supervisor. These employees shall be appointed by the Township Committee as it deems appropriate and who shall constitute the management of the Department and shall be considered management employees.

- d. Other Management Personnel, Qualifications and Duties.
 1. Qualifications. The Road Supervisor and Assistant Road Supervisor, as may be appointed by Township Committee, shall be qualified by training and experience in general public works administration and shall have prior experience in a public works supervisory capacity. They shall be required to obtain and

maintain certification as a Certified Public Works Manager as administered by the Department of Community Affairs, Division of Local Government Services. In addition, they shall also meet the minimum qualifications established for that position by the Department of Personnel.

2. Duties. The Road Supervisor and Assistant Road Supervisor shall perform such duties as prescribed by the Township Committee or the Superintendent of Public Works, as well as such duties as may be prescribed by law.

e. Functions of Department. The Department of Public Works shall perform all appropriate functions associated with:

1. Maintaining, constructing and reconstructing streets and drainage facilities.
2. Maintaining public buildings and grounds, including recreation areas and public beaches.
3. Maintaining all motorized equipment.
4. Installing, repairing and maintaining traffic signals and signs.
5. Supervising solid waste collection, disposal and recycling.
6. Supervising snow removal.
7. Such other duties as the Township Committee may prescribe.

The Recreational Program Coordinator shall have a general knowledge of the recreation activities of the Township, possess a valid New Jersey driver's license and otherwise meet the minimum qualifications established by the New Jersey Department of Personnel.
 - 2. Duties. The member of the Township Committee serving as Director of the Department of Sports and Recreational Programs shall take an active role in the supervision and direction of the Department. The Recreational Program Coordinator shall

The Committee discussed their concerns in that it appears that last year the Reagan's misrepresented their event. There were over 150 more participants at the event last year than were approved in the resolution. Another major concern is that paperwork for only 2 lifeguards was submitted. Also discussed were concerns with parking, in particular Upper Rescue Chief Jay Potter was concerned that there be no parking on Harbor Road. In previous years the unauthorized parking limited access to the residents in the area and was a safety hazard. Sgt. Fran Donlan of the NJ State Police Assist. Woodbine Station Commander was also present to address issues with regard to traffic control on the designated course. He reported CityTri has a contract for 8 Troopers for traffic control stationed only in the designated areas as stipulated in the contract. These are off duty Troopers; Sgt. Donlan assured the Committee that a full complement of Troopers would be on duty to cover the Township for anything else that may occur. The Committee directed that the event be limited to 300 registrants. The Reagan's have assured the Committee that they have the personnel to manage the event should they experience another emergency such as last year. They will work with the County Health Dept. in the serving of food. They have submitted paperwork for a total of four lifeguards for this event. Event setup the previous day cannot begin until after 6:30 PM because of Boat Ramp patrons. There is no use of Township equipment for the event. The Committee directed Municipal Attorney Young to prepare a resolution for the August 9, 2010 meeting consistent with past requirements including a limit on the number of registrants to three hundred (300).
