# **APPROVAL OF MINUTES** - September 13, 2010 Regular Meeting and

Closed Session Minutes Motion was made by Jay Newman, seconded by Frank Conrad to approve the Regular Meeting and Closed Session Minutes as submitted. During roll call vote, all five Committee members voted in the affirmative.

### REPORT OF GOVERNING BODY MEMBERS

Kristine Gabor: reported on Animal Control items in that she attended a recent meeting of the Cape May County Animal Shelter Advisory Board and that their Spay and Neuter program is progressing satisfactorily. With regards to Recreation she reported that she is recommending a five person Recreation Advisory Board which would consist of the Recreation Department Head which is herself and four Township residents. It was presented to the Recreation Committee this past week and after much discussion was approved by a majority vote. The Recreation Committee will no longer be an official committee of the Township and last Thursday was their last meeting. She discussed the responsibility of the Advisory Board. She requested permission from the Committee to move forward and work with the Township Attorney on getting together a resolution (or ordinance if necessary). The reason for the changes is that the Supervisor is retiring and we have no plans to replace her so we need to streamline our process and make it as efficient as possible. Also, it is important to have an Advisory Board that maintains objectivity concerning Recreation. She put that in the form of a motion and Frank Conrad seconded with all five Committee members voting in the affirmative. It was discussed that the Township Committee would appoint the Advisory Committee. It was discussed that a draft of the rules and regulations should be available for prospective Advisory Board members so that they are clear of what is expected.

**Jay Newman:** He reported that the annual Fire Prevention Awareness week will be observed in Upper Township Schools on October  $5^{th}$  and  $6^{th}$  with fire safety and prevention activities. Also, on the

evening of October 6<sup>th</sup> the Marmora Fire Department will host a Fire Prevention program at the Marmora Fire House from 5:30 p.m. to 7:30 p.m. He invited everyone to attend.

**Frank Conrad:** discussed the possibility of selling the former Township Hall building and ordering an appraisal of the property. It was discussed that a commercial appraisal would be more costly than a residential. Mr. Dietrich will research the matter further and report to the Committee at a future meeting.

Richard Palombo: reported on a request from Steven Martinelli and the Upper Township Business Association for revisions to the Upper Township sign Ordinance. Mayor Palombo referred the matter to the Planning Board for their consideration. The Mayor also discussed a request from Ralph Holt, and a letter received from the County to rezone certain Tuckahoe Road properties as Commercial. He reported that he spoke to Freeholder Director Beyel and the future county plan is a proposal to include a signal light at the Church in order to address traffic issues and the area's future development. Mayor Palombo referred the matter to the Planning Board to request their input and recommendations. Mr. Palombo also reported on a recent meeting he attended with the Ocean City/Upper Township Noon Rotary Club at which the members discussed an initiative to start a new program entitled "Angel Associates". The program would provide free support services to parents and siblings who are dealing with drug addiction and/or alcohol abuse as well as providing the most up to date information for parents on warning signs, drug testing, and treatment. The Rotary Club is hoping to see this program go countywide.

### **OTHER REPORTS**

**Daniel Young, Municipal Attorney:** reported that he has several items for closed session: Litigation Grubb v. Upper Township, a matter of Contract negotiations with respect to NIA Group for employee benefits consultant services, and a Personnel hearing matter.

**Paul Dietrich, Municipal Engineer:** requested permission to hire a part time Laborer. The Committee directed that the matter be looked at again later when more information is available about the injury status of members of the workforce. He also recommended putting several items that are no longer needed for Township use up for sale on an online auction. Motion was made by Curtis Corson, seconded by Frank Conrad to dispose of the surplus equipment through the use of an online auction. During roll call vote all five Committee members voted in the affirmative. A resolution will be placed on a future agenda.

# **PRESENTATION**

1. Upper Township Board of Education--presentation of the UTBE's building initiative for a new elementary school. James Arsenault, from the Upper Township Board of Education discussed their long-range facilities building plan, which options include but are not limited to the possible building of a new school building on the site of the existing Elementary school. He explained this has been discussed by the School Board for the past 5 years and the booklet presented this evening to the Township Committee is exactly what the School Board has been working with. (He invited the public to consult their website to view the power point presentation.) Present also were architect Robert Garrett to discuss the building and renovation plans, and School Board auditor Mr. Garcia to address the financing. Mr. Arsenault discussed that the Board has four presentations planned over the next 6 weeks starting with tours of each school showing the exact areas the architects have recommended for potential renovation. The tours include information on environmental impact, green initiative plans, as well as financing plans. The public referendum is targeted for January 25, 2011 and there was discussion as to

how the proposed date was chosen. There was concern that the referendum would fall when many residents are away for the winter and why it is not the same time as the school budget election. The School Board explained that state statute allows 2 dates in both spring and fall, and due to the State Grant funding it is necessary to hold the referendum in January or possibly risk losing the funding. The plan shows a new elementary school and major renovations on both the Primary and Middle Schools, which Mr. Garrett reviewed in depth. Plans also include removal of the "temporary classrooms" at the Elementary School site as well as renovations in rooftop air conditioning and heating, also new sidewalks and redesign of the bus drop off area. Mr. Garcia discussed that state grant funding of \$6 million is available and that it was important to have the referendum in January so that the bonds to pay for the school can be sold early. The total cost of the new school and renovations and additions to the Primary and Middle Schools is estimated at \$38,560,244; Actual Debt estimated at \$3,434,850; State Grants \$6,367,348; and the local Share is expected to be \$28,768,046. He presented several options to pay for the improvements and new school over 15, 20 and 25 years and explained that the impact for \$100,000 assessment in the 25-year scenario is \$79.20 and that the school would add \$269.60 a year to the average homeowner's tax bill over 25 years of assessment. The Committee thanked the School Board for the presentation and the next order of business began.

RE: APPROVAL OF A PAYMENT PLAN FOR A MUNICIPAL LIEN PLACED ON BLOCK 306, LOT 27 ON THE TAX MAP OF THE TOWNSHIP OF UPPER

WHEREAS, the Township Committee previously passed Resolution No. 190-2009, Authorizing the Demolition of a Structure at 2236 Route-50 in Tuckahoe as an Emergent Condition and Collection of Costs as a Municipal Lien on

Block 306, Lot 27, which authorized the expenditure of Seven Thousand, Seven Hundred Twenty-Three (\$7,723.00) Dollars to EarthTech Contracting, Inc. and Four Thousand, Four Hundred Fifty (\$4,450.00) Dollars to Klemco., Inc., for the removal of asbestos siding and the demolition of the structure at 2236 Route-50 in Tuckahoe, owned by Rosemary Bonner (hereinafter "Bonner"), which resulted in a cost to the Township of Twelve Thousand, One Hundred Seventy-Three (\$12,173.00) Dollars, a copy of said Resolution is incorporated by reference hereto; and

WHEREAS, the Township Committee previously passed Resolution 045- 2010, Authorizing an Additional Expenditure for the Demolition of an Unsafe Structure Located at 2236 Route-50, in Tuckahoe, and Collection of Costs as an Municipal Lien on Block 306, Lot 27, On The Tax Map of The Township of Upper, which authorized an additional cost of Two Thousand, Six Hundred Forty (\$2,640.00) Dollars to EarthTech Contracting, Inc., which was necessary for filling in the foundation of the structure previously located at 2236 Route-50 in Tuckahoe, a copy of said Resolution is incorporated by reference hereto; and

**WHEREAS,** the Township currently has a Municipal Lien in the amount of Fourteen Thousand, Eight Hundred Thirteen (\$14,813.00) Dollars against the property located at 2236 Route 50, Tuckahoe, NJ, Block 306, Lot 27;

WHEREAS, Bonner owes the Township a total amount of Fifteen Thousand, Eight Hundred Fifteen and 99/100 (\$15,815.99) Dollars, which represents Fourteen Thousand, Eight Hundred Thirteen (\$14,813.00) Dollars for the previously-entered Municipal Lien relating to said demolition costs, and an additional One Thousand, Two and 99/100 (\$1,002.99) Dollars, which represents unpaid real estate taxes and interest on the property located at 2236 Route-50 in Tuckahoe; and

**WHEREAS**, the owner of the property located at 2236 Route-50 in Tuckahoe, New Jersey, Bonner, has proposed a payment plan in order to avoid the Township of Upper from offering the Municipal lien for sale, and reducing the unpaid taxes to a tax lien certificate at the next scheduled tax sale;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

- 1. The allegations of the Preamble are incorporated herein by reference.
- 2. The total amount owed by property owner Bonner for the property located at 2236 Route-50 in Tuckahoe, for unpaid taxes and the Municipal lien which had been previously placed on said property being Block 306, Lot 27, is \$15,815.99.
- 3. The property owner Bonner will pay Two Hundred Seventy (\$270.00) Dollars per month to the Township of Upper on the first of each month, beginning October 1, 2010, for a period of Fifty-Eight (58) months, which will conclude on July 1, 2015.

- 4. The property owner Bonner will then make a Final Payment of One Hundred Fourteen and 01/100 (\$114.01) Dollars as of August 1, 2015. (A copy of said Agreement is attached and incorporated by reference as Exhibit "A").
- 5. The Township's agreement to accept such a payment plan is conditioned upon the property owner, Bonner, continuing to pay all subsequent real estate taxes, assessments and any other Municipal liens imposed in a prompt manner and remaining current on all said obligations during the term of this agreement.
- 6. If the property owner Bonner runs delinquent on any of the payments required under this agreement, or any subsequent tax, assessment and/or Municipal lien obligations, then said agreement shall be void and the Township officer charged by law with the duty to collect said Municipal liens and taxes shall proceed to enforce the current Municipal lien by selling it in the manner prescribed under New Jersey law.

TOWNSHIP OF UPPER CAPE MAY COUNTY ORDINANCE NO. 011-2010

# RE: AUTHORIZING THE USE OF UP TO \$23,000.00 FROM THE CAPITAL IMPROVEMENT FUND FOR ACQUISITION OF AN PHONE SYSTEM FOR THE TOWNSHIP OF UPPER

**BE IT ORDAINED** by the Township Committee, in the Township of Upper, County of Cape May and State of New Jersey, as follows:

**SECTION 1**. The improvement described in Section 2 of this Ordinance is hereby authorized to be undertaken by the Township of Upper, New Jersey as a general improvement. For the improvement or purpose described in Section 2, there is hereby appropriated the sum of up to \$23,000.00 from the Capital Improvement Fund.

#### **SECTION 2**.

- (a) The improvement hereby authorized is for the acquisition of a new phone system at the Municipal Building, Community Center, Rescue Squad Building and Public Works Building, including all related costs and expenditures incidental thereto.
- (b) The estimated cost of the improvement or purpose is equal to the amount of the appropriation herein made therefore.

**SECTION 3**. The following additional matters are hereby determined, declared, recited and stated:

- (a) The improvement or purpose described in Section 2 of this Ordinance is not a current expense. It is an improvement or purpose that the Township of Upper may lawfully undertake as a general improvement and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.
- (b) The period of usefulness of the improvement or purpose is within the limitations of the Local Bond Law.

**SECTION 4**. Any grant monies received for the purpose described in Section 2 hereof shall be applied either to direct payment of the cost of the improvement or to payment

of the obligations issued pursuant to this Ordinance. The amount of obligation authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

**SECTION 5**: **REPEALER:** All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.

**SECTION 6**: **SEVERABILITY**: If any section, paragraph, subdivision, subsection, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

**SECTION 7: EFFECTIVE DATE:** This Ordinance shall take effect immediately upon final adoption and publication as required by law.

**Carol Foster, Mayor of Corbin City,** discussed an offer by Corbin City to sell the former Atlantic County Regional Day School and Hostler Hall to the Township rather than build a new school.

**Ted Kingston of 5 East Willard Ave, Strathmere:** discussed doing an impact study on the cost to taxpayers in Strathmere. He is worried that it could create more "for sale" signs and more people being forced out of the Township.

**Russel Morano 5 Red Oak Dr. Marmora:** would like the School Board to find other alternatives to building a new school. He is worried about increase in taxes and wants to see the School Board explore other options.

William Collins, 413 Aetna Dr. Corbin City: asked for clarification on the tax rate.

**Robert Malkiewicz:** asked about the referendum and if the School Board does not raise the money the money from the State of New Jersey will be gone.

**Carol Iverson:** a member of the Corbin City Board of Education is in favor of using the Corbin City facility.
