# <u>APPROVAL OF MINUTES</u> - October 9, 20

#### October 9, 2012 Regular Meeting and Closed Session Minutes

Motion was made by Jay Newman, seconded by Anthony Inserra. During roll call vote all five Committee members voted in the affirmative.

#### **REPORT OF GOVERNING BODY MEMBERS**

**Edward Barr, Committeeman,** reported that 42 animals were vaccinated at the free rabies clinic held on Saturday October 13. He next reported on a public safety issue in the area of milepost 22.5 on Route 9. The area has been the location of numerous motor vehicle accidents due to the road design and poor drainage issues. He made a motion, seconded by Curtis Corson, to draft a resolution for a future agenda, identifying the issue to the New Jersey Division of Highway Traffic Safety. During roll call vote all five Committee Members voted in the affirmative.

**Anthony Inserra, Committeeman**, reported on a project recently completed by the Upper Township School District. It was stated that while the Township has no authority over the School District's budgetary expenditures, a request can be made to have a more open dialogue with the School Board regarding future projects and potentially utilizing Township personnel. Later in the meeting Mr. Inserra reported that the meeting of the subcommittee regarding the trash trucks had been delayed. A meeting will be scheduled in the near future.

**Jay Newman, Committeeman,** reported that the Annual Fire Prevention Open House was a huge success with a very good turnout.

**Richard Palombo, Mayor**, reported that he has been working with Senator Van Drew on several issues including a full interchange at Garden State Parkway Exit 20 in Seaville, and that the Senator has requested copies of all the previous resolutions adopted by UT in this matter. It was suggested that another resolution be adopted prior to the next meeting to include with the package to Senator Van Drew. Motion was made by Curtis Corson, second by Tony Inserra, to authorize the Mayor and Clerk to prepare and sign a Resolution consistent with prior resolutions that have been adopted requesting a full interchange at Exit 20 on the Garden State Parkway. During roll call vote all five Committee members voted in the affirmative

The Mayor reported on the positive progress being made with the NJDOT regarding the traffic lights on Hope Corson Road and Route 50, and the No Passing Zone on Route 9 near Osprey Point and that the traffic light should be functional within the next few weeks. Mayor Palombo next reported that the Township Engineer, Paul Dietrich, has received a Floodplain Manager Certification. He stated that the Township has been working diligently to help offset the cost of flood insurance through FEMA certifications and that obtaining the Floodplain certification was a positive step in that direction. Lastly, Mayor Palombo reported that free flu vaccinations will be offered at the Health Fair scheduled for tomorrow and urged the public to get vaccinated.

# **OTHER REPORTS**

**Wanda Gaglione, Municipal Clerk,** reported on a few upcoming events in the Township. Again, the annual Upper Township Health Fair on Tuesday October 23<sup>rd</sup>, at the Community Center from 9:00 am to 11:00 am. Various vendors will be in attendance, the County will be offering free flu shots, and the public is invited to attend. On Saturday October 27<sup>th</sup>, the Greater Tuckahoe Area Merchants Association will be holding a car show at 9:00 am at Amanda's Field. On Wednesday October 31, Halloween Trick or Treating will be from 5:00 pm to 8:00 pm. On Tuesday November 6, the polls for the General Election will be open from 6:00 am to 8:00 pm. On November 26, The Upper Township Annual Christmas Tree Lighting Ceremony will be hosted by the Upper Township Noon Rotary Club at 6:30 pm.

**Daniel Young, Municipal Attorney**, reported that there are two items for closed session; a personnel matter and a contract negotiation matter.

**Paul Dietrich, Municipal Engineer**, reported that the Cape May County Health Department is offering free well testing in the Southwoods Development. Flyers have been sent out to the residents in the area.

During roll call vote all five Committee members present voted in the affirmative.

### TOWNSHIP OF UPPER CAPE MAY COUNTY O R D I N A N C E ORDINANCE NO. 012-2012 RE: AN ORDINANCE AMENDING ORDINANCE NO. 010-2012 AND MODIFYING THE STANDARDS FOR THE AWARDING OF PROFESSIONAL OR EXTRAORDINARY SERVICES CONTRACTS PURSUANT TO THE STATE OF NEW JERSEY'S "PAY TO PLAY" LEGISLATION

WHEREAS, large political contributions from those seeking or performing contracts with a municipality raise reasonable concerns on the part of taxpayers and residents as to their trust in government and its business practices; and,

**WHEREAS,** pursuant to N.J.S.A. 40:48-2, a municipality is authorized to adopt such ordinances, regulations, rules and by-laws as necessary and proper for good government, as well as the public health, safety and welfare; and,

**WHEREAS,** pursuant to P.L.2005, c.271 (codified at N.J.S.A. 40A:11-51) a municipality is authorized to adopt by ordinance, measures limiting the awarding of public contracts to business entities that have made political contributions, and limiting the contributions that the recipient of such a contract can make during the term of a contract; and,

**WHEREAS,** in the interest of good government, the people and the Township Committee of the Township of Upper desire to establish a policy that will avoid the perception of improper influence in public contracting and local elections;

WHEREAS, it shall be the policy of the Township of Upper to create such a regulation which states that a Business Entity which makes political contributions to municipal candidates and municipal parties in excess of certain thresholds shall be limited in its ability to receive public contracts from the Township of Upper;

**WHEREAS**, the Township of Upper previously adopted Ordinance No. 010-2012 which established standards for the award of Professional or Extraordinary Services contracts and now desires to amend said ordinance and standards; and

**NOW, THEREFORE, BE IT ORDAINED** by the Township of Upper, in the County of County of Cape May, and State of New Jersey, as follows:

**SECTION 1**: Chapter II, Section 9.8 of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, is hereby amended as follows:

#### 2-9.8 PROFESSIONAL OR EXTRAORDINARY SERVICES CONTRACTS.

(1) Unchanged.

(2) Prohibition on Awarding Public Contracts to Certain Contributors

- (a) To the extent that it is not inconsistent with state or federal law, the Township of Upper and any of its departments, instrumentalities or purchasing agents shall not enter into any agreement or otherwise contract to procure "professional services" as such term is defined at N.J.S.A. 40A:11-2(6) and used at N.J.S.A. 40A:11-5(1)(a)(i) and/or banking, insurance or other consulting service (hereinafter "Professional Services"), nor "extraordinary unspecified services" as such term is defined at N.J.S.A. 40A:11-2(7) and used at N.J.S.A. 40A:11-5(1)(a)(ii) and/or media, public relations, lobbying, parking garage management or other consulting and/or management service (hereinafter "Extraordinary Unspecified Services") from any Business Entity if such Business Entity has solicited or made any Contribution to (i) a candidate, candidate committee or joint candidates committee of any candidate for elective municipal office in Township of Upper or a holder of public office having ultimate responsibility for the award of a contract, or (ii) to any Township of Upper political committee or political party committee within one calendar year immediately preceding the date of the contract or agreement.
- (b) Unchanged.
- (c) For purposes of this Ordinance, the office that is considered to have ultimate responsibility for the award of the contract shall be (i) the Township Committee, if the contract requires approval or appropriation from the Governing body, or (ii) the Mayor, if the contract requires approval of the Mayor, or if a public officer who is responsible for the award of a contract is appointed by the Mayor.
- (d) Rules regarding subcontractors. No person may be awarded a subcontract to perform under a contract subject to this Ordinance, if the subcontractor would be disqualified by subparagraph (a) from receiving the contract at the time that the subcontract is awarded. Nor may any person who would be disqualified by subparagraph (a) from receiving the contract perform substantially all of obligations

described in a contract for professional or extraordinary services that is subject to this ordinance.

**SECTION 2: SEVERABILITY**: If any provision of this Ordinance, or the application of any such provision to any person or circumstances, shall be held invalid, the remainder of this Ordinance to the extent it can be given effect, or the application of such provision to persons or circumstances other than those to which it is held invalid shall not be affected thereby, and to this extent the provisions of this Ordinance are severable.

**SECTION 3: REPEALER**: All ordinances or parts of ordinances which are inconsistent with any provisions of this Ordinance are hereby repealed as to the extent of such inconsistencies.

**SECTION 4: EFFECTIVE DATE**: This Ordinance shall take effect upon final adoption and publication as required by law.

**SECTION 5: CODIFICATION**: This Ordinance shall be codified in the Upper Township Code at the section referenced to above.

#### **DISCUSSION**

5. **Cape May County Wastewater Management Plan.** Paul Dietrich reported that he met with the Cape May County Planning Department and the NJ Department of Environmental Protection this morning and the NJDEP had two comments on the current Wastewater Management plan. Strathmere, and the Petersburg Disability Center located on Petersburg/Dennisville Road are two sites that had been requested to be mapped as a sewer service area and an area with greater than 2000 gallons of flow in the current plan. The DEP has stated that this part of the plan does not meet their rules and regulations because the two sites are in Planning Area 5, which is an environmentally restricted area. The current plan will have to be revised and sent back to the Planning Board for approval.

7. Tax Collector- Certification of Mailing-Added Assessment and Omitted/Added Assessment Taxes for 2012 Final/2013 Preliminary Tax Bills. Motion was made by Curtis Corson second by Antonio Inserra to accept the certification. During roll call vote all five Committee members voted in the affirmative.

#### PUBLIC COMMENT

**Ronald McCole, Beesley's Point,** inquired if the Committee has ever considered televising the Committee meetings on Channel 2. It was stated that while the Committee is not opposed to the idea, the cost of equipment and man power needed to film the meetings may be prohibitive. The suggestion will be considered.

**Hobart (Hobie) Young, Petersburg,** stated that he thoroughly supports the Rescue Squad, and all other Township Employees. He next inquired when the Master Plan was changed for the Shaw Farm and the Vanderslice tract in Seaville. The Township Engineer stated that the Vanderslice tract was changed within the last eight months and the Shaw Farm was done

during the Master Plan Reexamination as part of the Affordable Housing Plan in 2006/2007. Mr. (Hobie) Young stated his opposition to the zone changes because of the potential long term effects on schools. It was stated that all members of the Township Committee also share that sentiment however the Committee had to prepare a Fair Share Plan to protect the Township from Builders Remedy suits. The Fair Share Plan was prepared by the Planning Board and a housing subcommittee made up of residents and Planning Board members. The Plan was precipitated by a Builders Remedy suit filed against the Township several years ago. It was filed on an environmentally sensitive tract of property in Tuckahoe that if successful could have resulted in the construction of numerous COAH units being built without regard of zoning regulations or the negative impact on the school system. The Affordable Housing Plan was developed by the Committee because of the potential for subsequent lawsuits and they needed to protect the Township and residents from the uncontrolled development that would have resulted.

**Ralph Holt, 50 Jill Ave., Marmora,** spoke about a letter he had sent requesting an appeal of the Planning Board decision regarding a zone change to his property. The Township attorney stated that an appeal can be filed at Superior Court within 45 days of the Planning Boards decision. Mr. Holt then asked if he could bring the matter before the Township Committee. The Township attorney stated that a request could be made to the Township Committee to change the zoning of the property irrespective of the Planning Board's recommendation. The Committee would make their decision based on their own investigation and find valid reasons under the law to disregard the Planning Board's recommendations. However, there have been questions of conflict regarding this matter. Mr. Young was requested to give recommendations on questions of conflict with the Committee that presently exist.

**Karen Deuel, Petersburg,** requested all upcoming events to be placed on the website. She next inquired if the option of Comcast broadcasting the Committee meetings had been considered. It was mentioned that UTTV is a free Comcast channel; however Comcast does not provide the equipment or do the actual filming.
