## CAPITAL BOND PROJECTS AND BUDGET WORKSHOP-6:30 P.M.

In preparation of the 2013 Municipal Budget the second budget workshop meeting was called to order by Mayor Palombo this evening at 6:30 PM.

Also present were Municipal Clerk Barbara L. Young, Finance Officer Barbara Spiegel, and Municipal Engineer Paul Dietrich.

The Open Public Meeting notice was read into the record.

Mr. Corson began the meeting by stating that since the first budget workshop \$30,000 has been added back into the budget. \$25,000 was returned to the Special Litigation line and \$5,000 to the Computer Services line. However the budget is still under cap with a zero tax rate increase and approximately \$260,000 less than the proposed budget at the last meeting. He suggested that they again go through the budget line item by line item and discuss any possible additional cuts.

**Financial Administration**-under the Computer services line the increase was discussed. The amount appropriated also includes a proposal for video recording of Township meetings.

**Affordable Housing**-Mr. Dietrich explained this includes appropriations for updates to the Affordable housing plan that may be necessary due to DEP obligations.

Public Works Functions - Several line items were discussed and explained.

Under Surfacing of Roads Mr. Dietrich explained that the appropriation was increased since last year due to the deteriorating condition of Township roads. In 2012 most of the amount appropriated was expended for pothole repairs, curb repairs and basic maintenance.

Under Tipping fees the increase was discussed. Mr. Dietrich explained that the Township will see an increase of at least 2% due to contractual obligations with the MUA and an increase in their rates.

**Park & Recreation Functions-**The increase under Shore Protection was discussed. Also included in the appropriation is an Emergency Contingency.

Construction Code-there was discussion on revenue compared to expenses.

Zoning/Code Official- O/E has been reduced by \$1,000 from last year's appropriation.

**Board of Health**- the CFO explained that the actual expenditures under this line have decreased significantly from years past. The O/E appropriations under this line are for employee physicals and hearing tests for DPW employees.

**Deferred Charges** under Interest on Note the appropriation was reduced due to a significant reduction in the interest rate on the band. The CFO explained that the expenditure in 2012 was \$45,690.00 since then the Township has paid 2.5 million on the 3.5 million band. The 2013 appropriation is \$26,900.00.

Mr. Corson stated that he anticipates the budget will be ready for introduction on March 11, 2013.

Mr. Corson then opened up the meeting for public comment.

**Ted Kingston, Strathmere-**questioned the Capital Improvement Fund. The CFO stated the appropriation for the Capital Improvement Fund is \$40,000.

## **Capital Bond Projects**

Paul Dietrich presented a proposed list of Capital Bond Projects.

Mr. Corson began the discussion by discussing the proposed amount for Trash Trucks. The CFO stated there is \$379,000 in the Recycling fund and an additional \$750,000 is needed to purchase the trucks. The Committee next discussed the paving project Mr. Dietrich proposed bonding \$1.5 million for repaving. Mr. Dietrich stated that the roads in the Township are in deteriorating condition and recommended repaving 22 miles of roadway over the next 10 years. The proposal for 1.5 million would allow the Township to repave two years' worth of streets, averaging about \$775,000 per year to resurface all the recommended streets over a ten year period. Mr. Inserra discussed postponing the project to wait for energy receipt taxes from hosting the B. L. England power plant. Mr. Corson expressed concerns with postponing the repaving projects and stated that the cost of repaving is much less compared to reconstruction. Mr. Dietrich reported that the cost of reconstructing a half mile of road is approximately \$300,000 compared to repaving a mile of roadway at \$340,000.

Because of time constraints, it was then decided to continue the discussion of the capital bond projects at the end of the regular meeting.

\* Later in the meeting, the Capital Bond Projects Workshop was continued. The proposed capital projects were discussed again item by item. It was then decided to schedule a Capital Bond Projects workshop on the next agenda in order to reach a final decision on which projects should be authorized.

There was a 5-minute recess and then the regular meeting convened.

## <u>APPROVAL OF MINUTES</u> - January 28, 2013 Budget Workshop, Regular Meeting and Closed Session Minutes

Motion by Jay Newman, second by Ed Barr to approve the closed session, regular meeting and budget workshop minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

## **REPORT OF GOVERNING BODY MEMBERS**

Edward Barr, Committeeman, reported that during the recent Recreation Board meeting Upper Township Lacrosse submitted a request to form a girls Lacrosse program and Daryl Ditroia of the Challenger program submitted a request to be accepted as an official Upper Township Organization. As soon as the organizations have completed all the necessary paperwork the recreation board will be submitting a letter to the Committee with their recommendations pertaining to the requests. He next reported that he was recently approached by Sea Isle City officials regarding extending Jitney service form Sea Isle into Strathmere for the summer season. Dan Young stated that in order to allow the Jitney service the Township would have to adopt an Ordinance and the Jitney service would have to be licensed through the Township. The Committee directed Mr. Young to prepare an Ordinance for their review. Mr. Barr next reported on a request from a resident for support of a proposed Good Samaritan bill. The Township Attorney stated that there are two versions of the bill. The first version of the bill offered protection from prosecution for someone who witnesses a drug overdose and called for help. That bill was vetoed by the Governor. The second version that is now pending is for a study on drug overdose reporting in order to make a recommendation on how to approach the problem. The Township Attorney requested clarification on which version of the bill should be supported. Mr. Barr next reported that cases of rabies infection are on the rise in Cape May County. The Township will be having a free Rabies Clinic on February 23, 2013 from 1:00 p.m. to 3:00 p.m. at Shore Veterinarians.

**Curtis Corson, Committeeman,** reported that the Budget introduction will be on March 11, 2013 at 7:30 p.m. The Municipal Auditor will be present to answer any questions.

**Richard Palombo, Mayor,** reported that the Committee may continue the discussion of the Capital Bond Projects later during this meeting. He next reported that he and the Township Engineer will be attending a FEMA meeting tomorrow in Trenton with officials from FEMA,

the Department of Community Affairs, and the Department of Environmental Protection to address municipal concerns regarding the Advisory Base Flood Maps which were implemented as emergency rules by the DEP and adopted by executive order for purposes of reconstruction although the maps are not yet official. Mayor Palombo next reported that plans are underway with the Township's website to become more user friendly and more informational.

#### **OTHER REPORTS**

**Daniel Young, Municipal Attorney**, reported that there a few contract negotiation items and personnel items for closed session.

WHEREAS, pursuant to state regulations, municipal water quality management plans must be in compliance with its regional wastewater management planning agency which, in the case of Upper Township, requires that same be in compliance with the Cape May County Water Management Plan (WQM); and

WHEREAS, on January 17, 2012, the New Jersey State Legislature adopted an Act (P.L.2011, c.203) requiring that, within 180 days, each wastewater management planning agency prepare and submit an existing and future sewer service area map to the New Jersey Department of

Environmental Protection (NJDEP) as a foundational document of the county's future wastewater management plan; and

WHEREAS, in conjunction with the Cape May County Planning Department and Maser Consulting, P.A., the Township of Upper has developed its Future Wastewater Facilities and Service Areas Map prepared by Paul E. Dietrich, Sr., Professional Engineer, dated April 2012; and

WHEREAS, the duly advertised public meeting of the Upper Township Planning Board occurring on April 19, 2012, the Upper Township Planning Board discussed the Future Wastewater Facilities and Service Areas Map, accepted public comment, and deemed same satisfactory to the Board pursuant to NJSA 40:55D-28, a municipality's planning board is required to adopt and amend its Master Plan to guide the use of lands within the municipality in a manner which protects the public health and safety and promotes the general welfare; and

WHEREAS, at a meeting of the Township Committee occurring on April 30, 2012 that the Upper Township Committee did discuss the Future Wastewater Facilities and Service Areas Map and the Upper Township Planning Board's Special Resolution; and

**WHEREAS,** The County of Cape May incorporated Upper Township's request for plan amendment to the Cape May County WQM and submitted it to the NJDEP for review; and

WHEREAS, the NJDEP has removed two locations from the Township's request, the Petersburg Disability Center (Block 453 Lot 1) and proposed sanitary sewer service for Strathmere & Whale Beach sections of Upper Township because their underlying Planning Area is a 5; and

WHEREAS, the Petersburg Disability Center is an integral component of the Township's Affordable Housing & Fair Share Plan and located adjacent to the Town Center in Borough of Woodbine and removing it from the WQM will require the Township to reevaluate our Fair Share Plan; and

WHEREAS, the Strathmere & Whale Beach sections of Upper Township are currently served by individual on-site septic systems on 4,000 Square Foot lots. This septic density does not meet the NJDEP Water Quality Management Planning Rule (N.J.A.C. 7:15-5.25(e) which requires a development density to attain 2.0 mg/L nitrate in the ground water. In order to meet the antidegradation standard for the Atlantic Coast HUC11 Watershed a septic density is 8.6 acres/ septic is required. The Township did request this area to be endorsed as a Village Center but it was not endorsed by the NJDEP; and

WHEREAS, the Township of Upper will request in the future that the NJDEP should consider adding the Strathmere & Whale Beach sections to the proposed sanitary sewer area to meet the NJDEP's antidegradation standard which should be held paramount to the planning area rule and the Petersburg Disability Center so that the Township can continue to meets its obligation under the adopted Affordable Housing & Fair Share Plan which should be held paramount to the planning area rule; and

**WHEREAS,** the Cape May County WQM has been published in the N.J. Register on January 7, 2013 and in the Atlantic City Press on January 9, 2013; and

WHEREAS, the Township of Upper does consent to the amendment to the Cape May County WQM but we may continue to request future amendments for the Petersburg Disability Center and sanitary sewer service for Strathmere and Whale Beach sections of Upper Township.
