APPROVAL OF MINUTES - **July 8, 2013 Regular Meeting and Closed Session Minutes-** Motion by Jay Newman, second by Edward Barr, to approve the regular meeting and closed session minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Jay Newman, Committeeman, reported the Upper Township Emergency Services will be holding a Junior Firefighting Camp for 4th through 8th graders, August 19th to 22nd from 6 to 8 p.m. each evening. More information on the camp is available on the Upper Township website at www.uppertownship.com.

Antonio Inserra, Committeeman, discussed several issues including unkempt properties and pot holes throughout the Township. The Township Engineer was directed to follow up on the issues.

Edward Barr, Committeeman, offered a motion, seconded by Anthony Inserra, to authorize a resolution to honor Abigail Craige, and Christopher Furey for winning first place in their respective age divisions in the Philadelphia Phillies Home Run Derby held in Sea Isle City on July 9th. During roll call vote all five members voted in the affirmative. He next reported on the progress of repairs to one of the well pumps at Amanda’s Field. Lastly Mr. Barr reported on the construction kick off meeting he attended with Mayor Palombo for the Upper Township Senior Center; all permits are in place and the project to renovate and

redesign the building is moving along as scheduled. Mayor Palombo acknowledged Freeholder Gabor for spearheading the project and seeing it through.

Richard Palombo, Mayor, began by inviting the Township Attorney and Engineer to join him for a meeting later in the week scheduled with FEMA to discuss funding for Beach replenishment. The Federal Government has recently authorized a federal cost share increase for recovery projects funded by FEMA from a 75 percent (local share 25 percent) to 90 percent (local share 10 percent).

Next he reported that earlier this evening he attended the M.S. Row annual fundraiser hosted by the Upper Township Lifeguards in Strathmere. Mayor Palombo acknowledged the lifeguards for their success in some of the local competitions held throughout Cape May and Atlantic Counties. He congratulated them on winning two races in a two day period; the best paddling in North Wildwood and the Tri-Resort competition against Sea Isle City and Wildwood. He also acknowledged the Beach Patrol for holding drills with the Strathmere Fire Company on water emergencies.

Lastly Mayor Palombo reported that four individuals, Katelynn Wintz, Karen Mitchell, Myra Small and Ralph Cooper submitted applications for the Upper Township Green Team Advisory Board. The subcommittee will serve to develop initiatives and promote sustainability and growth throughout the Township. Motion by Mayor Palombo, second by Edward Barr to approve the four applicants to serve on the Upper Township Green Team Advisory Board along with Committeeman Inserra as the Township Liason and Township Engineer Paul Dietrich. During roll call vote all five Committee members voted in the affirmative.

OTHER REPORTS

Barbara L. Young, Municipal Clerk, reported on a resident complaint she received concerning issues with speeding on Corson Tavern Road (CR 628) and waste haulers using the route to access the County Landfill. The resident requested that warning signs be placed along the route to remind waste haulers that they are required to use approved routes only. The Committee discussed also requesting the State Police to increase their presence in the area as well. Motion made by Mayor Palombo, second by Antonio Inserra to direct the Township Clerk to write a letter to the County requesting signage on Corson Tavern Road and to notify the State Police of the problem with speeding. During roll call all five Committee members voted in the affirmative.

Daniel Young, Municipal Attorney, reported that there is one personnel item for closed session.

Paul Dietrich, Municipal Engineer, reported on various issues including progress being made with the clearing of brush in order to keep the site triangles throughout the township clear. He also gave an update on the Old Sams Gulf Station; in the event the Construction Official deems the structure as unsafe the Executrix of the estate has consented to its demolition. He next reported he received estimates for additional cameras to video record Township meetings. Mr. Dietrich stated that for approximately \$6,800 the township can purchase the additional cameras necessary to produce enhanced video recordings. Ed

Corcoran, Upper Township Webmaster gave a brief summary on which types of digital video cameras and connections can be used to stream live videos of the meetings. Motion made by Antonio Inserra, second by Jay Newman to authorize the purchase of additional cameras. Lastly Mr. Dietrich reported on a pre-construction meeting he attended last week with the NJDOT for the Route 50 Tuckahoe River bridge project during which it was discussed that in an effort to shorten the duration of the project which could take up to three years to complete the contractor has proposed to have alternating one way traffic with a traffic signal on the bridge during the construction. Once complete the value Engineering Study outlining the proposal will be submitted to the New Jersey DOT and the surrounding Counties and Municipalities for their approval.

WHEREAS, Alejandra Reagan and George L. Reagan, individually and trading as CITYTRI RACING, INC., of 18E 21st Street, Brooklyn, NY 11226, have submitted a proposal to the Upper Township Committee requesting authority to hold an international distance race in Beesley's Point, New Jersey, including the use of Township roads and the Beesley's Point Beach parking lot, on August 11, 2013, which will consist of a run course, swim course, and a bike course, with participants arriving and activities commencing at 6:30 a.m., as more particularly specified in their proposal, a copy of which is attached hereto as Exhibit "A";

WHEREAS, the run segments will travel NJSH Route 9 and the bike segment will utilize Township, County and State roads in Upper Township as described on maps attached hereto as Exhibit "B"; and

WHEREAS, the proposed event is sanctioned and insured by the USA Triathlon Association, a copy of insurance certificate is attached hereto as Exhibit "C"; and

WHEREAS, a vehicle management plan has been prepared with additional parking at Tuckahoe Inn, Beesley's Point Sea Doo, and BL England property, map and letters of permission from businesses are attached hereto as Exhibit "D"; and

WHEREAS, a fully executed Event Supervisor Agreement, which certifies compliance with the rules and regulations as established in Chapter XXVI of the Code of Upper Township, has been received and is attached hereto as Exhibit "E"; and

WHEREAS, a liability release and waiver will be received from every participant in the triathlon, prior to the event, on a form which has been approved by the Township Solicitor and is attached hereto as Exhibit “F”; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.
2. The Township Committee does hereby grant approval, to the extent that it has jurisdiction to do so, to Alejandra Reagan and George L. Reagan, individually and trading as CITYTRI RACING, INC. for the race event to be held on August 11, 2013 as specified in this Resolution and in the accompanying Exhibits subject to and conditioned upon the following:

- (A) The event described in this Resolution is carried out by Alejandra Reagan and George L. Reagan, individually and trading as CITYTRI RACING, INC. These sponsors have no connection, direct or indirect, with the Township of Upper or any of its officials or employees. - (i) the Risk Management Consultant of the Township of Upper.
- (ii) the New Jersey State Police.
- (iii) the Upper Township Rescue Squad.
- (iv) Cape May County Board of Chosen Freeholders.
- (v) New Jersey Department of Transportation.

The event sponsors have provided written authorization from the above entities, including any conditions required of said entities, to the Township Clerk.

(D) Alejandra Reagan and George L. Reagan, individually and trading as CITYTRI RACING, INC., have executed and

provided to the Township of Upper an approved Use of Facilities Agreement.

- (E) The event is expressly limited to 300 participants only.

- (H) Alejandra Reagan and George L. Reagan, individually and trading as CITYTRI RACING, INC., shall remit to the Township, before the event, the appropriate fee in accordance with Chapter XXVI of the Code of Upper Township. This fee shall include the amount required for closure of the boat ramp and the hourly fee for use of the parking lot since it is a facility not specifically identified in the ordinance. The use of the

parking lot will begin at 6:00 a.m. and will terminate at 12:00 p.m.

- (I) The approval granted herein is subject to all conditions and stipulations as may be recommended or imposed by the Township's Risk Management Consultant or Insurance Representatives. The Township may revoke this approval if the Event Sponsors fail to comply with any said condition or recommendation or any other condition of this Resolution.

3. All Township officials and officers are hereby authorized and empowered to take all action deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.

13. **American Cancer Society requests the use of Amanda's Field for the "Bark for Life" event on August 17.** Motion by Jay Newman, second by Edward Barr, to approve the request. During roll call vote all five Committee members voted in favor.

14. **Furnishing and Delivery of Refuse Collection Vehicles and Refuse Containers.** The Township Engineer reported that following the last Committee meeting where the award of Bids was discussed, he was contacted by one of the unsuccessful truck

bidders, who requested a meeting with the Township to discuss the variations in the bids for the automated trash trucks. The bidder discussed that some of the items that were listed as required were actually optional items that the manufacturer could provide.

Mr. Dietrich stated that after speaking with the bidder and reviewing the specifications for the automated trucks, the review found that two items, a heavy duty mechanical arm and a smaller wheelbase for the truck, were indeed listed as requirements instead of options. The township had intended to make them options, and rebidding the contract with the items listed as options could lower the price.

Mr. Dietrich recommended that the bids for the automated trucks be rejected due to the technical deficiencies and be rebid with the following revisions to the specs: remove the description of the heavy duty arm, clarify the wheel base and the total capacity of the truck and remove the optional tail gate.

The Township Attorney explained that because the technical deficiencies in the specs were discovered after the fact and this may have led a bidder not to bid an item or not to bid as low this is a reason for rejecting the bids and substantially revising the bid specifications. Mr. Young stated that he agrees with the recommendation to rebid the automated trucks.

Motion by Jay Newman, second by Curtis Corson to reject all bids for the automated trash trucks and authorize the engineer to prepare revisions to the specifications and rebid item #1 for the automated trucks. During roll call vote all five Committee members voted in the affirmative.
