## APPROVAL OF MINUTES -

# September 23, 2013 Regular Meeting and Closed Session Minutes

Motion by Curtis Corson, second by Edward Barr, to approve the regular meeting and closed session minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

## **REPORT OF GOVERNING BODY MEMBERS**

**Jay Newman, Committeeman,** reported that the Marmora Fire House hosted the Annual Fire Prevention Public Safety Open House last week, and although the weather did not cooperate, it was a successful event with a good turnout. He next reported that the Upper Township security committee recently met to discuss various security issues, and will be submitting recommendations to the Committee at a meeting in the near future.

**Curtis Corson, Committeeman,** asked for a report on the status of the Ocean Avenue paving project. Mr. Dietrich reported that the Reconstruction of Ocean Avenue paving project is currently out to bid with the bid opening scheduled for October 22, 2013. Mr. Corson next reported that the Historical Society will be holding their annual apple fest on Saturday October 19<sup>th</sup> at the Gandy House.

**Edward Barr, Committeeman**, reported that the Township will be holding a free rabies clinic on Saturday October 26<sup>th</sup> from 1:00 to 3:00 pm at Shore Veterinarians in Seaville.

**Richard Palombo, Mayor,** reported on correspondence received from Congressman LoBiondo stating that the Army Corps of Engineers Great Egg Harbor to Corson's Inlet beach replenishment project has been approved and has received 100% funding. This is a multi-million dollar ongoing replenishment program that will require zero municipal funds. Mayor Palombo thanked Mr. Dietrich and Mr. Young for their efforts in seeing this project and the funding to fruition, and complimented the partnership between the Township, Ocean City and Sea Isle. He next reported that the Township has received a \$142,000 grant for back-up generators and other emergency systems, and the Township has received notification from the County of an award of a \$220,000 recreation grant for improvements to Amanda's Field, and a \$280,000 grant for the Boat Ramp on Bayview Avenue. He congratulated Paul Dietrich, Daniel Young, Barbara Young, and Barbara Spiegel for their efforts in achieving these grants.

# **OTHER REPORTS**

**Barbara Young, Municipal Clerk,** reported that the Upper Township annual Health Fair will be held on Monday October 21 from 1:00 to 3:00 pm at the Upper Township Community Center. There will be free health screenings and demonstrations, and the County will be offering free flu shots. The public is invited and encouraged to attend. Mrs. Young next reported that Trick or Treating in Upper Township will be held on October 31 from 5:00 pm to 8:00 pm., and lastly she reported that the Special General Election for US Senate will be held tomorrow October 16. The public and the Clerk's Office will be open from 6:00 am to 8:00 pm.

**Daniel Young, Municipal Attorney**, reported that there are several items for closed session; two contract negotiation items, and two litigation items.

Paul Dietrich, Municipal Engineer, distributed a "letter to residents" to the Committee for their review which outlines the automated trash collections procedures. Upon the Committee's approval, the letter will be sent to the residents within the next week. Information will also be available on the website. Mr. Dietrich next requested authorization to solicit bids for a 6 yard dump truck and a road side boom mower. Motion by Anthony Inserra, second by Jay Newman, to accept the request. During roll call vote all five Committee members voted in the affirmative. A resolution will be placed on the next agenda. Mr. Dietrich next requested authorization to join the Intergovernmental Purchasing Agreement, in order to purchase a sixteen foot wide recreational mower from the only vendor that manufactures the mower. IPA is a national cooperative purchasing organization, and there is no cost to participate. Motion by Anthony Inserra, second by Edward Barr, to approve the request. During roll call vote all five Committee members voted in the affirmative. Mr. Dietrich next reported that the 2013 Capital Improvement Bond Ordinance authorized the purchase of a utility body pickup truck and a mini-dump truck with utility box and snow plow. However, it has been determined that the mini-dump truck with utility box and snow plow does not fit the functionality of the Township's needs. State contract prices will allow the Township to purchase a utility body pickup truck, a 1/2 ton pickup truck, and a <sup>3</sup>/<sub>4</sub> ton pickup with a plow for \$30,000 less than the vehicles authorized by the Capital Improvement Bond. It was stated that Bond Counsel will have to approve the purchase of the different vehicles before a discussion or decision can be made. The issue will be listed under

unfinished business on a future agenda. He then reported that the Strathmere Beach sustained only minor damage and erosion from the recent nor'easter.
