#### **REPORT OF GOVERNING BODY MEMBERS**

**Jay Newman, Committeeman,** offered his congratulations to Hobie Young and John Coggins on their election as Committeemen, and offered any help he could provide. He next reported that there are several street signs throughout the Township that are misspelled. Mr. Dietrich stated that as the misspellings are received corrections can generally be made within the day.

**Curtis Corson, Committeeman**, also offered his congratulations to Mr. Young and Mr. Coggins, and offered his assistance to insure a smooth transition.

Anthony Inserra, Committeeman, reported that there is a problem with speeding on Stagecoach Road and suggested asking the County to reduce the speed limit, and request the State Police increase their patrol of the area. Motion by Anthony Inserra, second by Edward Barr, to have a resolution prepared asking the County to reduce the speed limit on Stagecoach Road from 35 mph to 25 mph. During roll call vote all five Committee members voted in the affirmative. He next requested permission to donate his time and services to supervise a Township project to replace the tank to the water system at Township Hall. It was stated that as long as the work is covered under the Township's insurance, there is no conflict with a Committeeman donating his time or services. Lastly Mr. Inserra reported on a recent supervisors meeting with the department of public works in that the DPW yearend budget is approximately ten percent under budget.

**Edward Barr, Committeeman**, offered his congratulations to Mr. Young and Mr. Coggins. He next reported that there was an issue with vandalism to the bathrooms at Amanda's Field over the weekend. There was a brief discussion on possible security measures that could be taken to reduce access to the facilities. He next reported that the Upper Township Business Association will be hosting a community night at the primary school from 6:00 -9:00 pm.

**Richard Palombo, Mayor**, offered his congratulations to Mr. Young and Mr. Coggins on their election, and also offered his assistance for a successful transition.
