<u>APPROVAL OF MINUTES</u> - November 25, 2013 Regular Meeting and Closed Session Minutes

Motion by Jay Newman, second by Edward Barr, to approve the regular meeting and closed session minutes as submitted. During roll call vote four Committee members voted in the affirmative. Curtis Corson abstained.

REPORT OF GOVERNING BODY MEMBERS

Jay Newman, Committeeman, made a motion to honor Marissa Sampson for receiving the "Outstanding EMS Action by a Youth" award from the New Jersey Office of Emergency Services. The motion was seconded by Curtis Corson. During roll call vote all five Committee members voted in the affirmative. A resolution will be placed on the next agenda.

Curtis Corson, Committeeman, reported that the CFO has been authorized to prepare the Temporary Budget for the beginning of 2014, which will be voted on at the Reorganization meeting.

Edward Barr, Committeeman, reported on a request from Christian Chadwick to use the Community Center for pickup basketball games open to adults. Motion by Ed Barr, seconded

by Anthony Inserra, to designate Christian Chadwick as a Township volunteer to coordinate pickup basketball games on behalf of the Township for adults only at the Upper Township Community Center with no fee, subject to confirmation of the appropriate Insurance, waivers being signed, and the understanding that the requestor is responsible for the facility. During roll call vote all five Committee members voted in the affirmative.

Richard Palombo, Mayor, reported that he attended a meeting this evening in Galloway Township for the New Jersey Pinelands Commission. Mayor Palombo read the following statement which was accepted by the Commission as public comment:

TO: New Jersey Pinelands Commission

FROM: Mayor and Township Committee of the Township of Upper

RE: Statement in Support of Proposed Project by South Jersey Gas

DATE: December 9, 2013

Municipalities have a responsibility to take a balanced approach to economic development, job creation and environmental protection for their communities. Few projects ever accomplish all three priorities, but Upper Township is fortunate to be presented with that opportunity.

The BL England electric generation facility in Beesley's Point was ordered by the New Jersey Department of Environmental Protection to either install cost prohibitive controls to significantly reduce emissions from the coal and oil the plant currently burns, repower the plant with much cleaner natural gas, or shut down entirely. The owners of the plant decided to convert to cleaner natural gas, which is in line with New Jersey's plan to reduce our reliance on coal. By converting the plant to natural gas, they are able to save the jobs of our neighbors at the plant, provide a local reliable energy source and ensure the plant continues to contribute to our local economy.

In order for the plant to operate, South Jersey Gas must build a pipeline to the plant. South Jersey Gas has already received all necessary approvals, after in-depth reviews, from the Army Corps of Engineers, the Department of Environmental Protection, and the Board of Public Utilities. It now awaits final approval from the Pinelands Commission.

The pipeline would be built parallel to Route 49 and Tuckahoe Road. The pipeline will run under and adjacent to already paved roadways, and will therefore not cut into this treasured and pristine area of our state. An independent third party consulting firm has spent over a year performing studies in this area to ensure there are no impacts to nearby threatened and endangered species or to adjacent wetlands along the route.

In addition to being a cleaner energy source, this pipeline would bolster the reliability of the gas supply system in Cape May County and create 75 full time jobs for approximately nine months. The existing system only has one feed into the county. A disruption, such as one seen in other areas of the state from Super Storm Sandy, could severely interrupt service to thousands of our neighbors and residents, possibly for multiple months at a time. Therefore, it is critically important to our residents to have this project approved.

Upper Township respectfully requests that the Pinelands Commission act favorably on the proposal of South Jersey Gas.

Mayor Palombo next reported that he will be attending another meeting regarding the pipeline at the Pinelands Commission this Friday with the Township Engineer.

OTHER REPORTS

Daniel Young, Municipal Attorney, reported that there are a few items for closed session; contract negotiations items, safety and security issues, and a personnel item.

Paul Dietrich, Municipal Engineer, reported that the letters to residents regarding the automated trash collection carts have been sent out and there has been a positive response. He next reported on a New Jersey 2013 Hurricane Sandy Coastal Resiliency Competitive Grant Program offered through the US Department of Interior which will allow the Township to partner with the NJDEP for planning and green infrastructure projects along the back bays, wetlands and waterways. Mr. Dietrich stated that the grant funding could potentially be used to enhance or rebuild the Strathmere Boat Ramp area on the easterly side of Bayview Avenue where it meets the marsh and requested authorization to apply for the grant. Motion by Curtis Corson, seconded by Anthony Inserra, to approve the request. During roll call vote all five Committee members voted in the affirmative. Mr. Dietrich next gave a brief update on the Township's Affordable Housing Rehabilitation Program with regard to a historic home in the Tuckahoe area. Due to the historic designation of the home, budget prices for materials have come in over the allotted amount. The Administrative Agent has requested an additional \$2,235, over the allotted \$20,000 to replace the siding which would bring the total amount for this home to \$22, 235.00. It was stated that the homeowner is still responsible for the repayment of the loan. Motion by Jay Newman, seconded by Ed Barr to approve the request, subject to the approval of Community Affairs and COAH. During roll call vote all five Committee members voted in the affirmative.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee, the governing body of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. SHARED SERVICES AGREEMENT. Pursuant to the provisions of the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et. seq., the Township of Upper

is hereby authorized and empowered to enter into a Shared Services Agreement with Ocean City pertaining to Ocean City providing public safety answering and dispatch services and associated computer-aided dispatch support to Upper Township.

2. **SERVICES TO BE PROVIDED BY CONTRACT.** The Shared Services Agreement authorized in paragraph 1 shall delineate the services, promises and covenants of each party and a copy of such Agreement shall be maintained by the Township Clerk and shall be available for public inspection.

3. **AUTHORIZATION TO MUNICIPAL OFFICIALS.** The appropriate Township officers and officials are hereby authorized to take any action necessary or advisable to carry out the intent and purpose of this Resolution. Specifically, the Mayor and Township Clerk are hereby authorized and directed to execute such Shared Services Agreement on behalf of the Township of Upper pursuant to the authority conferred by this Resolution. The Township Clerk is further authorized and directed to seal the Agreement with the official seal of the Township of Upper.

4. **COMPLIANCE WITH STATUTORY REQUIREMENTS.** The Shared Services Agreement between the Township of Upper and Ocean City meets and satisfies the requirements of N.J.S.A. 40A:65-7, as may be amended and supplemented.

5. **CONTRACT TERM.** This Resolution authorizes a Shared Services Agreement for a duration of five (5) years commencing on January 1, 2014 and continue through December 31, 2018, unless sooner terminated or modified by either of the parties as provided in the Agreement.

6. **SEVERABILITY.** If any action, subsection, paragraph, sentence or other part of this Resolution is adjudged to be unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Resolution, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Resolution directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Resolution shall remain in full force and effect.
