REPORT OF GOVERNING BODY MEMBERS

Hobie Young, Committeeman, gave a brief report on the plans for the Fourth of July Event at Amanda’s Field. There will be a free concert by the Kenny Young Band & D-Suspended Band from 4:30 to 8:30 p.m., with the intermission performed by Lets Party Painter’s Characters. A salute to veterans performed by the Upper Township Boy Scout Troops and American Legion Post 239 of Tuckahoe. There will be various activities including free face painting, Moon Bounce and Pony Rides, and refreshments will be available with the proceeds going to support the Upper Township Challenger Sports programs. The Fireworks show will begin at dusk.

Edward Barr, Committeeman, reported that he has been working along with Committeeman Young and Emergency Management on the parking and safety plans for the Fourth of July events at Amanda’s Field.

Richard Palombo, Mayor, reported that the Committee members will be riding in the OEM deuce and a half truck in the Strathmere parade. He next reported that the Township has been able to obtain several items from army surplus, including a heavy tow truck and a self-contained cooking trailer. In addition there is a partnership with the NJ State Police for the use of two Humvees. Mayor Palombo then congratulated the graduates from Ocean City High School and the eighth graders from Upper Township.

OTHER REPORTS

Barbara Young, Municipal Clerk, reported that the Upper Township Municipal Offices will be closed on Friday July 4th in observance of the holiday. A parade will be held in Strathmere beginning at 10:30 a.m. and later in the day festivities will continue at Amanda's Field with a free concert and various other activities.

Daniel Young, Municipal Attorney, reported that there are a few items for closed session; several contract negotiation matters, safety and security, and personnel.

Paul Dietrich, Municipal Engineer, reported that the Federal Government and the NJ Department of Environmental Protection signed the project partnership for the Army Corps of Engineers beach replenishment project. It is anticipated that the project will be advertised in August with the bid to be awarded in October. He next gave a brief update on the Township's Housing Rehabilitation project. The last house to be rehabbed will soon be completed. This will place the Township in full compliance with that aspect of the Fair Share Plan.

Barbara Spiegel, Chief Financial Officer, reported that the Township's employee picnic is scheduled for Thursday July 10th at Caldwell Park. Motion by Richard Palombo, second by Anthony Inserra to authorize \$500.00 to cover the cost of the picnic. During roll call vote all five Committee members voted in the affirmative. She next reported on a recent RFQ for actuarial services. Three companies responded, with the lowest quote being \$2,900.00 for a full actuarial report for 2013, and \$960 for later interim years. Motion by John Coggins, second by Anthony Inserra, to authorize a contract with Danziger & Markhoff for actuarial services. During roll call vote all five Committee members voted in the affirmative. A Resolution will be placed on the next agenda for formal action.

18. **Benjamin Duncan request to purchase Township owned property Block 667, Lot 7.** Due to a conflict, Municipal Attorney Daniel Young stepped down from this discussion. PUBLIC COMMENT

Richard Fellows, Tuckahoe, expressed his concern with a report that the Township will be selling an easement on a parcel of Township owned property which is currently being used as a baseball field in Tuckahoe. It was stated that the sale of the easement fits into the Township's plans to consolidate all recreation fields into Amanda's Field, as well as furthers the Township's support for the South Jersey Gas pipeline to BL England project.

Bob Allen, Seaville, spoke regarding the potential impact radius of a gas pipeline blowout and voiced his opposition to the proposed valve station in Tuckahoe.

Dave Lauro, President of Bayberry Cove Condominium Association, spoke regarding taxes and Township services in Bayberry Cove. The Municipal Attorney stated that the taxes are set by the assessor for the market value of the land and any improvements on it. In addition every individual land owner has the right to appeal their assessment if they feel their property is assessed too high. He further stated that because under State law Bayberry Cove Condominium Campground is considered a seasonal proprietary business and not a residential year round community, the Municipal services that residential properties receive are not available to businesses.

Pat Welsh, President of Oakridge Condominium Resort, stated that the residents of Oakridge campground love Upper Township, own and maintain their homes, and pay their taxes faithfully. They consider Upper Township as their home and anything the Township can do for the residents of Oakridge and Bayberry would be greatly appreciated.

Donald Rainear, Strathmere, stated his opposition to the Township executing the Treatment Works Application for Block 829, Lot 4.02, and requested the Township to reconsider submitting the application.

Anna Bauer, Strathmere, voiced her frustration with the County and the State with regards to a dispute she has with the owners of Block 829, Lot 4.02 and their plans to build a home.

Mellissa Linz, Tuckahoe Rd, requested that in the future if the Township is going to honor emergency workers for their response to a call, then everyone that was at the scene should be acknowledged. Committeeman Barr suggested forming a recognition Committee with the Chiefs Association to make sure that no one is slighted from receiving the recognition they deserve.

Joel Wentz, Bayberry Cove, inquired as to why a campground is treated as a business. Municipal Attorney stated that Bayberry Cove is a seasonal licensed approved campground and the state statute for municipal services does not cover campgrounds. It was stated that while the Township cannot provide the same services to the campground as they do for a residential property, the Township will pick up recycling if the recycling is placed in appropriate containers and located in one centralized location.
