Meeting and Closed Session Minutes

Motion by Edward Barr, second by Anthony Inserra, to approve the February 3, 2014 Special Budget Workshop Meeting Minutes, and the February 10, 2014 Budget Workshop, Regular Meeting, and Closed Session Minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

John Coggins, Committeeman, reported on an agenda item regarding a revision to the temporary budget. He stated that this revision does not increase the budget, it allows the temporary budget to be spread from three months to four months to allow time for the budget to be adopted.

Hobie Young, Committeeman, briefly reported on the agenda item pertaining to repairs that are currently underway on the well at the Municipal building. He next stated that he will be requesting an additional \$50,000 from the bond to finish the lighting at the little league and adjacent fields at the Amanda's Field Recreation Complex. He next commended employees

Mike Jones and Dave Pennello on the compliments he has received from School Administrators regarding the professionalism they have shown while working at the school.

Anthony Inserra, Committeeman, gave a brief update on the automated trash collection program. The drivers are being trained on using the automated trucks, the carts are scheduled to be delivered to the residents beginning March 3, and the automated pickup is scheduled to begin March 17. This information has been posted on the website and UTTV. He next reported that the school has requested the following projects be completed by the Township over the summer: grade, fill and topsoil around the Primary and Elementary School playgrounds; remove chain link fencing and curbing at the former playground site, and install drainage, and grade for asphalt for parking at this area; install a pavilion kit between the Primary School and Elementary School and finish with a concrete floor; and install new locks on doors throughout the interior of the schools. Mr. Inserra stated that in exchange for the completion of these projects, the school has agreed to provide janitorial services at the Upper Township Senior Center. Motion by Anthony Inserra, second by Richard Palombo, to authorize Township employees to complete the above listed projects, with the understanding that the school will provide janitorial maintenance services at the Upper Township Senior Center. During roll call vote all five Committee members voted in the affirmative. Mr. Inserra next stated that he has had several requests for the Township to coordinate the Committee meeting schedule with the School Board to allow residents the opportunity to attend both meetings. Mr. Inserra requested that the Committee look into changing the meeting schedule to the 1st and 3rd Mondays. The Municipal Clerk was directed to draft a schedule for further review.

Edward Barr, Committeeman, reported that the Township held another successful rabies clinic this past Saturday, with approximately 150 vaccinations given. Next Mr. Barr reported on a recent meeting he attended with the Township Chiefs Association. Due to a pending application by New Jersey American Water Company to construct a water tower in the township, the Chiefs Association is requesting that the water company grant them access to place emergency communication equipment on the tower. The Township Attorney recommended that the fire companies send a letter to the zoning board secretary requesting the zoning board address this request. Mr. Young further recommended that the fire companies may want to have their attorneys contact the water company attorney to confirm their position prior to the zoning board hearing on the matter.

Richard Palombo, Mayor, reported that he met this past week with the new station commander at the State Police Barracks in Woodbine. They discussed several issues including the placement of radar signs along Corson Tavern and Stagecoach Road and other areas throughout the Township. It was requested that the areas be identified by the Township. They also discussed the possibility of the Township supporting the purchase of exercise equipment to be used at the barracks for training purposes. Mr. Young stated that although he would need to explore the matter further it may be allowed as long as the equipment was used for the furtherance of the township.

OTHER REPORTS

Barbara Young, Municipal Clerk, requested permission to attend a NJ Municipal Clerks Association Conference on March 24-27 in order to obtain continuing education credits.

Motion by Richard Palombo, second by Anthony Inserra, to approve the request. During roll call vote all five Committee members voted in the affirmative.

Daniel Young, Municipal Attorney, reported that there are a few items for closed session, personnel, contract negotiation, and safety and security issues.

Paul Dietrich, Municipal Engineer, gave a brief update regarding the public access channel UTTV 2 changing to Channel 97. He stated Comcast does not have authorization to stream information on the channel once the change takes place. However, they have placed inserts in all bills notifying residents of the change. He next reported that the paving project is set to commence as early as next week depending on the weather. They will most likely begin on Ocean Avenue towards Seasounds Avenue. The affected residents will be notified. It was requested to coordinate the trash pickup schedule with the paving contractors, and have the paving schedule placed on UTTV. Mr. Dietrich next reported that the Green Team has submitted a proposed Resolution supporting wildlife habitat. He requested that the Committee look over the draft.

Barbara Spiegel, Chief Financial Officer, reported that there is a need to purchase an additional six hundred 64 gallon carts, and an additional cart tipper. The CFO requested the Committee to approve up to \$35,000 be withdrawn from the Recycling Trust Fund to purchase the requested items. Motion by Richard Palombo, second by John Coggins, to approve a change order for the additional carts and authorize the funds be withdrawn from the Recycling Trust Fund for the carts and tipper. During roll call vote all five Committee members voted in the affirmative. A Resolution will be place on a future agenda for formal action.

ORDINANCE NO. 002 -2014

AN ORDINANCE VACATING ADAMS AVENUE ADJACENT TO BLOCKS 417 THROUGH 424, WITHIN THE TOWNSHIP OF UPPER, COUNTY OF CAPE MAY AND STATE OF NEW JERSEY

WHEREAS, N.J.S.A. 40:67-1 authorizes the Governing Body of a municipality to adopt an Ordinance, among other things, to vacate any street, highway, lane, alley, square, place or park, or any part thereof, dedicated to public use but not accepted by the municipality, whether or not the same, or any portion, has been actually opened or improved; and

WHEREAS, Ralph Clayton, Delores Clayton and Clayton Equipment Corp are the owners of Block 417, Lots 1-3; Block 417, Lots 11-28, 30, 32, 34-60; and Block 417,

Lots 29, 31 and 33 and have requested that the Township vacate Adams Avenue as described in this Ordinance and have agreed to pay the costs incurred by the Township to vacate said street including the costs of the revisions to the tax map; and

WHEREAS, the Township Committee has duly considered the matter and it appears reasonable to agree to the request since there is no present or foreseeable need or intention to utilize said roadway; and

WHEREAS, it is deemed to be in the public interest to vacate Adams Avenue within the Township of Upper, as hereinafter provided.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

SECTION 1: The public right in, along, upon and over the following described land is hereby vacated, surrendered and extinguished:

Description

Vacation of Adams Avenue Adjacent to Blocks 417 - 424 as shown on Tax Map Sheet No. 13.01 Petersburg Section of Township of Upper

BEGINNING at the Southwesterly corner of Adams Ave. (30' wide) and Mill Rd. (40' wide) extending Southwestwardly along Block 417 a distance of 613.03'; and continuing across Second St. (30' wide); and continuing along Block 418 a distance of 600'; and continuing across Third St. (30' wide); and continuing along Block 419 a distance of 600'; and continuing across Fourth St. (30' wide); and continuing along Block 420 a distance of 445'; and extending Southeasterly across Adams Ave. (30 wide); and extending Northeastwardly along Block 421 a distance of 447'; and continuing across Fourth St. (30' wide); and continuing along Block 422 a distance of 600'; and continuing across Third St. (30' wide); and continuing along Block 423 a distance of 600'; and continuing across Second St. (30' wide); and continuing along Block 424 a distance of 611.69'; and extending Northwesterly along the Southerly line of Mill Rd. across Adams Ave. (30' wide) to the point of beginning; excepting out those portions of Right-of-Way for Second, Third and Fourth Streets.

SECTION 3: EXCEPTION: This Ordinance expressly reserves and excepts from vacation all rights and privileges now possessed by public utilities, as defined in R.S. 48:2-13, and by any cable television company, as defined in the "Cable Television Act", P.L. 1972, c. 186, (C.48:5A-1, et seq.), to maintain, repair and replace their existing facilities in, adjacent to, over or under the street, highway, lane, alley, square, place or park, or any part thereof, to be vacated, as hereinabove described.

SECTION 4: REPEALER: All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

SECTION 5: EFFECTIVE DATE: This Ordinance shall take effect immediately upon final adoption and publication as required by law.

The Municipal Attorney reported that due to the new automated collection program, the ordinance will need to be amended to reflect the new system, and direction from the Committee is needed regarding the cost that will be charged to residents who wish to purchase an additional cart. After a brief discussion, an amending Ordinance was directed to be prepared for introduction on the next agenda.
- **12. Proposed Animal Welfare Ordinance amendment**. Mr. Barr reported that the Township's Animal Control Officer has requested an amendment to the Animal Welfare Ordinance to include regulations on sheltering animals during extreme weather conditions. - 13. Amanda's Field Volunteer Services Indemnification agreement. The Municipal Attorney reported that Atlantic City Electric inquired as to whether the Township would indemnify their company if they provide volunteers to install lighting at Amanda's Field. The Township's Risk Management Consultant indicated the Township is insured, but it is always better to have an indemnification from the contractor. It is unusual that the Township would indemnify the contractor. The Municipal Attorney advised that the Committee must balance the value of volunteer labor and equipment versus the liability in the event of an accident. Motion by Hobie Young, second by Edward Barr, to offer an indemnification to Atlantic City Electric for the use of equipment and volunteers for the purpose of installing lighting at Amanda's Field. During roll call vote all five Committee members voted in the affirmative.
- **14. Amending Bond Ordinance 015-2013**. Motion by Committeeman Young to amend the Bond Ordinance to reflect an additional amount of \$50,000.00 for improvements and lighting at Amanda's Field. After a lengthy discussion, the motion was seconded by Edward Barr. During roll call vote all five Committee members voted in the affirmative. The Clerk was directed to gather demographical information regarding the size of the sports organizations, including the number of participants and use of facilities, for the Committee's review.
- **15. Assessment of well damage at Township Hall.** Motion by Hobie Young, second by John Coggins, to authorize the Purchasing Agent to proceed on an emergent basis to obtain quotes for the repair or replacement of the well at the Municipal Building as necessary.
