REPORT OF GOVERNING BODY MEMBERS

He next congratulated lifeguard Daniel Gill for his winning performance in a lifeguard competition, and Kyle Malar for winning the National Club Soccer championship for U17.

Hobie Young, Committeeman, congratulated the 9 and 10 year old baseball team for winning the Mid-Atlantic and East Region Championships, and stated how impressed he was with the character and composure of these young men throughout the season.
