APPROVAL OF MINUTES - November 10, 2014 Regular Meeting and Closed Session Minutes

Motion by Edward Barr, second by John Coggins, to approve the November 10, 2014 Regular Meeting Minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

Motion by Edward Barr, second by John Coggins, to approve the November 10, 2014 Closed Session Meeting Minutes as submitted. During roll call vote four Committee members voted in the affirmative. Committeeman Inserra abstained.

## REPORT OF GOVERNING BODY MEMBERS

**Hobie Young, Committeeman,** requested an update on the sports field lighting project. The Engineer stated that the bid opening for the lighting material is scheduled for tomorrow November 25 and the results will be discussed at the December 8<sup>th</sup> meeting. Committeeman Young next reported on a situation with a malfunctioning door at the Upper Township Senior Center. The County has been notified to resolve the issue. He then stated that work is progressing on the baseball fields at Amanda's Field. The topsoil has been brought in and they are working hard to get the grading finished before the ground completely freezes. He next reported that an eligibility issue with the Wrestling program will go before the Recreation Advisory Board at their December 4<sup>th</sup> meeting, who will then submit a

recommendation to the Committee on how to proceed. He finally requested that quotes be obtained for a blanket event insurance policy for the upcoming year. The information will be obtained for discussion at the 2015 budget workshop meetings.

**Richard Palombo, Mayor**, congratulated Paul Dietrich and the Upper Township Green Team for obtaining the Bronze designation from Sustainable New Jersey. He stated that the Green Team has worked hard and accomplished quite an achievement in a short amount of time. He next reported on a meeting he, Paul Dietrich, and Barbara Young recently had with the New Jersey American Water Company. Although he felt the outcome of the meeting was not positive, another meeting will be scheduled to see if there may be opportunities for people with well problems to have access to city water. He next stated that he and the CFO have been working on the health insurance quotes and contract for the upcoming year.

**Anthony Inserra, Committeeman,** gave a brief report on a change to the Public Works schedule for next year in which the brush pickup will be on a monthly schedule. He stated that everything else will remain the same.

**Edward Barr, Committeeman**, wished everyone a safe and happy Thanksgiving.

# **OTHER REPORTS**

**Barbara Young, Municipal Clerk,** reminded everyone that the Township offices will be closed on Thursday and Friday for the Thanksgiving holiday.

**Daniel Young, Municipal Attorney**, reported that there are three contract negotiation matters, a litigation matter, and personnel matters for closed session.

**Paul Dietrich, Municipal Engineer**, requested the formation of a floodplain management public information group consisting of community stakeholders, residents and Township officials. The public information group is an important component of the CRS certification program for next year. A resolution for formal action will be placed on a future agenda. He next reported that the Planning Board has recommended several zoning changes to Chapter 19 and 20 of the Upper Township Code, the bulkhead standards, and a minor change to the zoning map. The Committee will review the recommendations at a future meeting.

WHEREAS, the Township of Upper, hereinafter referred to as MUNICIPALITY, participated as a member municipality of the Atlantic County Municipal Joint Insurance Fund, hereinafter referred to as FUND, for one or more of the following FUND fiscal years beginning January 1, 1998, January 1, 1999, January 1, 2000, January 1, 2001, January 1, 2002, January 1, 2003, January 1, 2004, January 1, 2005, January 1, 2006, January 1, 2007, January 1, 2008, January 1, 2009, January 1, 2010; and

**WHEREAS**, the FUND is a statutory filed municipal joint insurance fund as defined in N.J.A.C. 11:15-2.1 et seq.; and

**WHEREAS**, the MUNICIPALITY joined the FUND knowing that membership carries with it joint and several liability with all other member municipalities for each year of the MUNICIPALITY's membership; and

WHEREAS, the MUNICIPALITY understands that the FUND's Executive Committee are the only persons authorized in law to make decisions as to when and how much of any available statutory surplus will be released by the FUND; and

WHEREAS, the MUNICIPALITY understands that the FUND's Executive

Committee are the only persons authorized in law to make decisions as to when and how

much of any projected deficit will be declared as an additional assessment due to the FUND; and

WHEREAS, the MUNICIPALITY understands that Available Statutory Surplus is defined to be the amount of money in excess of the projected value of claims by line of coverage, plus an actuarially determined value for Incurred But Not Reported claims, subject to the surplus reserve calculations as defined in N.J.A.C. 11:15-4.6 et seq., and subject to review and approval by the Department of Banking and Insurance and Department of Community Affairs, State of New Jersey, prior to release by the Executive Committee of the FUND; and

WHEREAS, the MUNICIPALITY understands that it remains jointly and severally liable into perpetuity despite the earlier release of Available Statutory Surplus due to the possibility that a FUND year wherein a return of Statutory Surplus has been duly authorized could later be presented with a claim for which it could be responsible causing a demand for an additional assessment from each participating member municipality of that FUND year; and

WHEREAS, the MUNICIPALITY understands that it remains jointly and severally liable into perpetuity despite the earlier collection of an additional assessment due to the possibility that a FUND year wherein an additional assessment has been duly authorized could later be presented with a need for additional assessments from each participating member municipality of that FUND year; and

**WHEREAS**, the MUNICIPALITY understands that its options for directing the distribution of its net share of released Statutory Surplus to be as follows:

- 1. Direct the FUND to apply the MUNICIPALITY's share to the MUNICIPALITY's premium as credit in the next FUND fiscal year (N.J.A.C. 11:15-4.21(e)),
- 2. Direct the FUND to issue a check to the MUNICIPALITY for the MUNICIPALITY's share,
- 3. Direct the FUND to apply the MUNICIPALITY's share to the FUND's Aggregate Excess Loss Contingency Fund (A.E.L.C.F.), which provides member municipalities with an available individual contingency balance for use in satisfying any possible need for a supplemental assessment for any year they were a member and an annual capacity to use all or a portion of a member municipality's available balance in offsetting future premiums, or
- 4. Direct the FUND to apportion the MUNICIPALITY's share as a stated dollar amount among options 1, 2 and 3 above such that the sum total of allocated dollars equals the amount of the Net Distribution available to the MUNICIPALITY as noted above.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

- 1. The allegations of the preamble are incorporated herein by this reference.
- 2. The MUNICIPALITY does hereby direct the FUND to apply the full amount to the MUNICIPALITY's share of the FUND's Aggregate Excess Loss Contingency Fund (A.E.L.C.F.).

3. All Township officials and officers are hereby authorized and empowered to take all action deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.

TOWNSHIP OF UPPER CAPE MAY COUNTY ORDINANCE

#### **ORDINANCE NO. 014-2014**

AN ORDINANCE VACATING A PORTION OF WILLETS ROAD ADJACENT TO BLOCK 487, LOTS 22 AND 33; BLOCK 488, LOTS 1, 13 THROUGH 16, AND 22; AND BLOCK 489, LOTS 1, AND 12 THROUGH 22, WITHIN THE TOWNSHIP OF UPPER, COUNTY OF CAPE MAY AND STATE OF NEW JERSEY

WHEREAS, N.J.S.A. 40:67-1 authorizes the Governing Body of a municipality to adopt an Ordinance, among other things, to vacate any street, highway, lane, alley, square, place or park, or any part thereof, dedicated to public use but not accepted by the municipality, whether or not the same, or any portion, has been actually opened or improved; and

WHEREAS, Clayton Development Associates, LLC is the owner of Block 479, Lot 48.01 and has requested that the Township vacate a portion of Willets Road as described in this Ordinance and have agreed to pay the costs incurred by the Township to vacate said street including the costs of the revisions to the tax map; and

WHEREAS, the Township Committee has duly considered the matter and it appears reasonable to agree to the request since there is no present or foreseeable need or intention to utilize said roadway; and

**WHEREAS,** it is deemed to be in the public interest to vacate a portion of Willets Road within the Township of Upper, as hereinafter provided.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

**SECTION 1:** The public right in, along, upon and over the following described land is hereby vacated, surrendered and extinguished:

# Description

Vacation of Portion of Willetts Road (50' Wide)
Adjacent to portion of Blocks 479, 487, 488 & 489
as shown on Tax Map Sheet No. 18.01
Marmora Section of
Township of Upper

BEGINNING at the Southwesterly corner of the intersection of Hudson Ave. (50' wide) and Willetts Rd.(50' wide) extending Northwestwardly along Block 488 Lots 1, 13-16 and 22 and Block 487 Lot 33 a distance of 454.88' to the Northwesterly corner of Block 487 Lots 22 and 33; and extending Northeastwardly across Willetts Rd. (50' wide) to a point; and extending Southeastwardly along Block 479 Lot 48.01 distance of 707' plus or minus to a point which is perpendicular to the Southeasterly property line of Block 489 Lot 22; and extending Southwestwardly across Willetts Rd. a distance of 50' to the Southeasterly corner of Block 489 Lot 22; and extending Northwestwardly along Block 489 Lots 1 and 12-22 to a point in the Southeasterly corner of the intersection of Hudson Ave. and Willetts Road; and extending across Hudson Ave. (50' wide) to the point of beginning.

**SECTION 2:** This Ordinance vacates no portion of Hudson Avenue or of Willetts Road except that portion set forth and described in **SECTION 1** above.

**SECTION 3: EXCEPTION:** This Ordinance expressly reserves and excepts from vacation all rights and privileges now possessed by public utilities, as defined in R.S. 48:2-13, and by any cable television company, as defined in the "Cable Television Act", P.L. 1972, c. 186, (C.48:5A-1, et seq.), to maintain, repair and replace their existing facilities in, adjacent to, over or under the street, highway, lane, alley, square, place or park, or any part thereof, to be vacated, as hereinabove described.

**SECTION 4: REPEALER:** All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

**SECTION 5: EFFECTIVE DATE:** This Ordinance shall take effect immediately upon final adoption and publication as required by law.

# **ORDINANCE NO. 015-2014**

RE: AN ORDINANCE AMENDING REVISED GENERAL ORDINANCE CHAPTER X OF THE CODE OF UPPER TOWNSHIP TO PROVIDE FOR REGISTRATION AND MAINTENANCE OF VACANT PROPERTIES

**BE IT ORDAINED** by the Township Committee, in the Township of Upper, County of Cape May and State of New Jersey, as follows:

**SECTION 1.** Chapter 10, Section 6 of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended and supplemented as hereinafter provided:

# 10-6 VACANT PROPERTY REGISTRATION.

**10-6.1 Purpose.** This ordinance governs the maintenance of vacant properties in the Township of Upper, implementing registration requirements and registration fees for owners of vacant properties.

## 10-6.2 Definitions.

**Owner** – The title holder, any agent of the title holder having authority to act with respect to a vacant property, any foreclosing entity subject to the provisions of N.J.S.A. 46:10B-51 (P.L. 2008, c. 127, Sec. 17) or any other entity determined by the Township of Upper to have authority to act with respect to the property.

Vacant Property – Any building used or to be used which is not legally occupied or at which substantially all lawful construction operations or

occupancy has ceased, and which is in such condition that it cannot legally be reoccupied without repair or rehabilitation; provided, however, that any property that contains all building systems in working order and is being actively marketed by its owner for sale or rental, shall not be deemed vacant. Notwithstanding the foregoing, property determined to be "abandoned property" in accordance with the meaning of such term in the Abandoned Properties Rehabilitation Act, N.J.S.A. 55:19-78, et seq. shall also be deemed to be vacant property for the purposes of this ordinance.

# 10-6.3 Registration statement required.

- A. Effective January 1, 2015, the owner of any vacant property as defined herein shall within sixty (60) days after the building becomes vacant property or within thirty (30) days after assuming ownership of the vacant property, whichever is later, file a registration statement for each such vacant property with the Zoning Officer or his or her designee on forms provided by that Zoning Officer or his or her designee for such purposes. The registration shall remain valid for one year from January 1 until December 31 of that year. The owner shall be required to renew the registration annually as long as the building remains vacant property and shall pay a registration or renewal fee in the amount prescribed in Section 10-6.5 of this chapter for each vacant property registered.
- B. Any owner of any building that meets the definitions of vacant property prior to January 1, 2015 shall file a registration statement for that property on or before January 31, 2015. The registration

- statement shall include the information required under Section 10-6.4 of this chapter, as well as any additional information that the Zoning Officer or his or her designee may reasonably require.
- C. The owner shall notify the Zoning Officer or his or her designee within thirty (30) days of any change in the registration information by filing an amended registration statement on a form provided by the Zoning Officer or his or her designee for such purpose.
- D. The registration statement shall be deemed prima facie proof of the statements therein contained in any administrative enforcement proceeding or court proceeding instituted by the Township against the owner or owners of the building.
- **10-6.4 Registration statement requirements; property inspection.** After filing a registration statement or a renewal of a registration statement, the owner of any vacant property shall provide access to the Township to conduct an exterior and interior inspection of the building to determine compliance with the Municipal Code, following reasonable notice, during the period covered by the initial registration or any subsequent renewal.
- A. The registration statement shall include the name, street address and telephone number of a natural person twenty-one (21) years of age or older, designated by the owner or owners as the authorized agent for receiving notices of code violations and for receiving process, in any court proceeding or administrative enforcement proceeding, on behalf of such owner or owners in connection with the enforcement of any applicable code. This person must maintain

an office in the State of New Jersey or reside within the State of New Jersey. The statement shall also include the name of the person responsible for the maintenance and security of the property, if different.

- B. An owner who is a natural person and who meets the requirements of this ordinance as to location of residence or office may designate him or herself as agent.
- C. By designating an authorized agent under the provisions of this section the owner consents to receive any and all notices of code violations concerning the registered vacant property and all process in any court proceeding or administrative enforcement proceeding process on the authorized agent. Any owner who has designated an authorized agent under the provisions of this section shall be deemed to consent to the continuation of the agent's designation for the purposes of this section until the owner notifies the Zoning Officer or his or her designee of a change of authorized agent or until the owner files a new annual registration statement. The designation of an authorized agent in no way releases the owner from any requirement of this ordinance.

**10-6.5 Fee schedule.** The registration fee for each building shall be Five Hundred Dollars (\$500) each year. For any partial year, there shall be no proration of the fee.

10-6.6 Requirements for owners of vacant property. The owner of any building that has become vacant property, and any

person maintaining, operating or collecting rent for any such building that has become vacant shall, within thirty (30) days:

- A. Enclose and secure the building against unauthorized entry as provided in the applicable provisions of the Code of the Township of Upper or the laws of the State of New Jersey.
- B. Post a sign affixed to the building indicating the name, address and telephone number of the owner, the owner's authorized agent for the purpose of service of process (if designated, pursuant to Section 10-6.4 of this chapter), and the person responsible for day-to-day supervision and management of the building, if such person is different from the owner holding title or authorized agent. The sign shall be of a size and place in such a location so as to be legible from the nearest public street or sidewalk, whichever is nearer, but shall be no smaller than 18" x 24";
- C. Secure the building from unauthorized entry and maintain the sign until the building is again legally occupied or demolished or until repair or rehabilitation of the building is complete.
- D. Post the property with No Trespassing signs of a nature sufficient to give notice to any person entering upon the property that it is against the law to enter the property without permission of the owner.
- **10-6.7 Administration.** The Zoning Officer or his or her designee may issue rules and regulations for the administration of the provisions of this ordinance.

# 10-6.8 Violations and penalties.

- A. Any owner who is not in full compliance with this ordinance or who otherwise violates any provision of this ordinance or of the rules and regulations issued hereunder shall be subject to a fine of not less than Five Hundred Dollars (\$500) and not more than One Thousand Dollars (\$1,000) for each offense. Every day that a violation continues shall constitute a separate and distinct offense. Fines assessed under this chapter shall be recoverable from the owner and shall be a lien on the property.
- B. For purposes of this section, failure to file a registration statement in time, failure to provide correct information on the registration statement, failure to comply with the provisions of Section 10-6.4 of this chapter, or such other matters as may be established by the rules and regulations of the Zoning Officer or his or her designee shall be deemed to be violations of this ordinance.

10-6.9 Other regulations not affected. Nothing in this ordinance is intended nor shall be read to conflict or prevent the Township from taking action against buildings found to be unfit for human habitations or unsafe structures as provided in applicable provisions of the Code of the Township of Upper or any other applicable statute or regulation. Further, any action taken under any such Code provisions, statute or regulation, other than the demolition of a structure, shall not relieve an owner from its obligations under this ordinance.

**SECTION 2**: **REPEALER**: All Ordinances or parts of Ordinances which are in conflict or inconsistent herewith are hereby repealed to the extent of such inconsistency or conflict only.

**SECTION 3: SEVERABILITY:** If any section, paragraph, subdivision, subsection, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

**SECTION 4: EFFECTIVE DATE:** This Ordinance shall take effect upon final adoption and publication as required by law.

- G. TOWNSHIP COMMITTEE MEETING ATTENDANCE: The Township Clerk and the Chief Financial Officer, in lieu of receiving compensatory time for attendance at meetings during non-business hours will receive \$100.00 per meeting.
- H. MILEAGE: The standard rate per mile in accordance with I.R.S. regulations.
- I. GIFT CARD AWARD OR BONUS: In addition to the salary set forth in this Ordinance, the Township Committee, by resolution, may award as a bonus any employee a gift card or gift cards not to exceed a total amount of \$200.00 for the year. Said award shall be by resolution of the Township Committee setting forth the amount of the gift card bonus.
- J. EDUCATIONAL CERTIFICATION PAY RAISE: In addition to the salary set forth in this Ordinance upon resolution of the Township Committee, the Township Committee may give an increase in salary of \$1,000.00 to any employee that has satisfied educational certification requirements for his or her position in accordance with current Township policy. The Township Committee shall by resolution fix the pay increase in this regard and certify that the employee has satisfied the educational certification requirement.

K. ADDITIONAL PAY TO CREW OF SANITATION VEHICLES: employed in the collection of trash and assigned to the rear of a trash truck shall, in addition to any other compensation payable pursuant to this Ordinance, receive an additional sum to be known as "Hazardous Duty Pay", which shall be payable at the rate of \$.25 per hour.

L. ADDITIONAL PAY TO EMERGENCY MEDICAL TECHNICIANS (EMTs): The most senior Emergency Medical Technician assigned to a shift where a supervisory employee is not also assigned to that shift, in addition to any other compensation payable pursuant to this Ordinance, shall receive an additional sum to be known as "Officer in Charge Pay", which shall be payable at the rate of \$.50 per hour.

**SECTION 3: LONGEVITY:** In addition to the compensation and benefits otherwise payable, certain employees shall be paid an additional sum based on longevity. Any payment based on longevity shall be in accordance with the following schedule:

**SECTION** 3A: RESTRICTIONS ON LONGEVITY **PAYMENTS:** Notwithstanding the provisions of Section 3 hereof, a longevity payment or longevity bonus to any single official, officer or employee of the Township of Upper shall not exceed the sum of Three Thousand (\$3,000.00) Dollars. If, as of January 1, 1997, any such official, officer or employee of the Township of Upper was entitled to a longevity payment in excess of Three Thousand (\$3,000.00) Dollars, then such individual shall be entitled to receive the amount to which he or she would have been entitled as of January 1, 1997 and each such official, officer or employee shall thereafter, in all subsequent years, receive a longevity payment or bonus in the amount paid as of January 1, 1997. In no event shall the amount of longevity payments exceed the sum of Three Thousand (\$3,000.00) Dollars, except for those individuals who are entitled to receive in excess of Three Thousand (\$3,000.00) Dollars as of January 1, 1997 and all such individuals shall in 1997 and all succeeding years be restricted to a payment which does not exceed that which was payable on January 1, 1997.

**SECTION 3B**: LONGEVITY PAY **ABOLISHED FOR CERTAIN** EMPLOYEES: Any official, officer or employee who was employed by the Township of Upper on or after January 1, 1996 shall not be entitled to any longevity payment. Longevity pay is abolished for any and all officials, officers and employees hired on or subsequent to that date.

SECTION 4: RESOLUTION AS TO SALARIES: The salaries set forth in this Ordinance are the maximum salaries to be paid for the various positions during 2015 and for such period or periods as this Ordinance shall remain in effect. Such maximum salaries shall be paid for each of the positions indicated unless the Township Committee, by Resolution shall fix a lesser salary, in which event such lesser amount shall be paid.

SECTION 5: EFFECTIVE DATE OF PAYMENT: All salaries authorized by this Ordinance shall be paid commencing as follows:

- (A) As of January 1, 2015 for all officials, officers and employees of the Township who were employed or appointed as of December 31, 2014. For those officials, officers and employees appointed at the Reorganization Meeting of the Township Committee, such persons shall be deemed appointed and employed by the Township as of January 1, 2015. This provision shall not apply to members of a Collective Bargaining Unit.
- (B) The payment of any salary increment and longevity payment for members of a Collective Bargaining Unit shall be made in accordance with the provisions of the Collective Bargaining Agreement currently in effect, any other provisions herein to the contrary notwithstanding.
- (C) Upon the effective date of appointment for all officers and employees appointed subsequent to January 1, 2015.
- (D) Any salary increases provided for in this Ordinance shall not apply to any official, officer or employee of the Township who has resigned or otherwise terminated his or her employment with the Township of Upper prior to the effective date of this Ordinance.

SECTION 6: REPEALER: All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION 7: SEVERABILITY: If any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance, but shall be confined in its effects to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

SECTION 8: EFFECTIVE DATE: This Ordinance shall take effect immediately upon passage and publication as required by law.
