## <u>APPROVAL OF MINUTES</u> - August 24, 2015 Regular Meeting and Closed Session Minutes

Motion by John Coggins, second by Jeffrey Pierson, to accept the August 24, 2015 Regular Meeting and Closed Session Minutes as submitted. During roll call vote all five Committeemen voted in the affirmative.

#### REPORT OF GOVERNING BODY MEMBERS

**John Coggins, Committeeman**, questioned if the Fall Fest, scheduled for Sunday October 18<sup>th</sup>, is in conflict with the other events going on that weekend. The Upper Township Historical Society will be holding their Apple Fest on Saturday October 17<sup>th</sup> at the Gandy House, and the South Shore Stitchers will be holding a quilt show on Saturday and Sunday at the Community Center. There was a general consensus that the date for the Fall Fest is not a conflict and should remain the same.

**Hobie Young, Committeeman**, reported that the Fall Fest will be held on Sunday October 18<sup>th</sup> from 1:00 to 6:00 pm at Amanda's Field. There will be live bands, a hayride, pumpkin carving and painting contests, games, etc. He gave a brief report on the progress of the Amanda's Field baseball fields and next reported that Football is underway, the kids did very well in the scrimmages, and there has been a great turnout. He also stated that the Babe Ruth World Series Champions will be coming in for an honoring resolution presentation at the

next meeting. Next, Committeeman Young reported on a few requests he has received for more outdoor basketball facilities throughout the Township. Lastly, he reported that Public Works will be installing the rubber compound on the concrete slab where the cheerleaders perform, and the hockey rink will soon be resurfaced to get ready for the season.

Later in the meeting, Committeeman Young stated for the record that he has stepped down as President of the South Jersey Storm Football Team. Although he will continue on as head coach, he will no longer be involved with the financial or administrative aspects of the team.

**Edward Barr, Committeeman**, commended the Public Works Department for the preparation of the fields for the endless soccer tournament, and the Rescue Squad for their presence during the games. He stated that there were many teams that participated, and it was a nice community event. He next stated that traffic conditions should improve with summer coming to a close; however he cautioned residents to look out for school buses and road workers.

**Richard Palombo, Mayor,** reported that there are some scarping issues along the beach at Vincent Avenue. He requested that Public Works level off the area again. Mayor Palombo next reported that the lifeguards were able to use a prototype of an aluminum lifeguard stand this year which proved to be much lighter, safer and lasts longer than the wooden stands. He requested that the wooden life guard stands be gradually replaced with the new aluminum stands. He stated that they are approximately the same cost as the wooden stands. Lastly, Mayor Palombo reported that there is an extremely large pothole on Roosevelt Boulevard in front of Broadleys. Mr. Dietrich stated that he will notify the County of the problem.

#### **OTHER REPORTS**

**Barbara Young, Municipal Clerk**, requested approval to register 22 township employees, members of the Township Committee, and members of the Planning and Zoning Boards for the New Jersey League of Municipalities Conference to be held in November. The cost to register is \$55.00 per person for online registration prior to October 1, 2015. Motion by Hobie Young, second by Jeffrey Pierson, to approve the request. During roll call vote all five Committee members voted in the affirmative.

**Daniel Young, Municipal Attorney**, reported that there are several contract negotiation items, a litigation matter, and a safety and security matter for closed session.

Paul Dietrich, Municipal Engineer, reported that a resident has requested, and he agrees, that the intersection of Stagecoach Road and Tuckahoe Road be designated as a no parking zone in order to maintain the site triangles. Motion by Jeffrey Pierson, second by Edward Barr, to direct the Municipal Attorney and Municipal Engineer to obtain approval from the County and prepare an Ordinance for formal action at a future meeting. During roll call vote all five Committeemen voted in the affirmative. Committeeman Coggins requested an update on the seasonal employees. After a brief discussion it was stated that seasonal employment is normally for a six month time period. Lastly, Mr. Dietrich requested that the beach sweepers be employed until the end of September to perform road clean ups in certain areas. He stated that there is funding available from Clean Communities.

**Barbara Spiegel, Chief Financial Officer,** reported on a recent Personnel matter with the Beach Patrol in which Mayor Palombo had a conflict and which, due to time constraints, the matter was handled by Committeeman Barr. Ms. Spiegel requested a motion to officially appoint an alternate for Mayor Palombo in the event this was to happen again. Motion by John Coggins, second by Jeffrey Pierson, to appoint Committeeman Barr to act as an alternate for Mayor Palombo during conflict issues involving Personnel and the Beach Patrol. During roll call vote four Committeemen voted in the affirmative. Mayor Palombo abstained.

shall be attached to this Resolution and kept in the files of the municipal clerk.

7. The contractor has registered with the State of New Jersey pursuant to c.57, Laws

of 2004 and has provided proof of that registration to the Township of Upper.

Section Two. Section 6(b) of The Original Bond Ordinance is hereby amended to read as follows:

Section Three. The appropriation and the amount of bonds or notes for the purposes described in Section 3(a) of the Original Bond Ordinance are hereby decreased by \$190,000 and \$180,500, respectively, to \$1,946,500 and \$1,849,175, respectively.

Section Four.
