APPROVAL OF MINUTES - July 11, 2016 Regular Meeting and
Closed Session Minutes A and B

Motion by Hobie Young, second by Jeffrey Pierson, to approve the July 11, 2016 Regular Meeting and Closed Session A and B Minutes as submitted. During roll call vote all four Committeemen present voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Hobie Young, Committeeman, inquired into several matters including the Township's beach maintenance plan. The engineer stated that in accordance with our beach maintenance plan portions of our beach are listed as a "No Rake" zone for nesting birds. In order to allow raking a permit modification would be required. Beaches that may be eligible for raking would be those in the recreational zone; from Webster to Hawthorn. Mr. Young next inquired into the condition of Mosquito Landing Road in Tuckahoe. The engineer reported that the public works department has been out all week rehabilitating the road to a subgrade level in preparation for future paving. This will also allow DPW to keep the pot holes under control in the interim. In addition Mr. Young inquired into the cleaning and maintenance of the roof and siding on Friendship School building. He next reported that he received a request from the Upper Township Hockey Association for reimbursement of materials to complete repairs on the metal building at the Amanda's Field Skate park. The CFO stated that there is approximately \$500 available for materials. Lastly Mr. Young stated that all of the Township's sports teams are doing very well. The Babe Ruth League won the State Championship and is now moving

forward into the National Tournament. Lastly he requested that the baseball games be posted on the Township's website and Channel 97.

Jeffrey Pierson, Committeeman, reported that the EMS department has received their new beach rescue vehicle and they are in the process of training employees on the new equipment.

OTHER REPORTS

Barbara Young, Municipal Clerk, reminded everyone that there has been a change in the meeting dates for August. The August Committee meetings will be held on August 1st and August 22nd beginning at 7:30 pm.

Daniel Young, Municipal Attorney, reported that there are contract negotiation and safety and security items for closed session.

Paul Dietrich, Engineer, reported that he has prepared the final street rehabilitation list for the upcoming paving project, and requested authorization to prepare the bid specifications and solicit bids. Motion by John Coggins, second by Jeffrey Pierson, to approve the request. During roll call vote all four Committeemen present voted in the affirmative. A resolution for formal action will be placed on the next agenda. He next reported that the DOT will no longer be detouring southbound traffic around the Route 50 Bridge on Sundays. Committeeman Coggins inquired as to when the water tower will be painted. Mr. Dietrich stated the company NJ American Water contracted to do the job has been having scheduling difficulties. As soon as they are available the water tower is next on the list.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.
2. Ansell Grimm & Aaron, PC and Lawrence H. Shapiro, Esquire with offices at 1500 Lawrence Avenue, Ocean, New Jersey are hereby appointed Special Legal Counsel to handle condemnation, eminent domain and land acquisition matters in conjunction with and at the direction of the regular Township Solicitor and as directed by the Township Committee.
3. This contract shall have a term of one (1) year from date of full execution.
4.
