




# **Preparing for Safe Camping**

The great outdoors are home to incredible works of nature, years of family memories, and hazards that can be prepared for and prevented. Before heading out on your next camping trip with friends or family, be sure to keep the following precautions in mind.



Research the park you plan to camp in for park regulations on fire, food storage and disposal, pets, and permits. Once you know which items are allowed into the park, pack accordingly; always bring a first aid kit, flashlight, insect and sun protection, and navigational supplies! Additionally, make sure all parties in your trip are up to date on recommended vaccines such as tetanus, pertussis,



You've made it to the park! Upon arrival, be sure to <u>ask a park ranger</u> for any environmental or weather related hazards that you should be aware of during your stay including the local animal risks. Set up camp using <u>guidelines for setting up a camp</u>, provided by the National Parks Service.

While in the wilderness, remain continuously aware of not only your <u>personal safety and health</u>, but your environment and fellow campers as well. Also remember there are many creatures around you also sharing the area and respecting surrounding <u>wildlife</u> is crucial for both your immediate safety (aggression, <u>diseases</u>) and the experience of future campers.

#### **Individual and Community Preparedness**

The Community Preparedness Intern will work under the supervision of the Community Preparedness Officer and/or the Integration Branch Chief, the intern will provide research, planning, and development of a series of preparedness programs. This graduate or undergraduate level internship will provide the student with an opportunity to gain experience in the Federal Government, Emergency Management, Community Development, and Partnership Coordination. The Community Preparedness Intern will also support the Community Preparedness Officer to plan, initiate, coordinate and execute the development of a Higher Education Preparedness Network, which will meet the needs of Region II states NJ and NY to build and support successful preparedness efforts.

#### **Continuity of Operations**

The Intern will support the Continuity Manager to help coordinate and manage the continuity of operations program for Federal, State level (New Jersey, New York, Puerto Rico and Virgin Islands) and tribal, local governments within Region II states. The intern will help the Continuity Specialists build continuity programming between FEMA and the Continuity of Operations Working Groups (CWG) and will help organize, manage and facilitate training and exercise events, write policy papers, evaluate programs, develop plans, conduct outreach, instruct classes help identify gaps or weaknesses in pandemic and cyber security planning policies procedures and attend meetings.

#### Requirements

- (1) Interns MUST be enrolled in a Graduate School or Undergraduate School in their Junior/Senior year.
- (2) Previous work or ongoing study at bachelor's level in public health, liberal arts, business, public administration, communications, training, economics, emergency management or public relations.
- (3) Interns must be United States Citizens only (green card holders or those with student visas/work permits are not allowed).
- (4) Accepted Interns must complete a background investigation and suitability of employment prior to start date (this process can take 4-6 weeks or longer).

He also answered some amazingly grown-up questions about a variety of disasters, such as the formation of hurricanes and earthquakes, how to stay safe in a tsunami, and about the burning of the White House in the War of 1812.

## **Exercise Design Course**

FEMA Region II will be conducting training for emergency exercise design and evaluation (a combination of FEMA Courses I-120 and L-146). The course is a 4 day program which focuses on the design phase of the Homeland Security Exercise and Evaluation Program (HSEEP).

#### Course details:

Emergency managers, emergency services personnel, and other individuals who are part of the emergency preparedness and response or continuity of operations need to be able to use the fundamentals of exercise simulation and design as an integrated system of resources and capabilities. Skills learned during this program will enable jurisdictions to conduct NIMS required exercises.

The course will develop emergency response and continuity exercise skills in the following areas:

- · Exercise programs
- · Exercise design steps
- · Exercise evaluation
- · Designing a functional exercise

- · Exercise process
- · Tabletop, functional and full scale exercises
- · Exercise enhancements

The course will conclude with students conducting and evaluating actual tabletop and functional exercises in a group/team environment.

# FEMA Region II Preparedness Webinar: Preparedness Planning for Senior Citizen Communities

**Description:** The senior citizen population faces several unique challenges, coupled with the fact that many are often dependent upon others for basic necessities and psychosocial support. This dependency often increases their vulnerability to the impacts of major disasters, when not only are the seniors themselves impacted, but these critical services are also disrupted. Currently, 46.2 million

people in the United States are 65 years old or older, with that number expected to increase each year. This population demographic made up 13.3% of the population in the 2011 Census. The ability to recover from an emergency tomorrow often depends on planning and preparation done today. This webinar will provide to older individuals and their caregivers, as well as to the local agencies who serve them, tools and information to assist them in assessing their needs and vulnerabilities so they can be better prepared to cope with emergencies.

**Speakers: Ms. Kathleen Otte** is the Regional Administrator for HHS Regions I and II for the U.S. Administration for Community Living (ACL). In this capacity, she represents the Administration and the Assistant Secretary on Aging on all matters related to the implementation of the Older Americans Act (OAA) and other aging related issues within the 8 states and 2 territories she oversees. Prior to joining AoA, Kathleen served as the Director of the Bureau of Elderly and Adult Services for the State of New Hampshire. Kathleen and the New Hampshire team designed and implemented a caregiver support program that received national distinction by winning the Regional Innovation Award from The Council of State Governments and developed the nation's first statewide 'Structured Decision Making' process for Adult Protective Services.

Kathleen has over 30 years' experience in the field of aging, having served or volunteered in various human service delivery programs. In 2014, Kathleen received the Spirit of Jane Addams Award for Outstanding Performance in Social Justice from Be the Evidence, International for her work with Elder Justice Initiatives.

Rhonda Schwartz is an Aging Services Program Specialist within the U.S. Department of Health & Human Services Administration for Community Living. Rhonda is assigned to the Regional Office located in Boston, MA, where she works with federal, state and tribal organizations in the region, with particular attention to oversight of the Older Americans Act state and tribal grant programs. Prior to joining ACL in July 2016, Rhonda spent more than seven years managing Older Americans Act and other ACL programs at the Rhode Island Division of Elderly Affairs. Rhonda previously practiced law for sixteen years, specializing in commercial real estate transactions, before pursuing a Masters Degree in Social Work, focusing on older adults.


- 2. Scroll to the bottom of the page and enter your zip code to find a nearby event.

- 5. Be sure to type "CERT team/program name" in the Group/Organization field so FEMA can recognize your participation.


# FEMA Tribal Outreach and Consultation Period on FEMA Tribal Consultation Policy

FEMA will initiate a 90-day outreach and consultation period from **June 1 to August 29, 2017**, to seek input from federally recognized Indian tribal governments on the update of the agency's Tribal Consultation Policy. The <u>FEMA Tribal Consultation Policy</u>, first issued in 2014, acknowledges the agency's nation-to-nation relationship with tribal governments. The policy also guides how FEMA engages tribal governments in regular and meaningful consultation and collaboration on policy and actions that have tribal implications.

This consultation period aims to update the policy to reflect current authorities and best practices, as well as follow FEMA's new policy document format requirements. FEMA seeks input and feedback from tribal leaders, or their designees, during the consultation period to help inform the development of an updated policy. # **Important Deadlines**

## **Hazard Mitigation Assistance Grant App Period Open**

The open application period began on August 14 for two competitive <u>Hazard Mitigation Assistance</u> grant programs. Eligible applicants including territories, federally recognized tribes, states and local governments may apply for the Fiscal Year (FY) 2017 <u>Flood Mitigation Assistance</u> (FMA) and <u>Pre-Disaster Mitigation</u> (PDM) grants at <a href="https://portal.fema.gov">https://portal.fema.gov</a> through **3 p.m. Eastern Daylight Time (EDT) on November 14, 2017**.

FMA grants are available to implement measures to reduce or eliminate risk of flood damage to structures insured by the <a href="Mational Flood Insurance Program">National Flood Insurance Program (NFIP)</a>. For FY 2017, \$160 million is available, including \$70 million for community flood mitigation activities that address flooding on a neighborhood level, such as floodwater diversion and localized flood-control measures as well as advance assistance for mitigation design and development of community flood mitigation projects. The remainder of funds will be used for mitigation planning, technical assistance and mitigating Severe Repetitive Loss and Repetitive Loss structures, which include elevation, acquisition, and relocation projects. PDM grants are awarded for all-hazard mitigation planning and projects, such as the construction of community and residential safe rooms for tornados, and wind retrofits, which are enhancements made to strengthen the roof, walls and doors of structures to minimize damage caused by high winds. This year, \$90 million is available, including \$10 million for federally-recognized tribes. States, tribes, territories and the District of Columbia may apply for the statutory allocation of up to \$575,000 federal share. The remainder of funds will be awarded on a competitive basis with an

emphasis on mitigation activities that complement the post-disaster funding available under the Hazard Mitigation Grant Program and the flood mitigation funding from the FMA program.

This Virtual Tabletop Exercises (VTTX) will focus on an earthquake occurring in your community, using historical events and Hazus simulations.

The VTTX involves key personnel discussing simulated scenarios in an informal setting, and can be used to assess plans, policies, training, and procedures. This VTTX differs from other tabletop exercises in that it will be conducted using Video-Teleconference (VTC) technology (not a web-based program), and is intended to provide an opportunity for responders across the Nation to simultaneously participate in a hazard-specific facilitated discussion. # More than 2 million reached through Air Force Fall Prevention Stand-Down

Each year the U.S. Air Force promotes an extensive campaign to remind and educate all its personnel about fall prevention and the risks associated with working at heights. This year's Air Force Fall Prevention Focus, held in conjunction with OSHA's National Safety Stand-Down, reached more than two million people, including active duty, Air National Guard, Air Force Reserve, civilians, contractors, and family members.

Across the world, Air Force members were encouraged to take breaks to discuss fall prevention measures, equipment, and policies with their supervisors. Bases hosted OSHA fall hazard awareness training, conducted live fall protection demonstrations, displayed safety messages, and commercials




were broadcast across the Armed Forces Network. Since the Air Force began focusing on fall prevention in 2014, work-related fall injuries have decreased nearly 31 percent.

# **Early-season Storms one Indicator of Active Atlantic Hurricane Season Ahead**

The average Atlantic hurricane season has 12 named storms. According to <u>estimates from NOAA</u>, this season is above-normal, with 14 to 19 named storms and 2-5 major hurricane hazards.

This is a boost from May, which predicted 11 to 17 named storms and 2-4 major hurricanes. NOAA says "the updated outlook is based on the current and evolving atmospheric and oceanic conditions, the most recent model predictions, and pre-and early-season storm activity." NOAA and FEMA encourage those with hurricane risk to make preparedness plans for their families. You can check recent forecasts at the National Hurricane Center.

# **Planning to Recover from Emergencies at Schools**

August 25, 2017, 2pm EDT

The REMS TA Center, on behalf of the U.S. Department of Education's (ED) Office of Safe and Healthy Students (OSHS), will host a Webinar on how K-12 schools and districts can better plan to recover from emergency events and be ready for all hazards and threats that may impact their school community.

Presenters will describe key considerations for recovery; present the process for including recovery activities in planning efforts; and share lessons learned from the 2014 Washington Oso landslide and Marysville-Pilchuck High School active shooter situation, and the Moore, Oklahoma tornado in 2013. During the Webinar, presenters will focus on the four recovery components of academics; physical and structural; business functions; and social, emotional, and behavioral recovery.

This event will also feature a dedicated 15-minute Q&A session during which presenters will field questions from participants.
