APPROVAL OF MINUTES -

June 26, 2017 Regular Meeting and Closed Session Minutes

Motion by Edward Barr, second by John Coggins, to approve the June 26, 2017 Regular Meeting and Closed Session Minutes as submitted. During roll call vote all four Committeemen present voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Edward Barr, Committeeman, made a motion to hire Dylan Siciensky as a seasonal laborer in the Department of Public Works due to a recent vacancy. The motion was seconded by Curtis Corson. During roll call vote all four Committeemen present voted in the affirmative. He next stated that the Township's recycling collection program for commercial businesses will start soon and recommended that the Township provide the first dumpster free of charge to each commercial business. It was stated that the dumpsters were purchased through the Recycling Trust Fund, however the Ordinance will need to be reviewed to see if there is a fee already established for the dumpsters. Committeemen Corson suggested that the new program not be required for seasonal businesses in the middle of the season, as it will take time to implement compliance with the program. There was a motion by Edward Barr, second by John Coggins, to provide the first commercial dumpster to each business free of charge pending review of the Ordinance. During roll call vote three of the Committeemen present voted in the affirmative. A Resolution or Ordinance will be placed on the next agenda for formal action. Committeeman Corson abstained.

Curtis Corson, Committeeman, reported that this past Friday the Township dedicated a new Beach Patrol boat, which was named after Mayor Palombo, and stated that the Mayor's wife did an excellent job organizing the event.

Richard Palombo, Mayor, thanked the Strathmere Improvement Association and Linda Brown from the Deauville for their hospitality at the Strathmere 4th of July parade. The event was very well attended. He also stated that the Fireworks also went very well and thanked everyone for assisting with the event.

OTHER REPORTS

Scott Morgan, Township Administrator, reported that the 4th of July events went very well. He thanked the Clerk's Office, Public Works, the Cape May County Sheriff's Department, the Upper Township OEM, the CERT Volunteers, and the Upper Township EMS and Rescue Squad. He next reported that the commercial recycling dumpsters will be delivered later in July. Next, he reported that the No Left Turn sign that Committeeman Young had requested for the Oasis Market has been delivered and will be installed next week. Lastly, he reported that he has received several complaints of speeding on Neptune Avenue in Strathmere. He stated that some residents had installed a few homemade speed bumps along Neptune, which have since been removed.

Daniel Young, Municipal Attorney, reported that there are personnel, litigation, and contract negotiation items for closed session.

Paul Dietrich, Township Engineer, reported on correspondence regarding the remediation of the Sam's Gulf Station. The Township's remediation consultant has confirmed that if the Township were to dedicate the property to Open Space, an NJDEP grant would fund 75% of the project. Alternatively, if the Township were to use the property for Affordable Housing, a NJDEP grant would fund 50% of the project. The Municipal Attorney stated that the Township does not own the property, it is owned by an estate which does not have the assets to remediate the site. The only way to dedicate the property to Open Space would be to have the estate deed the property to the Township once it's cleaned. It was further stated that the value of the property is not worth significantly more than the costs of the cleanup, however the contamination at the site does need to be addressed for the good of the surrounding community. The Engineer was directed to reach out to the estate to see if they are willing to deed the property to the Township. He next reported that the Bikeway Steering Committee will be having their initial meeting later this month.

Barbara Spiegel, Chief Financial Officer, reported that Borgata has offered to donate a Polaris ATV to the Beach Patrol, and requested a motion from the Committee to accept the vehicle. It was further stated that although the Township will own the vehicle, Borgata signage will remain on the vehicle, and as such, Borgata has requested that the Township sign an indemnification agreement and confirm that we have the appropriate insurance coverage. Motion by Richard Palombo, second by John Coggins, to accept the donation of the Polaris ATV from Borgata. During roll call vote all four Committeemen present voted in the affirmative.

The Township Administrator shall perform such duties in each department under the general supervision of the member of the Township Committee appointed by the Township Committee as the head of such department.

Section 2-3.5 is replaced in its entirety with the following:

Section 2-3.5 Establishment of Other Township Departments. The following departments are hereby established by the Township of Upper and each such department shall have a member or members of the Township Committee appointed by the Township Committee to serve as director and head of such department: Public Safety, Buildings and Grounds, Revenue and Finance,

Municipal Court, Animal Control, Personnel, Lifeguards, Division of Emergency Medical Services (EMS), Housing, Engineering, Clerk's Office, Zoning and Planning, Construction Code and Information, Technology and Communications.

SECTION 2: Chapter V (Personnel) of the Revised General Ordinances of the

Township of Upper, also known as the Code of Upper Township, Section 5-6.2 shall be amended and supplemented as follows:

Add the Following Positions:

General Supervisor Public Works Supervisor Sanitation

Delete the Following Positions:

Road Repairer Supervisor Road Repairer 3

SECTION 3: REPEALER: All Ordinances or parts of Ordinances inconsistent
