**Closed Session Minutes** 

Motion by Edward Barr, second by John Coggins, to approve the July 10, 2017 Regular Meeting and Closed Session Minutes as submitted. During roll call vote four Committeemen voted in the affirmative. Committeeman Young abstained.

# **REPORT OF GOVERNING BODY MEMBERS**

**John Coggins, Committeeman**, reported that the Economic Development Commission has been meeting for the past four months during which they have been focusing on a vision plan for the Township to enhance economic development, development of the Town Centers, and to find ways to make the gateway areas more attractive. He requested the Committee to allow the president of the EDC to attend the next Committee meeting to give a brief presentation of the vision plan. The Committee agreed that an update would be a good idea, and directed that the presentation be listed on the next agenda.

**Hobie Young, Committeeman**, reported that the 4<sup>th</sup> of July event was a great success, with just a few issues to work on. He thanked Scott Morgan and the Office of Emergency Management for their help with coordinating the safety plan for the event. He next thanked Shawna Mulford for all of her work organizing the event and requested a Resolution honoring her for her hard work. He also requested a resolution thanking Cape Regional for their generous donation. Resolutions for formal action will be placed on the next agenda. Next, he reported on possibly inviting the Fleming Pumpkin Run to hold their annual car show event this year in Upper

Township during the first weekend in November. There was a brief discussion regarding several logistical and administrative issues that will need to be worked out. There was then a motion by Curtis Corson, second by Ed Barr, to approve of Committeeman Young moving forward with organizing the car show as a Township sponsored event. During roll call vote all five Committeemen voted in the affirmative. Lastly, Committeeman Young stated that the irrigation and top soil need to be installed at Caldwell Park. He stated that Tuckahoe Turf Farms has stated that they would donate turf, however the irrigation and top soil project need to be completed first. The Township Administrator stated that he would review the schedule.

#### **OTHER REPORTS**

Scott Morgan, Township Administrator, congratulated Public Works on their efforts in being one of two municipalities to reach the Cape May County MUA goal of 50% in Municipal Solid Waste Diversion. The CMC MUA report shows Upper Township reaching 57.02% of diversion. He next reported that the commercial containers from Midlantic will arrive on Friday, and will be dispersed to the commercial properties soon after. He next reported that he and the Township Engineer will soon have a meeting with the MUA to discuss the renewal of the Host Community Benefit Agreement. Lastly, he reported that he and the Township Engineer have been working with Verizon regarding the connectivity issue with Verizon Wireless in Town Hall. Verizon Wireless has provided at no cost to the Township a 4G LTE Network Extender which has been installed and has appeared to help the connectivity issue.

**Daniel Young, Municipal Attorney**, reported that there are a number of contract negotiation, litigation, safety and security, and personnel items for closed session.

**Paul Dietrich, Township Engineer**, reported that the Coastal Coalition has recently applied for a \$25,000.00 grant to perform a study to rebuild the shoreline in Strathmere near the Bayview Boat Ramp.

**Barbara Spiegel, Chief Financial Officer**, requested approval for a Public Works employee to attend a 3 day course in Pennsylvania in order to obtain his playground inspection certification. Motion by Ed Barr, second by Hobie Young, to approve the request. During roll call vote all five Committeemen voted in the affirmative.

#### **ORDINANCE NO. 010-2017**

# AN ORDINANCE UPDATING CHAPTER III POLICE REGULATIONS, WITHIN THE TOWNSHIP OF UPPER, COUNTY OF CAPE MAY AND STATE OF NEW JERSEY

**BE IT ORDAINED** by the Township Committee in the Township of Upper, County of Cape May and State of new Jersey as follows:

**SECTION 1:** Chapter III, Section 3-12, of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended as follows:

#### **Replace in its entirety Section 3-12.1:**

#### 3-12.1 Definitions.

As used in this section, the following terms shall have the meaning indicated:

Certified Coach shall mean a coach of an approved Upper Township Sports Program.

Department Head shall have the meaning of "Supervisor" as defined herein.

*Indoor place* shall mean a structurally enclosed area.

*Public Facility* shall mean any municipally owned building and/or property that has a building or other improvements like athletic fields and maintained paths.

*Smoking* shall mean the burning of a lighted cigar, cigarette, pipe, e-device or any other matter or substance which contains tobacco.

*Supervisor* shall mean the person who ultimately controls, governs or directs the activities and conduct of employees within a certain department or division.

# **Replace in its entirety Section 3-12.2:**

# 3-12.2 Smoking Prohibited.

Smoking shall be prohibited at all times at all Township Public Facilities.

#### Replace in its entirety Section 3-12.3a:

# 3-12.3a. Violation of Prohibition; Request to Comply; Denial of Services.

a. Any Certified Coach, Department Head or Supervisor, or their designee, may order any person smoking in violation of this section to comply with the provisions hereof. Thereupon, any member of the public who smokes in the Public Facilities is in violation of this section, shall be subject to a fine as hereinafter provided.

#### Replace in its entirety Section 3-12.4:

#### 3-12.4 Posting of Signs.

The Township shall install appropriate signs which shall be posted in conspicuous places throughout Public Facilities affected by this section advising the public and employees that smoking is prohibited.

**SECTION 2:** Chapter III of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be revised to add the following Section 3-18:

#### 3-18 Release of Balloons

#### 3-18.1 Release of Balloons - Purpose and Intent.

The intent of this section is to protect the environment, particularly the wildlife, and the health, safety and well-being of persons and property by prohibiting the release of helium balloons into the atmosphere, including latex and mylar, as it has been determined that the release of balloons inflated with lighter-than-air gases pose a danger and nuisance to the environment, particularly to wildlife and marine animals so as to constitute a public nuisance and may pose a threat to the safety of its inhabitants and their property.

#### 3-18.2 Prohibited Releases.

It shall be unlawful for any person, firm or corporation to intentionally release, organize the release, or intentionally cause to be released balloons inflated with a gas that is lighter than air within the Township of Upper, except for:

- (a) Balloon released by a person on behalf of a governmental agency or pursuant to a governmental contract for scientific or meteorological purposes.
- (b) Hot air balloons that are recovered after launching.
- (c) Balloons released indoors.

#### 3-18.3 Violations and Penalties.

Any person found in violation is guilty of a non-criminal infraction punishable by a fine not to exceed the sum of \$500.00.

**SECTION 3: REPEALER:** All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

**SECTION 4: EFFECTIVE DATE:** This Ordinance shall take effect immediately upon final adoption and publication as required by law.
