# <u>APPROVAL OF MINUTES</u> - April 13, 2015 Regular Meeting and Closed Session Minutes

Motion by Edward Barr, second by Jeff Pierson, to accept the April 13, 2015 Regular Meeting and Closed Session Minutes as submitted. During roll call vote four Committeemen voted yes. Committeeman Young abstained.

## REPORT OF GOVERNING BODY MEMBERS

Hobie Young, Committeeman, gave a brief report on the Amanda's Field project. The grading and drainage projects are almost complete, and proposals are being gathered for the concrete block for the concession stand and bathrooms. He next reported that a meeting for the 4<sup>th</sup> of July event will be held next Wednesday at 7:00 pm. Volunteers are needed for the event planning. Next, Mr. Young reported that during the last Sports and Recreation Advisory meeting a change to the bylaws was discussed regarding the residency requirements of the board members of the various Associations. Currently there is a mix of resident and nonresident members. The Recreation Advisory Board is recommending a requirement that 75% of the Board members be Upper Township residents. It was stated that the membership on these boards should be all Upper Township residents. After a brief discussion, there was a motion by Hobie Young, second by Edward Barr, to authorize the Municipal Attorney to draft an Ordinance requiring that all Association Board Members of Township approved ongoing programs be residents of Upper Township. During roll call vote all five Committeemen voted in the affirmative. An Ordinance will be drafted for introduction at a future meeting. Lastly, he gave a brief report on the accomplishments of the

Upper Township Wrestling team. Committeeman Young requested that once the tournaments are completed, a Resolution congratulating the members be placed on a future agenda.

**Edward Barr, Committeeman**, reported that the Township is currently collecting leaves and brush, and encouraged the public to report any potholes to the Public Works Department.

**Richard Palombo, Mayor**, reported that the Township has received several complaints regarding ATV vehicles trespassing through Amanda's Field and private property in Sunset Acres in order to access the mining pits. The State Police have been notified and are aware of the issue.

#### **OTHER REPORTS**

**Barbara Young, Municipal Clerk**, reported that the Day of Pray ceremony will be held on Thursday May 7 at 10:00 am. All are welcome to attend.

**Daniel Young, Municipal Attorney**, reported that there are a number of closed session items; contract negotiations, a potential litigation matter, and a personnel matter.

**Paul Dietrich, Municipal Engineer**, gave a brief report on the beach fill project. The dredge is currently still in dry dock in Norfolk awaiting Coast Guard certification. It is anticipated that the beach fill will begin from Hawthorn Avenue up to the North end. The dredge will then move to Avalon, and will come back to finish south to Whale Beach approximately the first week of July. He next reported that final paving of Bayview Drive will be finished next week and the project should be completed within the next week or two. He next reported that a kickoff meeting was recently held with the DEP and other partners involved in the Bayview Avenue boat ramp project. The Township has received a grant for this project. The permitting process should start over the next month and bids should go out in the fall. Lastly, he reported that bids for the cell tower leases on Mt. Pleasant Road were advertised last week. The bid due date is May 28<sup>th</sup> and the results will be reported. Mayor Palombo inquired into the progress of Hope Corson Road. Mr. Dietrich stated that the curb work and drainage should begin this week. The road will be closed to through traffic once they begin. It was stated that additional signage should be posted to prevent commercial vehicles from using the Township streets.

Barbara Spiegel, Chief Financial Officer, reported on a request from the Municipal Court Administrator for a one night hotel stay for a required two day class in Trenton. The cost of the room will be less than \$60.00. Motion by Jeff Pierson, second by Edward Barr, to approve the request. During roll call vote all five Committeemen voted in the affirmative. Ms. Spiegel next requested approval for the Tax Collector to attend a conference in Atlantic City on May 19<sup>th</sup> and 20<sup>th</sup> at a cost of \$300.00. Motion by John Coggins, second by Mayor Palombo, to approve the request. During roll call vote all five Committee members voted in the affirmative. Lastly, she reported that the Township is required to submit a report to COAH regarding the Township's affordable housing trust. For 2014, the Township received \$118,000.00 in receipts and paid out, through the Township's rehabilitation projects, \$50,000.00, leaving a current balance of approximately \$441,000.00. She requested authorization to sign and submit the certification to COAH. Motion by John Coggins, second by Jeff Pierson, to authorize the CFO to sign and submit the report. During roll call vote all five Committeemen voted in the affirmative.

# HONORING THE MEMORY OF KITTIE (LEAMING) KING, A WOMAN AIR FORCE SERVICE PILOT AND WORLD WAR II VETERAN, FOR HER YEARS OF SERVICE TO THIS COUNTRY

WHEREAS, Kittie (Leaming) King served this country with absolute integrity and dedication as a Woman Air Force Service Pilot earning the respect, admiration and high regard of all whom she came into contact; and

WHEREAS, at the age of 94 on March 10, 2015 Kittie (Leaming) King passed away, leaving her family and this community with a deep feeling of sorrow for the loss of such an honored and respected loved one and citizen; and

WHEREAS, we are forever grateful for her diligent and unselfish service to this country; and

WHEREAS, while attending the U.S.C. in California, Kitty became fascinated with flying and was ultimately accepted into the newly formed Woman's Air Force Service Pilots (WASP) graduating in the 43-4 class at Avenger Field in Sweetwater Texas; and

WHEREAS, the WASP'S predecessor, the Woman's Flying Training Detachment (WFTD) and the Woman's Auxiliary Ferrying Squadron (WAFS) organized separately in September 1942; and

WHEREAS, the WASP was the pioneering organization of civilian female pilots, employed to fly military aircraft under the direction of the United States Army Air Force during World War II; and

WHEREAS, the WFTD and the WAFS were merged on August 5, 1943 to create the paramilitary WASP organization; and

WHEREAS, out of the 25,000 woman that applied only 1,074 were accepted into the WASP'S to fly military aircraft during WWII; and

WHEREAS, in 1977 the WASP was granted Veteran status and in 2010 President Barrack Obama and the United States Congress awarded Kitty, along with all WASP'S the Congressional Gold Medal; and

**WHEREAS,** Kitty will always be remembered for her service to this country which she undertook with the utmost commitment, honor and integrity; and

WHEREAS, it is just and deserving that on behalf of the residents of Upper Township, we honor and celebrate the life of Kitty; and

NOW THEREFORE BE IT RESOLVED that this Township Committee join with all citizens of our community to pay tribute to the life and service of Kitty (Leaming) King, and do hereby extend to Kitty's family our most heartfelt sympathy for their loss and the hope that they will be consoled by the memories of her fine life and achievements.

WHEREAS, the Rutgers Economic Advisor Service, E/ECON recently conducted a study measuring and modeling the economic contributions to the state's economy of our Federal Military installations; and

WHEREAS, the Rutgers Economic Advisor Service determined that, in net, the Federal Government spent nearly \$4.8 billion within the state, generating over 45,600 jobs which pay \$2.6 billion in salaries and add \$3.8 billion of wealth to New Jersey residents; and

WHEREAS, the aforesaid \$4.8 billion in Federal Spending in New Jersey generates \$9.6 billion in net business revenues here; and

WHEREAS, of this total, \$4.5 billion is new wealth and was added in the form of gross domestic product by the State; and

**WHEREAS,** of this Gross Domestic Product total, over \$4.0 billion is in the form of labor income that supports an estimated 73,234 jobs; and

WHEREAS, all New Jersey Military installations make significant individual and

collective contributions to the capabilities of our Armed Forces and our National Security; and

WHEREAS, maintaining and expanding this military core is nearly as critical for

New Jersey's continued economic welfare as it is to its homeland security missions; and

WHEREAS, in the era of federal fiscal austerity, policymakers in our Nation's

Capital will be asked to consider proposals to reduce defense spending and the size of our uniformed

services.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the

Township of Upper, County of Cape May strongly urges the Governor and the New Jersey State

Legislature to take immediate steps to protect these valuable military assets, in recognition of their

vital importance to our Nation's and our State's security.

officials serving New Jersey at all levels of government to work in concert to promote the

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee, the governing body of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. **SHARED SERVICES AGREEMENT**. Pursuant to the provisions of the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et. seq., the Township of Upper is hereby authorized and empowered to enter into a Shared Services Agreement with Dennis

Township pertaining to Dennis Township providing clerical and administrative services to Upper Township for the Construction Code Office.

- 2. **SERVICES TO BE PROVIDED BY CONTRACT.** The Shared Services Agreement authorized in paragraph 1 shall cover those services which are enumerated in said Agreement, a copy of which is attached hereto as Exhibit A.
- 3. AUTHORIZATION OF MUNICIPAL OFFICIALS. The appropriate Township officers and officials are hereby authorized to take any action necessary or advisable to carry out the intent and purpose of this Resolution. Specifically, the Mayor and Township Clerk are hereby authorized and directed to execute such Shared Services Agreement on behalf of the Township of Upper pursuant to the authority conferred by this Resolution. The Township Clerk is further authorized and directed to seal said Agreement with the seal of the Township of Upper. Additionally, the Mayor is authorized to negotiate modifications in the language of the Agreement prior to his final execution of same so long as said modifications are consistent with the intent and purpose of the authority granted by this Resolution.
- 4. **COMPLIANCE WITH STATUTORY REQUIREMENTS.** The Shared Services Agreement between the Township of Upper and the Township of Dennis shall meet and satisfy the requirements of N.J.S.A. 40A:65-7, as may be amended and supplemented.
- 5. **CONTRACT TERM.** This Resolution authorizes a Shared Services Agreement for a duration of one (1) year, subject to renewal or termination as provided for in the agreement.
- 6. **SEVERABILITY.** If any action, subsection, paragraph, sentence or other part of this Resolution is adjudged to be unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Resolution, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Resolution directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Resolution shall remain in full force and effect.
- 7. **REPEALER.** All Resolutions or parts of Resolutions inconsistent herewith are hereby repealed to the extent of such inconsistency only.

13. Accepting the annual stormwater report and certification and authorizing the Township engineer to electronically sign and submit it to the NJDEP pursuant to stormwater rules.

Municipal Engineer Paul Dietrich gave a brief report on the Township's efforts to ensure any stormwater runoff is as clean as possible. The Township currently has approximately 750 stormwater basins and collection systems throughout the Township that are maintained and inspected on a regular basis. After each rainfall of more than an inch, all of the basins are inspected to ensure optimal operation. During 2014 the Township performed regular street sweeping of over 688 miles of roads within the Township, collected approximately 117 cubic yards of material and approximately 25 tons of material out of the stormwater inlets. The next phase of the permit requirements will be to ensure that private facilities are also maintained, including mapping the private facilities and keeping a log of when those areas have been inspected.
