### <u>APPROVAL OF MINUTES</u> - April 27, 2015 Regular Meeting and Closed Session Minutes

Motion by Jeffrey Pierson, second by Edward Barr, to approve the April 27, 2015 Regular Meeting and Closed Session Minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

#### REPORT OF GOVERNING BODY MEMBERS

**Hobie Young, Committeeman,** reported that an organization meeting for the 4<sup>th</sup> of July event will be held on Tuesday, May 12 at 7:00 pm at Levari's, and will be held every Tuesday night until the event. He next requested if 3 or 4 Township employees can be utilized during the July 4<sup>th</sup> event to monitor the restrooms, concession stand, parking, and handle any equipment issues that may arise. Committeeman Young next reported that there are still issues with cars parking in No Parking zones at Amanda's Field. He requested that the Township look into what steps can be taken to solve this problem. He next reported that he and the other Committee members attended the County's Coast Guard Community Ceremony. He stated that the event was well attended and successful. Lastly, Committeeman Young inquired into the status of the grading of the Beesley's Point boat ramp parking lot. The Municipal Engineer stated that Public Works have been working on the area and have the lot nicely graded. The NJ Turnpike Authority bridge construction workers have been notified that parking will not be available at the boat ramp lot during the summer season.

**Edward Barr, Committeeman**, reported that there have been four vacancies in the Road Department since the beginning of the year. He requested that the Township hire 4 part-time or seasonal employees for the busy summer months. After a brief discussion, there was a motion by Edward Barr, second by Richard Palombo, to direct the personnel officer to advertise for three seasonal positions with the Public Works department for 32 - 40 hours per week ending September 30<sup>th</sup>. During roll call vote all five Committee members voted in the affirmative.

**Jeffrey Pierson, Committeeman**, commended the County and the Coast Guard for the wonderful event this past weekend celebrating the designation of Cape May County as a Coast Guard Community. He next reported that the EMS will be hosting a Meet the Crew event on May 16, 2015 from 1:00 to 3:00 at Amanda's Field. The Rescue Squad is also holding a fundraising event on May 30, 2015 from 2:00 to 6:00 at the Tuckahoe Inn. He encouraged everyone to come out and support the EMS and Rescue Squad crew.

**Richard Palombo, Mayor,** reported that he and CFO Barbara Spiegel have recently received quotes for dental insurance for Township Employees and were able to negotiate an agreement with Delta Dental for a zero rate increase. He made a motion, second by John Coggins, to renew with Delta Dental at the same rate as last year. During roll call vote all five Committee members voted in the affirmative. Mayor Palombo next reported that the VFW will be holding Memorial Day services on Monday May 25<sup>th</sup> beginning at 8:00 am.

#### **OTHER REPORTS**

**Barbara Young, Municipal Clerk**, reported that the Municipal Offices will be closed for the Memorial Day holiday on Monday May 25<sup>th</sup>, and the next regular Committee meeting will be held on Tuesday May 26<sup>th</sup>.

**Daniel Young, Municipal Attorney,** reported that there are a few items for closed session; personnel and a contract negotiation matters.

Paul Dietrich, Municipal Engineer, reported that the Strathmere beach fill is underway and is progressing well. The beach and dune from Hawthorn Avenue to Prescott Avenue has been completed. He reminded the public that all of the beach access areas on the Northern end are closed because of safety concerns. He next reported that the County is continuing the project on Hope Corson Road and is progressing well. The road is closed to thru traffic and a detour route has been posted. Lastly, he reported that New Jersey American Water has started the construction of the new water tower in Seaville and the new well facility in Marmora. They are currently installing the piping for the new well facility on Stagecoach Road between Tuckahoe Road and Roosevelt Boulevard.
