#### **CORRESPONDENCE**

#### **PUBLIC COMMENT**

**Kevin Grubb, Greenfield**, questioned if the affordable housing units for the Osprey Cove project will be located offsite, and if so, how will the units be assessed. It was stated that per the developer's request, the developer will locate existing structures within the Township which will then be rehabilitated and designated as affordable housing units. The Township's Assessor takes into account deed restrictions and the market value of the property and sets the assessed value as such. Later in the meeting, Mr. Grubb inquired if the Township will be requiring certain residents to place their trash carts on only one side of the road. It was stated that on narrow roads, one way roads, or on cul-de-sacs which are difficult for the trucks to maneuver, the Township will be designating the trash collection area for one side of the road. It was stated that this is an industry safety standard, and is done for the safety of the residents and the drivers.

**Lieutenant Pearson, NJSP Station Commander**, reported that there is a new class of Troopers out in the Community. He has had several community outreach programs within Upper Township and will be planning more events in the future. Mayor Palombo congratulated Lt. Pearson on his outreach efforts and the success of the Medicine drop program. Committeeman Pierson stated the State Police also attend the fire company meetings and their work and efforts are greatly appreciated.

**Ralph Cooper, Gladwynn Drive**, gave a brief report on the upcoming activities of the Upper Township Business Association and the Upper Township Green Team. He thanked the Committee for their support and cooperation. Regular meetings of the Green Team are held on the third Thursday of each month at the Upper Township Library at 5:30.

Robert Grimley, Ocean Avenue, requested that the Township offer an additional Pre-K program. Mayor Palombo stated that for that type of request it should be directed to the Upper Township Board of Education. Mr. Grimley also requested that he be given the choice of using an additional trash can, other than the Township issued can, when he has excess trash. He stated that he can purchase an extra can for less that the Township's cost of \$100.00 for an extra can. It was stated that the Township issued cans are under warranty and have been chosen for their durability and wind resistance to help keep the trash from blowing around. It was also stated that the Township issued cans have a tracking chip that can be used to quantify trash and recycling collection data.
