- 8. Review of appropriateness of rumble strips on state highway Mayor Palombo stated that this matter was brought up during public comment at the last Committee Meeting, in which a resident requested that the Township urge the NJDOT to not install rumble strips along Route 49 because of the noise disturbance for area residents. Based on that request, the Committee asked for some background information from the State Police. Lt. Pearson, NJSP Woodbine Station Commander, spoke regarding the many studies that show the effectiveness of the rumble strips to keep drivers alert and reduce the number of distracted driver accidents. Mr. Briggs stated that NJDOT regulations specify that rumble strips should be installed regardless of whether the road is a passing zone or not, and the Federal Highway Administration has stated that the installation of rumble strips on rural roads reduce the number of head fatality crashes by 44%. After a lengthy discussion, there was a general consensus that the safety benefits of the rumble strips far outweighs any noise nuisance. Motion by Richard Palombo, second by Edward Barr, to table discussion on this matter. During roll call vote all five Committeemen voted in the affirmative.
