APPROVAL OF MINUTES -

November 21, 2016 Regular Meeting and Closed Session Minutes

Motion by John Coggins, second by Hobie Young, to approve the November 21, 2016 Regular Meeting and Closed Session Minutes as submitted. During roll call vote all four Committeemen present voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

John Coggins, Committeeman, reminded all Township departments that all budget requests must be submitted to the CFO by the week before Christmas for consideration in the 2017 Budget.

Hobie Young, Committeeman, reported that the Township sports teams had a very good year with the Youth Soccer teams taking home wins at the State level and the JV Football team defeating Galloway Township over the weekend to win the 2016 League Championship.

Edward Barr, Committeeman, encouraged everyone to give to those less fortunate and reminded everyone that there is a Toys for Tots bin located in Township Hall foyer. He also reminded everyone that the next Committee meeting is Monday December 19th. He next asked for a report from the Superintendent of Public Works on the progress of leaf collection; crews are currently finishing up in the Seaville and Petersburg sections of the Township and will be starting their second round once those areas are complete. Mr. Barr next reported that the Township will be implementing a new program for leaf collection. Yard signs be placed

in neighborhoods prior to leaf collection to notify residents when DPW crews will be in their neighborhood to collect leaves.

OTHER REPORTS

Daniel Young, Municipal Attorney, reported there are contract negotiation, litigation and personnel matters for closed session.

Paul Dietrich, Municipal Engineer, gave an update on the progress of the Bayview Avenue Boat Ramp project; the contractor anticipates construction on the ramp to be completed by the end of the year. He next reported on a request from the County Engineer for a resolution of support for road improvements on Corson Tavern Rd. Motion by Hobie Young, second by John Coggins to direct a resolution be placed on the next agenda in support of the Corson Tavern Road project. During roll call vote all four Committee members voted in the affirmative.

Barbara Spiegel, Chief Financial Officer, requested approval for a Senior EMT to attend a three-day class on emergency response to domestic biological incidents in Gloucester County at no cost to the Township. Motion by John Coggins, second by Curtis Corson, to approve the request. During roll call vote all four Committeemen present voted in the affirmative.

RESOLUTION NO. 268-2016

A RESOLUTION IN SUPPORT OF SENATE BILL S-2254 AND ASSEMBLY BILL A-3821 WHICH AFFIRMS THE LANGUAGE AND LEGISLATIVE INTENT OF THE FAIR HOUSING ACT

WHEREAS, the Township Committee of the Township of Upper supports the provision of affordable housing in a reasonable, rational and achievable way, consistent with economic realities and sound planning; and

WHEREAS, pursuant to the March 2015 New Jersey Supreme Court order which transferred oversight of the Fair Housing Act (FHA) to the courts, hundreds of municipalities filed declaratory judgment actions to voluntarily comply with their State imposed affordable housing requirements; and

WHEREAS, in February, the Ocean County Superior Court included a distinct "gap period" analysis retroactively over an additional 16 year period, separate and apart from the normal 10 year present and prospective need; and

WHEREAS, the Appellate Division recently in a unanimous decision overturned the February Ocean County Superior Court decision and held that municipalities are only responsible to address the ten year present and prospective need, not any "gap period" number; and

WHEREAS, the New Jersey Supreme Court has, for the stated purposes of, "...judicial economy and efficiency based on the large number of actions involved. The Court makes no findings as to the reasonable probability of success on the merits, irreparable harm, or the relative hardship to the parties," agreed to hear an appeal of the Appellate Division ruling in late November; and

WHEREAS, the Fair Housing Act (FHA) and existing case law, requires that "present and prospective fair share of the housing need in a given region ... shall be computed for a 10-year period." [N.J.S.A. 52:27D-307(c)]; and

WHEREAS, the "gap issue" arises out of the inability of the New Jersey Council on Affordable Housing to promulgate third round regulations from 1999 to the present or make any final determination as to state and regional housing need, as well as constant litigation by certain groups; and

WHEREAS, any retroactive "gap" obligations could have significant and unfunded impacts on municipalities, may double count households under both present and prospective need, and will likely result in forcing municipalities and their property taxpayers to subsidize development; and

WHEREAS, this issue needs a resolution which provides both certainty and an achievable path forward so municipalities can proceed with planning for and implementing their affordable housing obligations; and

WHEREAS, Senate Bill S-2254, sponsored by Senators Greenstein and Bateman, and Assembly Bill A-3821, sponsored by Assemblymen DeAngelo and Benson, re-affirm the language and legislative intent of the Fair Housing Act, so as to preclude significant unfair impacts and instead further progress toward a more rational statewide housing policy, including reasonable and achievable obligations for municipalities, facilitate municipal compliance and the actual provision of affordable housing.

NOW, THEREFORE, BE IT RESOLVED, on this 5th day of December, 2016 by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.

2. The Township Committee strongly urges New Jersey Legislators to immediately reaffirm the language and legislative intent of the Fair Housing Act (FHA) and expressly clarify that the municipal affordable housing share is the sum of present and prospective need for the enumerated ten year period.

3. The Township Committee supports Senate Bill S-2254 and Assembly Bill A-3821.

4. 8. Accepting the Bid and authorizing the execution of a contract for the 2016 Paving Project. The Municipal Attorney explained that four bids were received with Arawak being the lowest bidder at approximately \$16,000 less than the next lowest bidder, South State. Shortly after receipt and review of the bids an objection by South State to Arawak's bid was filed by their legal counsel who is arguing that the Bid Bond submitted by Arawak Paving company was defective, arguing that it did not have the name of the company listed where the President signed and allegedly did not have the contract attached. The Municipal Attorney stated that in his review of the lowest bid along with the review of the CFO, Engineer and Special Counsel the bid submitted by Arawak Paving was found to be accurate and not materially or fatally defective as claimed by South State, therefore it is his recommendation along with the Townships Special Counsel that the Township award the bid to the lowest bidder, Arawak Paving Company.

RESOLUTION NO. 275-2016

RE: ACCEPTING THE BID AND AUTHORIZING THE EXECUTION OF A CONTRACT WITH ARAWAK PAVING COMPANY, INC., FOR 2016 PAVING PROJECT

WHEREAS, on October 17, 2016, the Township of Upper solicited bids for

its 2016 Paving Project, which four (4)bids were received on November 1, 2016; and

WHEREAS, the purpose of the competitive-bidding process is to secure the

most economical result in the expenditure of public moneys by promoting uninhibited competition and guarding against favoritism, improvidence, extravagance and corruption; and

WHEREAS, the bid solicitation called for the submission of pricing for twenty nine (29) items making up the 2016 Paving Project; and

WHEREAS, at the time and place for bidding, the Township received four

(4) bids as follows:

1. Arawak Paving Company Inc.

Items 1 to 29 Total - \$1,557,600.00

2. South State, Inc.

Items 1 to 29 Total - \$1,573,731.36

- 3. <u>Landberg Construction, LLC</u> Items 1 to 29 Total - \$1,835,485.29
- 4. AE Stone, Inc.

Items 1 to 29 Total - \$1,809,000.00

WHEREAS, the Township Solicitor's office reviewed the bids and determined that each was legally compliant; and

WHEREAS, on or about November 11, 2016, the Township received a letter of protest from counsel for South State arguing that Arawak's bid was defective and must be disqualified because 1.) Arawak inadvertently did not attach the form of contract to its bid bond; and 2) Arawak's President, John Barret, signed the Form of Bid document as President but did not indicate that he was the President of Arawak(a true and correct copy of the November 11, 2016, protest letter is attached hereto as Exhibit "A"); and

WHEREAS, on or about November 18, 2016, counsel for Arawak responded to the protest letter, arguing that the allegations of South State amounted to minor, nonmaterial clerical errors in its bid, which must be waived (a true and correct copy of the November 18, 2016 correspondence from Arawak's counsel is attached hereto as Exhibit "B"); and

WHEREAS, on November 18, 2016, counsel for South State responded to Arawak's letter of the same day, again arguing that Arawak's bid must be disqualified and the contract should be awarded to South State (a true and correct copy of the November 18, 2016 correspondence from counsel for South State is attached hereto as Exhibit "C"); and

WHEREAS, the Township Solicitor's office reviewed the issues raised by South State concerning the validity of Arawak's bid; and

WHEREAS, thereafter, in an abundance of caution, the Township retained special construction counsel, Elyse Crawford of Parker McCay, PA, to review the bids and provide a legal opinion as to the validity of Arawak's bid and the import of the issues raised by South State, Inc.; and

WHEREAS, N.J.S.A. 40A:11-1 et seq., requires that a publically advertised contract must be awarded to the "lowest responsible bidder." <u>Meadowbrook Carting Co.,</u> <u>Inc. v. Borough of Island Heights</u>, 138 N.J. 307, 313 (1994). The overriding purpose of the Local Public Contracts Law is to "secure for the public the benefits of unfettered competition." <u>See Meadowbrook, supra</u>, 138 N.J. at 313 (citing <u>Terminal Construction Corp.</u> <u>v. Atlantic County Sewerage Authority</u>, 67 N.J. 403, 410(1974)); and WHEREAS, while strict compliance with public-bidding guidelines is required, competitive bidding provisions should not be construed in such a way as to thwart the primary purpose of achieving economy. <u>Tec Electric, Inc. v. Franklin Lakes Board of Education</u>, 284 N.J. Super. 480, 484 (Law Div. 1995). As such, material conditions contained in bidding specifications may not be waived, while immaterial deficiencies may be waived. <u>See Meadowbrook</u> at 314; and

WHEREAS, Courts must apply two criteria in determining whether a bidder's noncompliance with the terms of the advertised bid solicitations constitutes a material, non-waivable defect: 1.) whether [the effect] of the waiver of the bidding error would [be to] deprive the public entity of its assurance that the contract will be entered into, performed and guaranteed by the bidder according to its specified requirements; and 2.) whether the noncompliance is of such a nature that its waiver would adversely affect the competitive bidding process by placing the bidder who erred in a position of advantage over other bidders or by otherwise undermining the necessary common standard of competition. <u>Meadowbrook</u>, supra, 138 N.J. at. 315 (1994).

WHEREAS, Arawak's failure to include the contract with its bid submission cannot be seen in any way to have provided it a competitive advantage of any kind in that it is indisputable that the successful bidder would be bound by the contract included in the bid specifications, or deprives the Township of its assurance that the contract will be entered into, performed and guaranteed by Arawak; and

WHEREAS, further, Arawak's failure to identify Mr. Barret as the President <u>of Arawak</u> on the bid form also does not constitute a material defect under the standard highlighted above; and

WHEREAS, "where the irregularity is not substantial, it may well be the duty as well as the right of the municipality to waive it." <u>Township of River Vale v. R.J. Longo</u> <u>Constr. Co.</u>, 127 N.J. Super. 207, 222 (Law Div. 1974); and **WHEREAS**, the issues raised by South State are minor clerical errors, which are waivable under Public Bidding Laws; and

WHEREAS, the aforesaid bids were thereafter reviewed by the Chief Financial Officer; and

WHEREAS, the Chief Financial Officer of the Township of Upper has certified the availability of funds attached hereto as "Exhibit A" in a sufficient amount to award a contract in the aggregate amount of \$1,557,600.00; and

WHEREAS, the Township intends to take formal action awarding the bid to Arawak as hereinafter provided;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.

2. The Township hereby accepts the bid submitted by Arawak Paving Company, Inc., for the 2016 Paving Project in the amount of \$1,557,600.00.

3. The Mayor and Township Clerk are further authorized to execute a Contract with Arawak Paving Company, Inc., in the amount authorized in this Resolution.

- 11. Draft 2017 Residents Information packet. The Superintendent of Public Works, Paul Dietrich reviewed the draft information packet with Committee. He stated that there are no major changes in the information for 2017. A proposed program to pick up for leaves and grass clippings by cart was discussed. Mr. Dietrich explained that DPW is still reviewing the pros and cons of the proposed program. Mr. Dietrich next discussed Commercial trash collection; A recommendation was made to repeat the language under the Rules and Regulations pertaining to the requirements for commercial pick up for anyone that generates more than 96 gallons of trash. A recommendation was also made to offer Commercial establishments the option to purchase up to three 96 gallon containers or a 2- cubic yard container in addition to the one 96-gallon container that the Township provides instead of a 3- cubic yard container which is much heavier than the 2-yard container. The Municipal Attorney stated that an Ordinance amendment would be required in order to allow for the change in container size. He recommended that the matter be tabled to make the recommended language changes and for further review and discussions internally. The Clerk was directed to place the matter on the next agenda.
- 12. Change Order for the Reconstruction of Bayview Drive Boat Ramp. Paul Dietrich reported that a change order is needed to adjust the quantities for payment with the final as-built measurements of the work completed. Motion by John Coggins, second by Curtis Corson, to approve the Change Order. During roll call vote all four Committee members present voted in the affirmative. A resolution for formal action will be placed in the next agenda.
