<u>APPROVAL OF MINUTES</u> - December 19, 2016 Regular Meeting and Closed Session Minutes

Motion by Edward Barr, second by Curtis Corson, to approve the December 19, 2016 Regular Meeting and Closed Session Minutes as submitted. During roll call vote all five Committeemen voted in the affirmative.

#### **REPORT OF GOVERNING BODY MEMBERS**

**John Coggins, Committeeman**, requested that a budget workshop meeting be scheduled for January 23, 2017 at 6:30 pm. He requested the heads of the following departments to attend the meeting: Public Works, EMS, Municipal Court, Beach Patrol, OEM, Township Engineer, and the Township Administrator. He directed Barbara Spiegel to send a letter to those department heads requesting their attendance.

**Hobie Young, Committeeman**, thanked the Department of Public Works for plowing the roads during the past weekend's storm. He next reported that the Seventh Day Adventist School will be moving forward with their Open Space application for the property adjacent to Amanda's Field.

**Edward Barr, Committeeman**, also commended the Public Works Department for their excellent snow removal efforts.

**Curtis Corson, Committeeman**, reported that the Township will be holding two free rabies clinics on January 21<sup>st</sup> and February 18<sup>th</sup> at Shore Veterinarians from 1:00 pm to 3:00 pm.

Dog licenses will be available for purchase during the clinics. He next also commended Public Works for their excellent work as usual.

**Richard Palombo, Mayor**, made a motion to appoint John Coggins as the Committee liaison to the Economic Development Commission. The motion was seconded by Edward Barr with all five Committeemen voting in the affirmative. The Municipal Attorney stated that an Ordinance is required in order to establish an Economic Development Advisory Commission. Mayor Palombo next reported that he recently attended a meeting with the Historical Society regarding the use of the former Town Hall building as a Museum. The Historical Society will be applying for grants to cover the costs of the project, however, before any plans are finalized he would like to hire an Environmental Investigator in order to make sure there are no environmental issues with the property. Motion by Richard Palombo, second by Curtis Corson, to hire an Environmental Investigator to inspect the old town hall building. During roll call vote all five Committeemen voted in the affirmative.

#### **OTHER REPORTS**

**Daniel Young, Municipal Attorney**, reported that upon the Tax Assessor's discovery of an error by Vital Communications, in which the effective age of homes was not recorded correctly in the program which calculated the property values, the Cape May County Board of Taxation authorized her to perform a compliance plan. All of Vital's errors have now been corrected and a letter will be mailed within the next 30 days to all affected property owners explaining the corrections and any changes in assessment. He next reported that there are contract negotiation and personnel matters for closed session.

# CAPE MAY COUNTY RESOLUTION

#### **RESOLUTION NO. 31-2017**

RE: AFFIRMING THE TOWNSHIP OF UPPER'S CIVIL RIGHTS POLICY WITH RESPECT TO ALL OFFICIALS, APPOINTEES, EMPLOYEES, PROSPECTIVE EMPLOYEES, VOLUNTEERS, INDEPENDENT CONTRACTORS, AND MEMBERS OF THE PUBLIC THAT COME INTO CONTACT WITH MUNICIPAL EMPLOYEES, OFFICIALS AND VOLUNTEERS

WHEREAS, it is the policy of the Township of Upper to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

**WHEREAS,** the governing body of the of the Township of Upper has determined that certain procedures need to be established to accomplish this policy; and

**NOW, THEREFORE BE IT RESOLVED** to affirm and adopt the Township of Upper's civil rights policy as follows:

**Section 1:** No official, employee, appointee or volunteer of the Township of Upper by whatever title known, or any entity that is in any way a part of the Township of Upper shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Township of Upper's business or using the facilities or property of the Township of Upper.

**Section 2:** The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Township of Upper to provide services that otherwise could be performed by the Township of Upper.

**Section 3:** Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.

**Section 4:** The Township Committee shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

**Section 5:** No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

**Section 6:** The Personnel Officer shall establish written procedures that require all officials, employees, appointees and volunteers of the Township of Upper as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

**Section 7:** The Personnel Officer shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.

**Section 8:** At least annually, the Municipal Clerk shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Township of Upper. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Township of Upper's web site.

**Section 9:** This resolution shall take effect immediately.

**Section 10:** A copy of this resolution shall be published in the official newspaper of the Township of Upper in order for the public to be made aware of this policy and the Township of Upper's commitment to the implementation and enforcement of this policy.

The Board shall also include, at the discretion of the Township Committee, an alternate volunteer member who is a resident of the Township of Upper. Said alternate may attend and participate in the discussion of any matter but shall only vote in the event one of the five regular members of the Board is absent. Neither the volunteer members nor their immediate family members shall be a participant in or formally or informally associated with a current Upper Township sports and recreation program. Immediate family member refers to a spouse or significant other, child or stepchild. It does not refer to more remote relatives or relations; provided, however, if a more remote relative is associated with a current Upper Township sports and recreation program, the Board

member must abstain from, and not participate in, any discussion or action specifically involving that Upper Township sports and recreation program. Prior participation or involvement in Upper Township programs or sports shall be permitted so long as there is no current involvement. The Township Committee shall appoint the members of the Board annually and shall have the power to remove Board members in its discretion. Upon any vacancy, the Township Committee may fill the position.

3. The Township Committee expressly reserves the right to supplement this Resolution at any time it deems it appropriate to change the membership of the Sports and Recreation Advisory Board or change the policies, programs and personnel with respect to any recreational activity of the Township.

**SECTION 2**: **SEVERABILITY**: If any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance, but shall be confined in its effects to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

**SECTION 3**: **REPEALER**: All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.

**SECTION 4: EFFECTIVE DATE:** This Ordinance shall take effect immediately upon final adoption and publication as required by law.
