RESOLUTION NO. 144-2017

RE: ADOPTING ADDITIONAL RULES AND REGULATIONS FOR OPERATION OF JITNEYS IN THE TOWNSHIP OF UPPER

WHEREAS, pursuant to N.J.S.A. 48:16-23, et seq., the Township of Upper is authorized to regulate autobuses, commonly known as Jitneys; and

WHEREAS, the Township of Upper adopted Ordinance 007-2017 entitled "AN ORDINANCE AMENDING REVISED GENERAL ORDINANCE CHAPTER IV OF THE CODE OF UPPER TOWNSHIP TO ADD SECTION 4-3 ENTITLED JITNEYS" (Jitney Ordinance) on April 10, 2017; and

WHEREAS, the Jitney Ordinance allows for the adoption of additional rules to establish the approved routes, stops, time of permitted service and fares to be charged to passengers; and

WHEREAS, the Township Committee has determined that the location of stops should reflect the quieter and less commercial neighborhood of Strathmere and Whale Beach; and

WHEREAS, the Township Committee has further determined that the following additional rules and regulations shall apply to jitney operation in the Township:

- The approved jitney route in Strathmere and Whale Beach is limited to a closed loop to and from Sea Isle City along South Commonwealth Avenue and West Willard Road.
- 2. The jitney shall stop to pick up or drop off passengers only at the following locations:
 - Deauville Inn 201 West Willard Road, Strathmere pick-up and drop off location, driveway is used as turnaround location.
 - LaFontana Corner of Commonwealth Avenue and Willard Road
 - Mildred's Corner of Prescott Road and Commonwealth Avenue
 - 1495 South Commonwealth Avenue (Hawthorne Avenue)
 - 2075 South Commonwealth Avenue (Hayes Avenue)
 - 2613 South Commonwealth Avenue (Taylor Avenue)

- 3. It shall be unlawful and a violation of Upper Township Code Section 4-3 for any jitney to travel on any Township road other than an approved route or to make any stop to pick up or drop off passengers at any location other than those approved herein.
- 4. The jitneys are authorized to operate on approved routes only between the hours of 12 noon and 4:00 a.m.
- 5. There shall be charged a cash fare of two dollars (\$2.00) per ride per person between the hours of 12 noon and 11:00 p.m., and a cash fare of four dollars (\$4.00) per ride per person between the hours of 11:00 p.m. and 4:00 a.m. Only one (1) fare can be charged for each seat in the vehicle. Notwithstanding the foregoing, a third party or private entity may financially subsidize jitney service provided such service is in accordance with Township ordinances and rules and regulations.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper in the County of Cape May and State of New Jersey, as follows:

1. The allegations to the preamble are incorporated herein by this reference.

2. The jitney routes, stops, times of service, and fares are established as aforementioned and as set forth on Exhibit A attached hereto as additional rules and regulations in accordance with Upper Township Code Section 4-3.9.

3. The proper officials be and are hereby authorized to do all things necessary to carry out the intent of this Resolution.

ADDITIONAL RULES AND REGULATIONS FOR THE OPERATION OF JITNEYS IN THE TOWNSHIP OF UPPER PURSUANT TO UPPER TOWNSHIP CODE SECTION 4-3.9

- 1. The approved jitney route in Strathmere and Whale Beach is limited to a closed loop to and from Sea Isle City along South Commonwealth Avenue and West Willard Road.
- 2. The jitney shall stop to pick up or drop off passengers only at the following locations:
 - a. Deaville Inn -- 201 West Willard Road, Strathmere pick up and drop off location; driveway is used as turnaround location.
 - b. LaFontana -- Corner of Commonwealth Avenue and Willard Road
 - c. Mildred's Corner of Prescott Road and Commonwealth Avenue
 - d. 1495 South Commonwealth Avenue (Hawthorne Avenue)
 - e. 2075 South Commonwealth Avenue (Hayes Avenue)
 - f. 2613 South Commonwealth Avenue (Taylor Avenue)
- 3. It shall be unlawful and a violation of Upper Township Code Section 4-3 for any jitney to travel on any Township road other than the approved route or to make any stop to pick up or drop off passengers at any location other than an approved stop under these rules.
- 4. Jitneys are authorized to operate between the hours of 12 noon and 4:00 a.m. Jitneys are prohibited from providing service to the Township after 4:00 a.m.
- 5. On an authorized jitney route there shall be charged a cash fare of Two Dollars (\$2.00) per ride per person between the hours of 12 noon and 11:00 p.m. and a cash fare of Four Dollars (\$4.00) per ride per person between the hours of 11:00 p.m. and 4:00 a.m. Only one (1) fare can be charged for each seat in the vehicle. Notwithstanding the foregoing, a third party or private entity may financially subsidize jitney service provided such service is in accordance with Township ordinances and rules and regulations.
- 3. Accepting the conveyance of real property known as Block 450, Lot 3 on the municipal tax map of the Township of Upper, County of Cape May and State of New Jersey by gift.

2. SERVICES TO BE PROVIDED; CONTRACT. The Shared Services Agreement authorized in paragraph 1 hereof shall cover those services, which shall be enumerated in said Agreement.

3. AUTHORIZATION TO MUNICIPAL OFFICIALS. The appropriate Township officers and officials are hereby authorized to take any action necessary or advisable to carry out the intent and purpose of this Resolution. Specifically, the Mayor and Township Clerk are hereby authorized and directed to execute such Shared Services Agreement on behalf of the Township of Upper pursuant to the authority conferred by this Resolution. The Township Clerk is further authorized and directed to seal said Agreement with the official seal of the Township of Upper.

4. COMPLIANCE WITH STATUTORY REQUIREMENTS. The Shared Services Agreement between the County of Cape May and the Township of Upper shall meet and satisfy the requirements of N.J.S.A. 40A:65-1, et seq., as same may be amended and supplemented.

5. CONTRACT TERM. The term of this Agreement is for the period as stipulated in the Shared Service Agreement from the date of full execution of the Shared

Services Agreement. 6. SEVERABILITY. PUBLIC COMMENT

Tom Henry, 2058 Route 9, urged the Township to join up with the proposed Countywide 911 system. He stated that he recently had a medical emergency, and because of confusion on the part of the 911 dispatcher, the EMTs did not arrive until approximately 50 minutes after 911 was called. Mr. Henry stated that once the EMTs arrived he received first class treatment, however minutes are precious during these situations. It was stated that part of the issue was due to the use of a cell phone which pings the location to the nearest tower instead of the actual physical location. The Township Administrator was directed to look into the issue.

Virginia Malar, Marmora, inquired into the plans for the bike path on Harbor Road. The Municipal Engineer stated that the path is still in the conceptual stages. Future meetings will be held during which the public will be given the opportunity to give input for the project.

Ed Dodge, Bayview Ave, stated that there is a lot of construction happening in Strathmere and requested the Township adopt Ordinances, similar to Ocean City's, which would regulate demolition and construction during the summer months. It was stated that stakeholders in

Strathmere should be contacted for their input. It was also questioned as to the feasibility to enforce such regulations. The Municipal Engineer was directed to send a letter to the Strathmere Improvement Association requesting their feedback on the request for regulations to require notice for the installation of pilings, restrict demolition during the summer months, and regulate the hours of construction.
