<u>APPROVAL OF MINUTES</u> - June 12, 2017 Regular Meeting and

Closed Session Minutes

Motion by Edward Barr, second by John Coggins, to approve the June 12, 2017 Regular Meeting and Closed Session Minutes as submitted. During roll call vote all five Committeemen voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

John Coggins, Committeeman, wished everyone a happy Independence Day and encouraged all to attend the Township events planned for the day.

Hobie Young, Committeeman, gave a brief update on the plans for the 4th of July event at Amanda's Field. He next reported that he has received a few complaints from the residents regarding the site triangle at the intersection of Route 50 and Marshall Road in Tuckahoe. Since the State changed the traffic pattern of the intersection of Route 50 and Mt. Pleasant Road vehicles are now using Marshall Road to access Route 50 and residents are reporting a lot of near accidents. There was a motion by Hobie Young, second by Edward Barr, to direct the Engineer to request the State and County inspect the site triangle at the intersection. During roll call vote all five Committeemen voted in the affirmative. He next reported on a potentially dangerous situation of vehicles turning left onto Route 50 from the Oasis Market parking lot, and requested that a sign be placed prohibiting left turns from the parking lot. It was stated that any signs would need to be voluntarily placed by the owners of the property. The Engineer was directed to talk with the property owners about the issue.

Edward Barr, Committeeman, made a motion, seconded by John Coggins, to promote Daniel Schuler to Senior Mechanic. During roll call vote all five Committeemen voted in the affirmative. He next made a motion, seconded by John Coggins, to transfer Matthew Taylor from the position of Laborer to Mechanic's Helper. During roll call vote all five Committeemen voted in the affirmative. Resolutions for formal action will be placed on the next agenda.

Curtis Corson, Committeemen, inquired into the plans for the Strathmere Parade and offered to provide the transportation. Mayor Palombo thanked Committeeman Corson for his generous offer, but stated that plans have already been made to use the OEM vehicle.

Richard Palombo, Mayor, reported that he recently met with the NJDOT and the legislative representative to discuss several matters related to traffic issues along Route 9, Route 50, and access to the Garden State Parkway. He stated that he was able to obtain a commitment that funds will be budgeted to perform traffic surveys of the area.

OTHER REPORTS

Scott Morgan, Township Administrator, gave a brief report on several Public Works projects that have been completed, including the installation of the overhead doors at the Public Works building and repair to a hole at the Taylor Avenue Boat Ramp.

Daniel Young, Municipal Attorney, reported that there are personnel, litigation, and contract negotiation items for closed session, however, the contract negotiation item for Shared Services with Dennis Township has been tabled for more information.

Paul Dietrich, Municipal Engineer, gave a brief update on the Atlantic-Cape Coastal Coalition Multi-Jurisdictional program for Public Information. The program will work with community stakeholders to disseminate outreach materials for increased flood risk awareness. Participation in this program will give the Township increased CRS credits. Final copies of the program will be distributed to the Committee. He next reported that there are still funds remaining from the Sandy Hazard Mitigation Grant. The Strathmere Fire Company has requested assistance to purchase an emergency generator, and he and Scott Morgan have been able to amend the application to use the excess Sandy grant funds for that purpose. He next reported on the cost analysis of materials and labor for the installation of speed humps. The labor costs are the same regardless of the materials used. Using asphalt as material would cost \$1,000. The rubberized material would cost \$4,000. Motion by John Coggins, second by Hobie Young, to proceed with the installation of an asphalt speed hump on Sunset Drive between California Road and the Amanda's Field entrance. During roll call vote all five Committeemen voted in the affirmative. Lastly, he reported that the NJDOT representative is working with the Township on the bikeway planning grant, and submitted a proposed Harbor Road/Route 9 Bikeway Steering Committee for the project. There was a motion by Edward Barr, second by Curtis Corson, to appoint Committeeman Coggins as the Township Committee Representative to the Bikeway Steering Committee. During roll call vote all five Committeemen voted in the affirmative. Committeeman Corson requested that a representative from Emergency Services be included on the committee as well.

Barbara Spiegel, Chief Financial Officer, requested approval to attend a three day Finance Conference in Atlantic City in order to obtain required education credits. Motion by John Coggins, second by Hobie Young, to approve the request. During roll call vote all five

Committeemen voted in the affirmative. She next requested approval for the Deputy Tax Assessor to attend a two day conference in Cape May. Motion by John Coggins, second by Hobie Young, to approve the request. During roll call vote all five Committeemen voted in the affirmative.

8. Authorizing the execution of a contract renewing membership in the Atlantic County Municipal Joint Insurance Fund.

TOWNSHIP OF UPPER CAPE MAY COUNTY RESOLUTION

RESOLUTION NO. 178-2017

RE: AUTHORIZING THE EXECUTION OF A CONTRACT RENEWING MEMBERSHIP IN THE ATLANTIC COUNTY MUNICIPAL JOINT INSURANCE FUND

WHEREAS, the Township of Upper (hereinafter the "MUNICIPALITY") is a member of the Atlantic County Municipal Joint Insurance Fund (hereinafter the "FUND"); and

WHEREAS, the MUNICIPALITY'S membership terminates as of January 1, 2018 unless earlier renewed by a Contract between the MUNICIPALITY and the FUND; and

WHEREAS, N.J.S.A. 40A:11-5 (1) (m) provides that a Contract which exceeds the bid threshold may be negotiated and awarded by the governing body without public advertising for bids and bidding therefor, if the subject matter is for the purchase of insurance coverage and consultant services, provided that the award is in accordance with the requirements for extraordinary unspecifiable services; and

WHEREAS, N.J.S.A. 40A:11-6.1(b) provides that the MUNICIPALITY shall make a documented effort to secure competitive quotations; however, a Contract may be awarded upon a determination, in writing, that the solicitation of competitive quotations is impracticable; and

WHEREAS, in accordance with N.J.A.C. 5:34-2.3, a designated official of the MUNICIPALITY, has filed a certificate with the governing body describing in detail, as set forth below in this Resolution, why this Contract meets the provisions of the statutes and the regulations and why the solicitation of competitive quotations is impracticable; and

WHEREAS, it has been determined that the purchase of insurance coverage and insurance consultant services by the MUNICIPALITY requires a unique knowledge and understanding of the municipal exposures and risks associated with the operation of a municipal entity, and many insurance professionals are not qualified to assess these risks and exposures based upon their inherent complexity; and

WHEREAS, insurance coverage for municipal entities can vary greatly in the type, limits, and exceptions to coverage, and therefore particularized expertise in determining and obtaining the appropriate coverage is required to protect the MUNICIPALITY; and

WHEREAS, it is the goal of the MUNICIPALITY to obtain a single integrated program to provide all types of insurance coverage with a plan to limit the MUNICIPALITIES exposure; and

WHEREAS, the FUND has provided comprehensive insurance coverage to member municipalities since 1987; and

WHEREAS, since 1987, the Fund has continually refined all of the types of coverage that it provides to its members so that it offers comprehensive insurance coverage and limits to all members that is unique and cannot be purchased from a single entity in the commercial insurance market; and

WHEREAS, the FUND has also developed and made available to its members Safety, Risk Management and Litigation Management programs that address the specific exposures and risks associated with municipal entities; and

WHEREAS, the FUND provides the MUNICIPALITY with Fund Administration, Claims Review, Claims Processing, Claims Administration, Actuarial and Legal services; and

WHEREAS, the FUND is one of the most financially sound Municipal Joint Insurance Funds in New Jersey, and the FUND operates with strong fiscal controls, member oversight, and meets all of the requirements promulgated by the New Jersey Department of Community Affairs and the Department of Banking and Insurance; and

WHEREAS, as an existing member of the FUND, the MUNICIPALITY would be renewing its membership in an organization with experienced and dedicated FUND Professionals who provide specialized services to the members; and

WHEREAS, the membership of the FUND includes many neighboring municipalities that uniquely have similar exposures to the MUNICIPALITY, and with whom the MUNICIPALITY has existing inter-local arrangements; and

WHEREAS, all of the aforementioned factors categorize the award of this Contract as an "extraordinary, unspecifiable service" that cannot be duplicated, accounted for, accurately detailed, or described in a manner that truly depicts the value of the MUNICIPALITY'S membership in the FUND; and

WHEREAS, for all of the aforementioned reasons, it is impracticable for the MUNICIPALITY to seek competitive quotations for a Contract to provide the procurement of insurance coverage and consultant services; and

WHEREAS, the FUND has been organized pursuant to N.J.S.A. 40A:10-36 et seq., and as such is an agency of the municipalities that created it; and

WHEREAS, N.J.S.A. 40A:11-5(2) also provides that a Contract which exceeds the bid threshold may be negotiated and awarded by the governing body without public advertising for bids and bidding therefor, if the Contract is entered into with a municipality or any board, body, officer, agency or authority thereof; and

WHEREAS, the FUND meets the definition of an agency as set forth in N.J.S.A. 40A:11-5(2); and

WHEREAS, for all of the aforementioned reasons, the MUNICIPALITY desires to enter into a Contract to renew its membership with the FUND for a period of three (3) years, for insurance coverage and consultant services, as an exception to the public bidding requirements of the Local Public Contracts Law.

NOW THEREFORE, be it resolved by the governing body of the MUNICIPALITY as follows:

- 1. The MUNICIPALITY agrees to renew its membership in the FUND and to be subject to the Bylaws, Rules and Regulations, coverages, and operating procedures thereof as presently existing or as modified from time to time by lawful act of the FUND.
- 2. The Mayor and Clerk of the MUNICIPALITY shall be and hereby are authorized to execute the "Contract to Renew Membership" annexed hereto and made a part hereof and to deliver same to the FUND evidencing the MUNICIPALITY'S renewal of its membership.
- 3. In accordance with N.J.A.C. 5:34-2.3, the certificate of a designated official of the MUNICIPALITY, which details why the solicitation of competitive quotations is impracticable, is attached hereto and made a part of this Resolution.
- 4. The Clerk of the MUNICIPALITY is authorized and directed to place a notice of the adoption of this Resolution and the award of this Contract in the official newspaper of the MUNICIPALITY.

WHEREAS, the Township of Upper maintains our recreation fields and to do so desires to enter into a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, the Qualified Purchasing Agent has determined and certified in writing that the value of acquisitions with TruGreen, LP for the year 2017 will exceed \$17,500 and a contract pursuant to N.J.S.A. 19:44A-20.5 is required; and

WHEREAS, TruGreen, LP has completed and submitted a Business Entity Disclosure Certification which certifies that TruGreen, LP has not made any reportable contributions to a political or candidate committee in the Township in the previous one year, and that the contract will prohibit TruGreen, LP from making any reportable contributions through the term of the contract; and

AN ORDINANCE VACATING A PORTION OF WALTON AVENUE, WITHIN THE TOWNSHIP OF UPPER, COUNTY OF CAPE MAY AND STATE OF NEW JERSEY
