APPROVAL OF MINUTES - November 20, 2017 Regular Meeting and Closed Session "A" and "B" Minutes

Motion by Edward Barr, second by Hobie Young, to approve the November 20, 2017 Regular Meeting and Closed Session "A" and "B" Minutes as submitted. During roll call vote all five Committeemen present voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Hobie Young, Committeeman, gave a brief update on the projects at Caldwell Park and Amanda's Field. He next reported that a post event meeting for the Pumpkin Run Car Show was recently held. The meeting went well with mostly only minor issues to address. However, one key issue necessary for future events will be obtaining a good public announcement system. He requested that the Committee consider the purchase of a PA system.

Edward Barr, Committeeman, thanked Committeeman Coggins for his idea to place signs in the neighborhoods notifying residents when leaf pickup will commence. He stated that he has received positive feedback from the public regarding the notices.

Richard Palombo, Mayor, reported that he recently received a letter from the Cape May County Planning Department regarding the new countywide Water Quality Management Program. He stated that they are requesting the Township's involvement in the project, and have asked the Township to nominate a qualified individual to act as the Township's liaison. Mayor Palombo then made a motion to designate Paul Dietrich to act as the Township's

Municipal Liaison for the County's Water Quality Management Program. The motion was seconded by Committeeman Barr. During roll call vote all five Committeemen voted in the affirmative.

OTHER REPORTS

Scott Morgan, Township Administrator, gave a brief update on the progress of the leaf collection throughout the Township. He next reported that the Chief of the Seaville Fire Company has requested the Township's assistance in applying for a grant for self-contained breathing apparatus equipment for all of the Township's Fire Companies. He will be attending a meeting with the Fire Companies regarding the grant later in the week and will report the details from that meeting to the Committee. He next reported that the term for a temporary employee in the Department of Public Works, Jamie Heilman, will be coming to an end soon. Mr. Morgan stated that Mr. Heilman has been an excellent employee, and recommended that he be hired on a full-time basis. After a brief discussion, the Committee requested that this matter be listed on the next agenda for further discussion. Last, Mr. Morgan reported that the Township's new phone system has been completely installed.

Daniel Young, Municipal Attorney, reported that there are a few personnel, potential litigation, and contract negotiation items for closed session.

RESOLUTION NO. 331-2017

PROCLAIMING NOVEMBER AS ADVERSE CHILDHOOD EXPERIENCES AWARENESS MONTH IN CAPE MAY COUNTY

WHEREAS, the Cape Regional Wellness Alliance believes that children are our county's most precious resource, and

WHEREAS, according to the 2017 NJ Kids Count report, for the 7th year in a row, Cape May County is ranked the highest of all 21 New Jersey counties in unemployment, child out-of-home placements, lowest in overall child wellness, and has the highest rate of reported and substantiated investigations of child abuse and/or neglect; and

WHEREAS, Adverse Childhood Experiences (ACEs) is a term to describe all types of abuse (emotional, physical, sexual), neglect (emotional, physical), and other traumatic experiences (mother treated violently, substance abuse, mental illness, separation/divorce, incarcerated household member) that occur to individuals under the age of 18; and

WHEREAS, Cape Regional Health System through a grant from the Robert Wood Johnson Foundation/NJ Health Initiatives (NJHI) has formed the Cape Regional Wellness Alliance for the goal of Building a Culture of Health in Cape May County; and

WHEREAS, by March 2019 the Cape Regional Wellness Alliance will have developed and implemented strategies to reduce the impact of Adverse Childhood Experiences (ACEs) in the communities of Lower Township, Middle Township, Wildwood and Woodbine; and

WHEREAS, 2016 Health rankings indicate Cape May County ranked 15th for overall health outcomes, Type II diabetes and obesity, infant and child mortality, as well as adult premature mortality outcomes above state rate with the second highest suicide rate and fourth highest drug abuse deaths; and

WHEREAS, neglected and traumatized children face challenges that no child deserves, and damage caused by ACEs often results in young people who develop long lasting harmful behaviors that affect themselves, their families, and their communities; and

WHEREAS, the Cape Regional Wellness Alliance expects that this pilot program of reducing the occurrences of ACEs in these four Cape May County communities will be used as a model for county-wide implementation; and

WHEREAS, the Cape Regional Wellness Alliance will work in partnership with the Cape Regional Health Needs Coalition and other invested community members to achieve this goal; and

WHEREAS, the Cape Regional Wellness Alliance will establish baseline data on the prevalence of ACEs in these four Cape May County communities; and

WHEREAS, the Cape Regional Wellness Alliance will develop and implement a community education program about ACEs and its impact on the Culture of Health in these four Cape May County communities; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, that November be proclaimed Adverse Childhood Prevention Month in Cape May County; and

AND BE IT FURTHER RESOLVED that the Township of Upper pledges to promote safe and healthy environments for all children encouraging parents, caregivers, educators, and neighbors to provide children with love, security, emotional support, and a strong connection to their extended families and communities,

AND BE IT FURTHER RESOLVED that all citizens, service agencies, organizations, medical facilities, schools, businesses, and government entities increase their participation efforts, to strengthen families and communities for the prevention of Adverse Childhood Experiences,

NOW, THEREFORE BE IT RESOLVED that the Cape May County Freeholders, School Boards and Town Councils be committed to raising awareness about ACEs and the need to emphasize the importance of providing protective factors and building resiliency among the population.

RE: AUTHORIZING A HOST COMMUNITY BENEFIT AGREEMENT BETWEEN THE TOWNSHIP OF UPPER AND THE CAPE MAY COUNTY MUNICIPAL UTILITIES AUTHORITY

WHEREAS, the Cape May County Municipal Utilities Authority ("CMCMUA") operates a solid waste complex located on the border of the Borough of Woodbine and the Township of Upper, in Cape May County, New Jersey; and

WHEREAS, said solid waste complex has been sited as said location pursuant to the Solid Waste Management Plan of Cape May County adopted by the Board of Chosen Freeholders and approved by the New Jersey Department of Environmental Protection; and

WHEREAS, the Township of Upper is a host community for CMCMUA's solid waste complex; and

WHEREAS, New Jersey Statutes (N.J.S.A. 13:1E-28) provide that a municipality within which an approved solid waste facility is located shall be entitled to an annual economic benefit in consideration of the amount of solid waste accepted for transfer or disposal at said facility; and

WHEREAS, Upper Township and CMCMUA have previously entered into various Agreements dated January 21, 1993, May 16, 1997, November 14, 2005, and December 20, 2011 regarding an annual host community benefit to be paid by the CMCMUA to Upper Township, for serving as a host community for CMCMUA's solid waste complex; and

WHEREAS, said Agreement provided, among other provisions, that a minimum annual economic benefit be paid to the Township of Upper, based upon a minimum annual volume of solid waste of 143,885 tons, regardless of the actual amount of solid waste received for disposal at the landfill; and

WHEREAS, the minimum tonnage provision of the Agreement will guarantee an annual revenue to the Township of \$400,000; and

WHEREAS, the term of the Agreement shall be effective on January 1, 2018 and shall terminate on December 31, 2023; and

WHEREAS, the Agreement specifically allows the term of the Agreement to be extended up to five (5) additional years; and

WHEREAS, the Township of Upper is desirous of assuring a revenue stream derived from a Host Community Benefit of at least \$400,000 per year for budgetary purposes; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

- 1. The allegations of the preamble are incorporated herein by this reference.
- The Mayor and Township Clerk are hereby authorized to sign an Amendment to the Host Community Benefit Agreement extending the term of said Agreement for five years, expiring on December 31, 2023.
- 3. All Township officials and officers are hereby authorized and empowered to take all action deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.
