WHEREAS, the Annual Budget for the Upper Township Fire District No. 1 (the "Fire District") for the fiscal year beginning January 1, 2016 and ending December 31, 2016 has been presented before the Board of Commissioners of the Fire District at its open public meeting of October 22, 2015; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.) *[Include the following as appropriate: [includes a proposed public referendum in the amount of \$0.00 in excess of the allowable amount to be raised by taxation][includes a proposed public referendum in the amount of \$0.00 as an appropriation from restricted fund balance to be used as budget revenue]]*; and



NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on October 22, 2015 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2016 and ending December 31, 2016 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

The 2016 proposed budget reflects a 2% increase (or \$1,581) in revenue to be raised through taxation from that of 2015. Since the 2% represents the districts increase in insurance alone, the district is also utilizing the Cap Bank from 2013-2015 increasing the amount to be raised through taxation another \$1,296 for a total increase of \$2,877. No line items vary +/-10.

2. Complete a brief statement on the impact the proposed Annual Budget will have on the Amount to be Raised by Taxation to support the district budget and on the Restricted and Unrestricted Fund Balance(s). Explain increases or decreases in the tax rate and utilization of fund balances. The amount to be raised from taxation is budgeted to increase 2% and utilize a small cap bank. This is not expected to have a significant effect on the local tax rate. The proposed budget should have no effect on the unrestricted and restricted fund balances.

The property tax levy cap has been complied with.
