Also present were Municipal Clerk Barbara Young, Municipal Engineer Paul Dietrich, Chief Financial Officer Barbara Spiegel, and Township Administrator Scott Morgan.

Committeeman Coggins began by stating that he would like to use tonight's budget meeting to review a variance report comparing variances between the 2017 expenditures and the 2018 proposed appropriations. He stated that he would like to utilize a second budget workshop for the Committee to have a more in-depth review into each line item and to review the capital requests, and a third budget workshop to discuss increases and decreases in the budget lines and approval of capital requests. There was then a general discussion of the line items in each department's proposed budget.

Motion by Hobie Young, second by Edward Barr to close the Budget Workshop Meeting. During roll call vote all five Committeemen voted in the affirmative. There was then a fiveminute break before the regular meeting began.

<u>APPROVAL OF MINUTES</u> - January 5, 2018 Reorganization Minutes and January 8, 2018 Regular Meeting and Closed Session Minutes

Motion by Edward Barr, second by John Coggins, to approve the January 5, 2018 Reorganization Minutes as submitted. During roll call vote all five Committeemen voted in the affirmative.

Motion by Edward Barr, second by John Coggins to approve the January 8, 2018 Regular Meeting and Closed Session Minutes as submitted. During roll call vote three Committeemen voted in the affirmative. Committeeman Corson and Committeeman Young abstained.

REPORT OF GOVERNING BODY MEMBERS

Hobie Young, Committeeman, reported that the Farmer's Market will be held at Amanda's Field this year. Preliminary plans have the market being held on Sundays from 10:00 am to 3:00 pm. He stated that these plans reinforce the need for a digital sign out in front of Amanda's Field to advertise these events. He next reported that there are still several paving areas in Amanda's Field that need to be fixed. Mr. Dietrich stated that he would reach out to the contractor. Next, he reported that the Historical Society has requested a status report on the proposed museum project at the old town hall. It was stated that the building is currently under asbestos abatement. From there, a discussion on plans for the building can move forward. Lastly, he inquired into the status of the corrective work on the speed bumps on Old Tuckahoe Road. He stated that the speed bumps were built narrow and high and the cars are bottoming out. There was a brief discussion regarding the rate of speed cars should be going over the bumps. It was then stated that the matter will be looked into.

Curtis Corson, Committeeman, reported that a free rabies clinic was held on January 20 at Shore Vets. 142 dogs, and 37 cats were vaccinated. A second free rabies clinic will be held on February 17, 2018 from 1:00 pm to 3:00 pm.

Edward Barr, Committeeman, requested a public service announcement be created to educate the public regarding snow plowing procedures during a storm.

OTHER REPORTS

Scott Morgan, Township Administrator, reported that the Ocean City High School After Prom Committee will be partnering with the Ocean City/Upper Township Municipal Alliance, the Cape May County Prosecutors Office, the Upper Township Education Association, and Cape Assist to host a "Hidden in Plain Site" interactive workshop at the Upper Township Primary School on February 1, 2018 at 6:00 pm. The workshop will provide useful information for parents by presenting a look at the latest substance abuse trends and hiding spots. He next reported that the DEP has recently approved of the Township's temporary debris management areas program.

Daniel Young, Municipal Attorney, reported that there are a number of items for closed session.

Paul Dietrich, Township Engineer, reported that the County has started work on the Ocean Drive revetment project in Strathmere. Construction will continue through March, will then pause for the spring and summer months, and then begin again next winter. He next requested authorization to bid for the re-roofing of the Municipal Building project. Motion by John Coggins, second by Edward Barr, to authorize the Engineer to prepare and advertise bid specifications for the re-roofing of the Municipal Building project. During roll call vote all five Committeemen voted in the affirmative. A resolution for formal action will be placed on the next agenda. Committeeman Coggins inquired into a potential public safety issue in which several streetlights in the Tuckahoe area have poles, but the lights have not been installed yet. Mr. Dietrich stated that Atlantic City Electric subcontracted with the NJDOT during the Route 50 bridge replacement project to install street lights in that area. He stated that the some of the fixtures were on backorder at the time of installation and now, at the present time, AC Electric itself is backlogged on their projects. Mr. Dietrich stated that he would reach out to the project manager to find out a timeline for completion. Mr. Coggins next reported on a safety concern at the crosswalk on Route 50 near the bank with regard to the rate of speed of vehicles in that area. He stated that the residents have requested signage to warn motorists of the upcoming crosswalk and to install flashing speed sign to help curb the rate of speed in that area. Mr. Dietrich stated that he would reach out to the DOT with the request.

Barbara Spiegel, Chief Financial Officer, reported on a request from the Tax Assessor to attend a week-long course on Assessment Administration in February at a cost of \$540.00. Motion by John Coggins, second by Curtis Corson to approve the request. During roll call vote all five Committeemen voted in the affirmative.

RE: IN SUPPORT OF A FULL INTERCHANGE AT EXIT 20 ON THE GARDEN STATE PARKWAY, UPPER TOWNSHIP, CAPE MAY COUNTY, NEW JERSEY

WHEREAS, Exit 20 of the Garden State Parkway, located near the very busy intersection of US Route 9 and US Route 50 in the Seaville section of Upper Township, Cape May County, is severely limited in that it provides only an exit for Northbound traffic and an entrance for Southbound traffic only; and

WHEREAS, for over thirty years, the Township Committee of the Township of Upper has repeatedly requested a full interchange at Exit 20 in order to provide an entrance and exit for both Northbound and Southbound traffic; and

WHEREAS, in a recent survey conducted by the Upper Township Economic Development Advisory Commission, Ninety percent of participants responded in favor of Exit 20 being developed into a full interchange with access from Garden State Parkway South and access to Garden State Parkway North; and

WHEREAS, in the South Jersey Transportation Planning Organization's 2016 Regional Transportation Plan, a full interchange at Exit 20 was identified as a critical need for the safety of the region in the event of an evacuation; and

WHEREAS, with an increase in population of over 591% in Cape May County during the summer months, and with tourism being the economic lifeblood of this region, an efficient and sensible traffic management system is essential for the safety, convenience, and enjoyment of our residents and visitors; and

WHEREAS, the continual delay and avoidance by State Officials to addressing and correcting this issue, which is vital to the safety and economic well-being of Upper Township and Cape May County, is unacceptable; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.

2. The Township Committee does hereby once again formally endorse and urge the construction of a full interchange at Exit 20 on the Garden State Parkway in Upper Township, Cape May County, New Jersey without further delay and without further public inconvenience.

3. Opposing regulations proposed by the New Jersey Department of Agriculture to regulate beekeeping.

RESOLUTION NO. 041-2018

RE: OPPOSING REGULATIONS PROPOSED BY THE NEW JERSEY DEPARTMENT OF AGRICULTURE TO REGULATE BEEKEEPING

WHEREAS, the New Jersey Department of Agriculture has published new

beekeeping regulations in the New Jersey Register which are now open to public comment;

and

WHEREAS, these new regulations include a section on Apiary Standards which states that bee colony density will be regulated as follows: on a residential lot of less than one-quarter acre where agriculture has not otherwise been determined as permitted new (not already in existence) hives are not permitted; on a residential lot of less than one-quarter acre where hives are in existence as of July 31, 2015, the hobbyist beekeeper may seek a waiver; on a residential lot of one-quarter acre to less than five acres, a person wishing to keep bees and a hobbyist may seek a waiver to keep two hives per lot; and

WHEREAS, these regulations also include a section of Location of Hives, which requires that all hives must be located at least ten (10) feet from any property line and at least twenty-five (25) feet from any roadside, sidewalk, or path and eighty-five (85) feet from any public place including playgrounds, sports fields, schools or churches, unless permission is granted for educational or research purposes, as well as establishing a Flyway Barrier at least six (6) feet in height consisting of a solid wall, fence, or dense vegetation parallel to the property line and extending ten (10) feet beyond the colony in each direction; and

WHEREAS, these new regulations ignore key best management practices for beekeeping and would be difficult for the vast majority of New Jersey municipalities to enforce; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, that the Township Committee wishes to go on record with the New Jersey Department of Agriculture that the Township is opposed to the new beekeeping regulations which would have a detrimental effect on beekeeping in the Township as well as throughout New Jersey, and urges the New Jersey State League of Municipalities to work towards creating legislation with straightforward regulations based on fact, science, and best management practices which will protect both beekeepers and non-beekeepers within the State of New Jersey; and **BE IT FURTHER RESOLVED**, that copies of this resolution be sent to Senator Jeff Van Drew, Assemblyman Bob Andrzejczak, Assemblyman R. Bruce Land, the New Jersey State League of Municipalities, the New Jersey Beekeepers Association, and all Cape May County municipalities urging them to oppose the adoption of the new beekeeping regulations as proposed by the New Jersey Department of Agriculture.

SECTION 5: In the event the Township Committee receives no offers for the property pursuant to the advertisement of same in accordance with N.J.S.A. 40A:12-13(b), the adjacent property owner requesting such sale, DeMarchi, shall purchase same in accordance with this Ordinance and shall appear before the Township Clerk and execute the agreement to purchase same pursuant to this Ordinance. SECTION 4: Clayton has paid the following sum to the Township Clerk prior to the adoption of this Ordinance: \$500.00 pursuant to Ordinance No. 002-2015. This payment will be used by the Township and defray Township expenses involved in Authorizing the Sale and terms thereof; Engineer's review; Attorney's review; legal advertising, certified mail notices, title review expenses, closing costs and other expenses. If the parcel is not sold, this amount will be retained by the Township as **LIQUIDATED DAMAGES** and will be used to pay for the review of the title report and other documents. If the highest bidder at the auction sale is <u>not</u> the original applicant, the highest bidder will be required to pay, in addition to the purchase price and other expenses, an additional sum of \$500.00, representing pre-sale amounts paid by the original applicant requesting the sale and the original applicant (who is not the highest bidder) will then be entitled to a refund of all sums paid (\$500.00) except for the non-refundable application fee (\$50.00).

SECTION 5: The aforesaid parcel of real property shall be offered for sale at an auction to be conducted by the Township Clerk at a date and time to be set by the Township Clerk after the appropriate notice of sale has been sent to contiguous owners of the subject real property. Said notice shall be sent certified and regular mail to the owners of contiguous property at the address set forth on the tax assessor's records. Said notice shall be sent no greater than 30 days prior to the date of sale and no less than 14 days prior to the date of sale. At any time, the Township Clerk may adjourn said sale and renotice in accordance with the provisions of this Ordinance and N.J.S.A. 40A:12-13.

SECTION 6: The Township Committee expressly reserves the right to reject any and all bids in the exercise of its sole judgment and discretion. The Township Committee is authorized to confirm the sale by resolution and complete the transaction pursuant to this Ordinance and N.J.S.A. 40A:12-13.

SECTION 7: In the event the highest bid at such auction exceeds the minimum bid established herein and the Township Committee rejects same in the exercise of

its sole judgment and discretion, then, in such event, all deposits made by the original applicant or the highest bidder, as the case may be, shall be refunded except for the \$50.00 application fee which shall be non-refundable.

SECTION 8: All payments required to be made pursuant to said sale to the Township Clerk must be made by personal check, cash or certified check, or any combination of the foregoing. All payments required to be made hereunder to a title company or abstract company conducting the closing shall be made in collected funds, that is, by cash, certified check, cashier's check or wire transfer.

SECTION 9: A sum equal to ten percent (10%) of the highest bid for said parcel or parcels shall be paid to the Township of Upper by the highest bidder or bidders at the time of the sale. The remaining balance of ninety percent (90%) of the highest bid for the parcel or parcels shall be paid to the Township of Upper, and must be received by the Township Clerk, not later than thirty (30) days after the date of the sale. In addition to the deposit of ten percent (10%), the highest bidder or bidders shall also be required to pay or tender at the time of sale the following:

IF THE BIDDER IS THE ORIGINAL APPLICANT:

- (B) The sum of 500.00, payable to the Township of Upper, representing payment to the Township for expenses of \$500.00 to defray Township expenses, which amounts were required of the original applicant.
- (C) (i) The sum of \$100.00 for the preparation of the Deed.
 - (ii) The sum of \$70.00 for recording the Deed.

AT THE TIME OF CLOSING the successful bidder shall be required to pay the following sums:

- (D) Any additional sum required for title search or title insurance.
- (E) The cost of any survey ordered by the successful bidder. Successful bidder shall place such order directly with the surveyor or with the title company conducting closing, but the survey must be prepared in time to permit the closing to take place as scheduled.
- (F) Title company settlement fees covering services to both the Seller and the Buyer.
- (G) Any additional fees or costs chargeable by the title company or otherwise necessary to complete the transaction on behalf of the purchaser.

SECTION 10: The closing of title shall take place as designated by the Township as follows:

- (A) Township Hall, Petersburg, New Jersey; or
- (B) Office of the Township Solicitor; or
- (C) At the office of a title insurance company or title abstract company located within Cape May County.

SECTION 11: If the bidder fails to close or fails to comply with the provisions hereof, such bidder shall be in default and all amounts paid to the Township by or on behalf of the bidder shall be retained by the Township as LIQUIDATED DAMAGES AND NOT AS A PENALTY.

SECTION 12: The Deed from the Township of Upper shall be what is commonly known as a Quitclaim Deed.

SECTION 13: The title to be delivered by the Township shall be free and clear of all taxes up to and including the date when the Deed is delivered and closing takes place. Purchaser shall be responsible for all taxes thereafter. Unless otherwise specified herein, the purchaser shall be liable for payment of all assessments, of any nature, against said land.

SECTION 14: The title to be delivered by the Township shall be under and subject to all easements and rights of way, recorded and unrecorded, whether for utilities or for others, and shall also be subject to all conditions, reservations and restrictions of record, if any. If the title report discloses an unmarketable condition of title, except as specified herein, the remedy of the bidder shall be limited to the return of payments made to the Township of Upper on account of the purchase price and closing costs only. Any and all other amounts paid to the Township shall be non-refundable. This sale is under and subject to any riparian claim which may affect said property. If any such claim exists, it shall be the sole responsibility of the purchaser to meet and satisfy all requirements of the State of New Jersey with respect to said riparian claim and the payment of any compensation to the State of New Jersey on account thereof. The Township of Upper makes no warranties or representations, expressed or implied, as to whether or not the property being offered for sale contains wetlands anywhere on the property. The Township makes no warranties or representations as to any matter of an environmental nature, or otherwise, which may prevent or limit building or construction.

SECTION 15: All references to Lots and Blocks described herein are to the Lots and Blocks as shown on the Current Official Tax Map of the Township of Upper.

SECTION 16: The successful bidder shall be required, at the time of the sale, to execute a document acknowledging that the sale is governed by the provisions of this Ordinance as well as N.J.S.A. 40A:12-13.

SECTION 17: The provisions of this Ordinance pertaining to this sale shall survive the closing of title and shall not merge into the Deed.

SECTION 18: It is a requirement of this sale that the purchaser of the subject property be a contiguous property owner. Said purchaser shall be required to take immediate action to cause a consolidation of the property being purchased with all of the bidder's existing adjacent property so as to constitute a single parcel of ground which shall not be further subdivided into more than one lot.
