In preparation of the 2018 Municipal Budget a budget workshop meeting was called to order this evening at 6:00 PM.

Mayor Palombo read the Open Public meeting notice into the record.

Committeeman Coggins began the meeting by stating that the plan for tonight is to go through each Department's budget narrative along with any capital requests. He also requested that the Department Heads come up during the discussion of their department in order to answer any questions the Committee may have. There was then an in-depth discussion of the line items in the budget proposals contained in the Clerk's Office, IT, Engineer, Green Team, and the Municipal Court.

Motion by Edward Barr, second by Hobie Young, to close the Budget Workshop Meeting. During roll call vote all five Committeemen voted in the affirmative. There was then a brief break before the regular meeting began.

APPROVAL OF MINUTES - January 22, 2018 Regular Meeting and Closed Session "A" and "B" Minutes

Motion by Edward Barr, second by John Coggins, to approve the January 22, 2018 Regular Meeting and Closed Session "A" and "B" Minutes as submitted. During roll call vote all five Committeemen voted in the affirmative.

# **REPORT OF GOVERNING BODY MEMBERS**

**John Coggins, Committeeman,** reported that at the next Budget Workshop meeting he would like to finish the discussion regarding Public Works, EMS, OEM, and Beach Patrol budgets.

**Hobie Young, Committeeman,** reported that the Easter Egg Hunt will be held on March 24<sup>th</sup>, rain date March 25<sup>th</sup>, at Amanda's Field. He stated that we are looking for volunteers to fill eggs. He next inquired into the status of the asbestos remediation at the Old Township Hall. The Township Engineer stated that the contract has been executed, and the contractor and consultant are coordinating a pre-construction meeting to go over permitting requirements. Committeeman Young next gave a brief update on the progress at the Amanda's Field baseball field. He thanked the Baseball Association for their help with the funding and construction of the press box.

**Edward Barr, Committeeman**, reported that Senator Van Drew has introduced Senate Bill S246 which directs the NJ Turnpike Authority to hold at least two of their regular meetings during the year in Ocean, Atlantic, and Cape May Counties; and at least one meeting a year in Salem, Gloucester, and Camden Counties. Committeeman Barr made a motion to draft a letter in support of this bill and to make a recommendation to fill the vacancy on the NJ Turnpike Authority with a resident of Cape May County. The motion was seconded by Curtis Corson. During roll call vote all five Committeeman voted in the affirmative.

Curtis Corson, Committeeman, reported that a free rabies clinic will be held on Saturday February 17, 2018 from 1:00 to 3:00 pm at Shore Veterinarians. He next reported that the Rescue Squad is selling roses for Valentine's Day. Lastly, he inquired into requesting the legislature to eliminate requirements for Municipalities to advertise public and legal notices in newspapers, and allow for electronic posting of such notices in order to save money. The Municipal Attorney stated that there have been several legislative attempts to do this, however, there is significant push back from the newspapers.

**Richard Palombo, Mayor**, reported that the Coast Guard has requested a donation of \$350 in order to provide lunches for active duty military during the Cape May County Coast Guard Community Festival. Mayor Palombo made a motion, seconded by John Coggins, to provide the donation as requested. During roll call vote all five Committee members voted in the affirmative. He next requested that preliminary plans and discussions be started for the bulkhead project on Bayview Drive in Strathmere. The Township Engineer stated that he will have information available for discussion at the first meeting in March.

#### **OTHER REPORTS**

**Scott Morgan, Township Administrator**, reported that a recent inspection of the communication towers at Town Hall and Estell Manor revealed that the tower in Estell Manor had been struck by lightning. The repairs have been made, and both towers are in

proper working order. Lastly, he reported that the Township's new website, <a href="https://www.uppertownship.com">www.uppertownship.com</a>, is up and running.

**Barbara Young, Municipal Clerk**, reported that Township Offices will be closed on Monday February 19<sup>th</sup> for President's Day and trash and recycling collection scheduled for collection on Monday will be collected on Tuesday February 20<sup>th</sup>.

**Daniel Young, Municipal Attorney**, reported that there are a number of contract negotiation, litigation and personnel items for closed session.

Paul Dietrich, Township Engineer, reported that he has spoken with AC Electric regarding the street lights on Route 50. They anticipate delivery and installation of the lights by the end of the month. Once the lights in Tuckahoe have been installed, they will remove the secondary lights. He next reported that the paving contractor has corrected and repaired the patch in the paving at Amanda's Field. Next, he reported that the suspects charged with trespassing on the Township's pit have been prosecuted and fined. He stated that hopefully word will get out that trespassing on the pits is unsafe and violators will be prosecuted. He next reported that the School Board has requested his engineering services to prepare a site plan for a storage building at the Elementary School. Motion by Hobie Yong, second by Edward Barr to approve the request. During roll call vote all five Committee members voted in the affirmative. Lastly, he gave an update on the plans to replace and repair the beach crossovers in Strathmere. Mr. Morgan stated that upon Committeeman Young's request, they checked with the DEP and were informed that some of the areas will need permits before work is commenced. Mayor Palombo requested that the plans be developed to provide more handicapped access. Committeeman Barr requested that signs designating the handicapped access be placed on Commonwealth Ave.

**Barbara Spiegel, Chief Financial Officer**, reported that the next Budget Workshop meeting will be held on February 26<sup>th</sup> at 6:00 pm.

- 1. SHARED SERVICES AGREEMENT. Pursuant to the provisions of the Uniformed Shared Services Act, (N.J.S.A. 40A:65-1, et seq.), the Township is hereby authorized and empowered to enter into a Shared Services Agreement with FD#2 for the purchase of gasoline/diesel fuel from the Township.
- 2. SERVICES TO BE PROVIDED; CONTRACT. The Shared Services Agreement authorized in paragraph 1 hereof shall cover those services, which are enumerated in said Agreement, a copy of which is attached hereto as Exhibit "A".

- 3. AUTHORIZATION TO MUNICIPAL OFFICIALS. The appropriate Township officers and officials are hereby authorized to take any action necessary or advisable to carry out the intent and purpose of this Resolution. Specifically, the Mayor and Township Clerk are hereby authorized and directed to execute such Shared Services Agreement on behalf of the Township of Upper pursuant to the authority conferred by this Resolution. The Township Clerk is further authorized and directed to seal said Agreement with the official seal of the Township of Upper.
- 4. COMPLIANCE WITH STATUTORY REQUIREMENTS. The Shared Services Agreement between FD#2 and the Township shall meet and satisfy the requirements of N.J.S.A. 40A:65-1, et seq., as same may be amended and supplemented.
- 5. CONTRACT TERM. The term of this Agreement shall be for a period of five years from the date of execution. Either party may cancel the agreement upon thirty (30) days written notice.
- 6. SEVERABILITY. If any section, subsection, paragraph, sentence or other part of this Resolution is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Resolution, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Resolution directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Resolution shall remain in full force and effect.
- 7. REPEALER. All Resolutions or parts of Resolutions inconsistent herewith are hereby repealed to the extent of such inconsistency only.
- 8. EFFECTIVE DATE: This Resolution shall take effect immediately upon final adoption and publication in the manner provided by law.

#### **RESOLUTION NO. 68-2018**

# AUTHORIZING THE EXECUTION OF A SETTLEMENT AGREEMENT WITH FAIR SHARE HOUSING CENTER

WHEREAS, pursuant to <u>In re N.J.A.C. 5:96 and 5:97</u>, 221 <u>N.J.</u> 1 (2015)(<u>Mount Laurel IV</u>), on July 2, 2015, the Township of Upper (hereinafter "Upper" or the "Township") filed an action with the Superior Court of New Jersey, entitled <u>In the Matter of the Application of the Township of Upper, County of Cape May</u>, Docket No. CPM-L-303-15

(the "Compliance Action") seeking, among other things, a judicial declaration that its Housing Element and Fair Share Plan (hereinafter "Fair Share Plan"), to be amended as necessary, satisfies its "fair share" of the regional need for low and moderate income housing pursuant to the "Mount Laurel doctrine;" and

**WHEREAS**, the Township simultaneously sought, and ultimately secured, a protective order providing Upper Township immunity from all exclusionary zoning lawsuits while it pursues approval of its Fair Share Plan; and

**WHEREAS**, Fair Share Housing Center ("FSHC") is an interested party in the Township's litigation; and

**WHEREAS**, the trial judge appointed Steven Perskie, Esq. as the Special Court Master (hereinafter the "Court Master"), as is customary in <u>Mount Laurel</u> matters adjudicated in the courts; and

WHEREAS, with assistance from the Court Master, the Township and Fair Share Housing Center (hereinafter "FSHC") engaged in good faith negotiations which resulted in an amicable accord on the various substantive terms and conditions as set forth in the Settlement Agreement attached hereto as Exhibit A; and

**WHEREAS**, through this process, the Township and FSHC agreed upon the Township's affordable housing obligations and the compliance techniques necessary for Upper Township to satisfy its "fair share" of the regional need for low- and moderate-income housing; and

**WHEREAS**, the Township and FSHC also agreed to present the Settlement Agreement to the Trial Judge for approval at a duly-noticed <u>Mount Laurel</u> Fairness Hearing; and

WHEREAS, although there is a well-established policy favoring the settlement of all forms of litigation, the settlement of Mount Laurel litigation is particularly favored because (1) it avoids the expenditure of finite public resources; and (2) expedites the construction of safe, decent housing for the region's low- and moderate-income households; and

**WHEREAS**, in light of the above, the Township Council finds that it is in the best interest of Upper Township to execute the attached Settlement Agreement with FSHC and to take various other actions delineated below, which will ultimately result in approval of the Township's Fair Share Plan which, in turn, will maintain the Township's immunity from all Mount Laurel lawsuits for the ten-year period set forth in the New Jersey Fair Housing Act, N.J.S.A. 52:27D-301 to 329.

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Township Council of the Township of Upper, County of Union, State of New Jersey, as follows:

- 1. The Mayor and Township Clerk are hereby authorized and directed to execute the Settlement Agreement with FSHC in substantially the form attached hereto as Exhibit A.
- 2. The appropriate Township officials are hereby authorized to take all actions necessary to carry out and complete the terms of the Settlement Agreement.

**BE IT FURTHER RESOLVED** that this Resolution shall take effect pursuant to law.
