APPROVAL OF MINUTES - March 12, 2018 Regular Meeting and

Closed Session Minutes

Motion by John Coggins, second by Edward Barr, to approve the March 12, 2018 Regular Meeting and Closed Session Minutes as submitted. During roll call vote all four Committeemen present voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

John Coggins, Committeeman, thanked the public works department for their response to the recent storm. He also thanked the Fire Departments, and the Rescue Squad for their responses to multiple calls all night long during the storm.

Edward Barr, Committeeman, reported that due to the Good Friday holiday, trash pickup for Friday will be picked up the following Monday.

Curtis Corson, Committeeman, also thanked the Fire Departments, the Rescue Squad, and the Public Works Department for their excellent service. Next he reported on recent correspondence regarding a fatal accident at the intersection of Stagecoach Road and Church Road. He made a motion, seconded by Edward Barr, to prepare a resolution requesting the County to install a 4 way stop at the intersection of Stagecoach Road and Church Road. During roll call vote all four Committeemen present voted in the affirmative.

Richard Palombo, Mayor, reported that the Beach patrol and the Strathmere Fire Co. were recently awarded a JIF special recognition award for safety and offered his congratulations to

them. He next reported that the Easter Egg Hunt event was a great success. He thanked the Clerk, the Public Works Department, and all the volunteers for their hard work.

OTHER REPORTS

Scott Morgan, Township Administrator, reported that he was recently informed by the New Jersey State Police that the Township's FY 2016 Emergency Management Assistance grant has been approved in the amount of \$9,400.00. He reported that the FY 2017 grant has already been applied for and we should hopefully hear about those funds soon, and he will be holding a meeting this Thursday to prepare for the FY 2018 grant application. Next, he reported that because of the storms the past month, the Department of Public Works will be operating two additional trucks for brush clean up.

Barbara Young, Municipal Clerk, reported that the Township will be hosting election poll worker training classes on April 10 at 6:00 pm and April 22 at 12:00 noon. She stated that if anyone is interested in becoming a poll worker to please contact the Clerk's Office or the Cape May County Board of Elections.

Daniel Young, Municipal Attorney, reported that there are a number of items for closed session.

Paul Dietrich, Township Engineer, reported that the State recently performed an onsite inspection of the asbestos removal operations at Old Town Hall. There were a few minor deficiencies that the contractor had to correct which caused a brief delay, but the project is now progressing. It was stated that the Township has two contracts; one for the contractor that is removing the asbestos, and one for a consultant to monitor the asbestos removal as per State requirements. Because of the unexpected delay, the consultant's contract will need be extended for the additional time to monitor the project, which will cause an increase in costs of up to \$7,000. The Municipal Attorney advised that the increase does not require a change order because the original contract for the consultant provided for this contingency. Mr. Dietrich next reported that he has researched street restoration ordinances and will prepare a draft ordinance updating the Township's street restoration requirements for the Committee's review.

6. Urging the Federal Emergency Management Agency (FEMA) to extend the Increased Cost of Compliance (ICC) coverage as part of the National Flood Insurance Program (NFIP).

URGING THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) TO EXTEND THE INCREASED COST OF COMPLIANCE (ICC) COVERAGE AS PART OF THE NATIONAL FLOOD INSURANCE PROGRAM (NFIP)

WHEREAS, the ICC component of a residents NFIP's coverage is an important part of helping a resident recover from devastating flooding like Superstorm Sandy; and

WHEREAS, ICC coverage provides up to \$30,000 to assist a resident with the mitigation of their residence and this is typically insufficient to complete the work; and

WHEREAS, many residents applied for ICC with their insurance companies after Superstorm Sandy but have been unable to complete raising their residence due to delays in receiving additional funding from other State and Federal agencies; and

WHEREAS, the ICC benefit is set to expire on October 29, 2018; and

WHEREAS, FEMA should change the NFIP to allow residents additional time to raise their residence using ICC and other matching State and/or Federal funds if the resident timely applied for said matching funding; and

WHEREAS, FEMA should change the NFIP to increase the ICC from \$30,000 to \$60,000; and

NOW THEREFORE BE IT RESOLVED, that the Township Committee of the Township of Upper, County of Cape May respectfully urges the FEMA to expedite reauthorization of the NFIP to include allowing residents additional time to utilize the ICC from Superstorm Sandy and increase the ICC for future storm events; and

BE IT FURTHER RESOLVED, that a certified copy of this Resolution be forwarded to the Administrator of FEMA, the Deputy Associate Administrator for Insurance and Mitigation at FEMA, Congressman LoBiondo, Senator Menendez, and Senator Booker.

ORDINANCE NO. 004-2018

RE: AN ORDINANCE AMENDING SECTION 4-3.2 OF CHAPTER IV OF THE REVISED GENERAL ORDINANCE OF THE CODE OF UPPER TOWNSHIP WITH RESPECT TO JITNEY LICENSING REQUIREMENTS

BE IT ORDAINED by the Township Committee of the Township, in the County of Cape May, New Jersey as follows:

SECTION 1. Chapter 4 of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, is hereby amended to replace the following Section 4-3.2.e as follows:

e. It shall be unlawful for any person to drive a jitney within the Township of Upper without first having obtained a jitney license and an identification card, the latter to contain the photograph and signature of the licensee. This identification card shall be produced by the Township Clerk. This identification card shall be carried at all times and prominently displayed while driving or operating a jitney. It shall be unlawful for any jitney operator or licensee to permit anyone else to wear his or her identification card or to refuse to show the same to lawful authorities upon request. A fee of Fifteen Dollars (\$15.00) shall be charged for a replacement identification card. All applicants shall provide such information as the Township Clerk requires, including but not limited to fingerprinting and a Criminal History Record Background Check pursuant to the provisions and requirements of N.J.S.A 40:48-1.4 and N.J.A.C. 13:59-1.1 et seq. Fees and costs in any manner associated with the Criminal History Record Background Check shall be charged to the applicant and collected by the Township Clerk. Written confirmation to the Township Clerk that the applicant successfully completed a Criminal History Record Background Check within the last nine (9) months from another New Jersey municipality will be acceptable if the other municipality conducts the check pursuant to N.J.S.A. 40:48-1.4 and N.J.A.C. 13:59-1.1 et seq. The Review Committee shall determine whether or not the applicant is disqualified based upon the results of the Criminal History Record Background Check.

If the applicant is a corporation, limited liability company or partnership, then the following individuals shall be subject to a Criminal History Record Background Check:

- In the event that the applicant is a corporation, the background investigation shall include all officers of the corporation and, if practical, the shareholders.
- In the event that the applicant is a limited liability company, such investigation shall include all officers of the limited liability company and, if practical, the members.
- 3. In the event that the applicant is a partnership, such investigation shall be required of each partner, whether full or limited partners.

SECTION 2: EFFECTIVE DATE: This ordinance shall take effect immediately upon adoption and publication as required by law.

SECTION 3: REPEALER: All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.

SECTION 4: SEVERABILITY: If any section, paragraph, subdivision, subsection, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

SECTION 5: CODIFICATION: This Ordinance shall be codified as indicated in Chapter 4 of the Upper Township Code.

TRANSFER TOWNSHIP OWNED LAND TO HABITAT FOR HUMANITY

WHEREAS, Township Committee of the Township of Upper, County of Cape May of the State of New Jersey desires to sell land to the Habitat for Humanity, Cape May County, Inc., a Non-Profit Corporation of the State of New Jersey 08210 ("Habitat for Humanity"); and

WHEREAS, New Jersey Statute 40A:12-21 allows a municipality to sell land to certain organizations for a nominal fee, such as to (j) Any duly incorporated nonprofit organization for the purpose of building or rehabilitating residential property for resale; and (1) Any duly incorporated nonprofit housing corporation for the purpose of constructing housing for low or moderate income persons or family or handicapped persons; and

WHEREAS, the Township of Upper owns a parcel of land which can be developed as a single family residential home; and

WHEREAS, the Township of Upper has an obligation to provide low and moderate affordable housing; and

WHEREAS, the Habitat for Humanity is a non-profit entity which has a purpose of constructing housing for low and moderate income persons; and

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

SECTION 1:

- The Township Committee of the Township of Upper, shall sell to Habitat for Humanity two parcels of land identified on the Official Tax map of the Township of Upper as: 43 Redwood Avenue, Block 527, Lots 12-21 and 41 Redwood Avenue, Block 527 Lots 22-31.
- 2. The sale price shall be for \$1.00.
- 3. Each parcel shall be deed restricted so as to provide that a single family residential dwelling shall be built upon it within 24 months or the land shall revert to the Township of Upper.
- 4. Each property shall be deed restricted so that the single family residential dwelling shall be COAH compliant and so that the Township of Upper will be credited for having COAH compliant units in the Township of Upper. The Township understands that the efforts to make this COAH compliant may fail due to the State's affirmative marketing requirements.
- 5. The Township shall review and approve the exterior design of each house to ensure that each house shall not be substantially alike in exterior design and appearance.
- 6. The Township makes no promise or warranty as to the physical condition or status of the title to these properties as they are transferred completely AS IS.
 If there is a defect in the title or condition of either parcel, the sole right of

Habitat for Humanity is to cancel the transaction before transfer of the deed with no further liability between the parties.

7. The Mayor, Clerk, and any and all other Township Officials, are hereby authorized to sign any documents necessary to effectuate this transaction, including any contract, deed, deed restriction or easement.

SECTION 2: All other ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency.

SECTION 3: Should any section, paragraph, sentence, clause or phrase of this ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this ordinance shall not be affected thereby and shall remain in full force and effect, and to this end the provisions of this ordinance are hereby declared to be severable.
