DISCUSSION

Mr. Dietrich informed the board that in April we will begin looking at the Waste Water Plan Amendment. The County's Planner is currently working on this and hopes to have a draft to the board for the April meeting. Mr. Dietrich will email a copy of the 2012 Waste Water Plan to the board members for their review prior to the meeting.

The Township Committee has approved a settlement agreement with Fair Share Housing to settle the Townships fair share housing litigation. The planning board must prepare a fair share plan and housing element of the master plan. He reviewed the total obligation of the township. The board discussed rentals, infrastructure and locations for new housing. Mr. Dietrich explained there are a lot of families and people that live in the township that meet and qualify for the affordable levels. Mr. Dietrich also discussed builders remedy suits and the town centers. He suggests forming a subcommittee to work with himself, Solicitor Barnes and the planner.
