WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7 through 7.5 the Township of Upper has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Township of Upper meets the necessary conditions to participate in the program for the 2018 budget year.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, County of Cape May, that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officers' certification, the governing body has found the budget has met the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:

- a. Payment of interest and debt redemption charges
- b. Deferred charges and statutory expenditures
- c. Cash deficit of preceding year
- d. Reserve for uncollected taxes
- e. Other reserves and non-disbursement items
- f. Any inclusions of amount required for school purposes

2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met. (Complies with "CAP" law.)

- c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality.

5. The budget and associated amendments have been introduced, publicly advertised, and adopted in accordance with the relevant provision of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A 40A:4-5 shall not prevent such certification.

ORDINANCES

12. Public Hearing and Final Adoption of Ordinance No. 006-2018 RE: An Ordinance amending Revised General Ordinance Chapter X (Building and Housing) and Chapter XI (Property Maintenance) of the Code of Upper Township.

Prior to the Public Hearing the Municipal Attorney explained that the purpose of the Ordinance is to bring our current Ordinance further into compliance with State laws, incorporate regulations for pilings and clarify various sections of our current Ordinance.

The Municipal Attorney then recommended the following amendments to Ordinance No. 006-2018:

10-4 Removal of Dangerous Structures

section d. - The Municipal Attorney explained this section requires that removal or demolition of a structure must be authorized by resolution of the Township Committee and in the event the Construction Code Official deems a property unsafe and violations are not corrected by the homeowner and the Township deems it necessary to take action to correct the violation, this Ordinance will allow the tax collector to attach a lien on the property to recover the costs.

10-6 Pile Installation Operations and Demolition of Structures – this section is added.

11-1.16 Occupancy Limits – Attorney Young recommended that this section be deleted. He explained that a recommendation regarding occupancy limits came to his attention after the Ordinance was introduced. He advised that after careful review it is recommended that this section be deleted as it doesn't fit our town. He explained that we have a lot of older smaller homes throughout the Township that would be in violation of the Ordinance and in talking with Code enforcement and Zoning there haven't been any complaints or problems with overcrowding or occupancy limits.

11-1.9 Grass and Weeds – Attorney Young recommended that debris be added to this section, that it be revised to include the premises and exterior be maintained free of brush, dying trees, filth, garbage, trash and debris and that the site reference 11-1.7 be corrected, from 11-1.7 to 11-1.6.

11-1.14- Motor Vehicles, Trailers, Boats, RV's and ATV's. The changes recommended to this section will delete the section on vehicle painting and clarify language pertaining to unregistered or inoperable motor vehicles to allow up to three (3) unregistered vehicles if those vehicles are part of an ongoing restoration process, provided the activity is in compliance with Chapter 20. In addition section e. of the Ordinance shall be revised to clarify language pertaining to storage of recreational vehicles.

Lastly Attorney Young advised that if the Township Committee decides to make the changes he has recommended that this will be a substantial change. He explained that when you have significant changes such as this, procedurally the Ordinance has to be republished. You have two choices table the Ordinance and go through the whole process again, re-introduce it in its amended form with a first reading, introduction, final adoption and public hearing or amend the Ordinance and publish the amendments at least two days prior to holding a second hearing on the Ordinance.

The following speakers spoke during the public portion of the Ordinance:

Mark Schuler – Palermo – requested an amendment to section 11-1.14- regarding Motor Vehicles, to allow certain uses. He requested residents be permitted to store more than one unregistered vehicle on their property. He stated that if a person has a hobby restoring old cars they may be using the unregistered cars for parts.

John Castaldi – Tuckahoe – requested clarification in reference to paining of motor vehicles in section 11-1.14- Motor Vehicles, Trailers, Boats, RV's and ATV's. He also spoke in opposition to the language in paragraph e., regarding the storage of recreational vehicles.

Bob Rush – Steelmantown – spoke in opposition to the regulations contained in the Ordinance regarding grass cutting.

Peter Schuler – Petersburg – requested clarification to the language contained in various sections of the Ordinance.

Jon Kevin Grubb – Greenfield – questioned regulations regarding the removal of structures on nonconforming property.

Howard Corneal - Petersburg - questioned regulations pertaining to commercial property.

Luke Eisele – Petersburg – questioned the regulations contained in section 11-1.14 - Motor Vehicles, Trailers, Boats, RV's and ATV's.

Nathalie Neiss – Petersburg – requested the adoption of the Ordinance be tabled to a future meeting for further review.

Christina Schuler - Petersburg – requested clarification to the language in the Ordinance.

Motion by Edward Barr, second by Curtis Corson, to table Ordinance No. 006-2018 and reintroduce it in its amended form at a later date. During roll call vote all four Committeemen present voted in the affirmative.
