Motion by John Coggins, second by Richard Palombo, to approve the March 25, 2019 Regular Meeting and Closed Session Minutes as submitted. During roll call vote all four Committeemen present voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

John Coggins, Committeeman, reported that the clock tower at Township Hall is an hour fast.

Hobie Young, Committeeman, reported that the Easter Egg Hunt will be held on Saturday April 13th with a rain date on the 14th. The event will start at 12:00 with a petting zoo, face painting, and a visit with the Easter Bunny. He stated that volunteers are needed to help with the event. He next gave several updates on plans for Caldwell Park, and an ongoing issue with parking at the Lacrosse fields. He next reported that the car show has been scheduled for September 28th.

Curtis Corson, Committeeman, reported that the Upper Township/Ocean City Municipal Alliance Committee is partnering with the Ocean City After Prom Committee to host two community presentations to discuss underage drinking and its hazards. The presentations will be held on April 8th from 6:30 to 8:00 pm at the Upper Township Middle School Cafeteria, and on April 9th from 6:30 to 8:00 pm at the Ocean City High School Library. He next reported that Upper Township does not have a fire inspector. Right now the Township relies on the State to inspect commercial properties. He stated that if the Township has their own fire inspector, rental properties can also be inspected. After a brief discussion, it was decided to direct the Administrator to look into the issue.

Richard Palombo, Mayor, reported that the Shops at Tuckahoe Village will be holding their Second Saturday Marketplace event on Saturday April 13th from 10:00 am to 4:00 pm.

OTHER REPORTS

Scott Morgan, Township Administrator, thanked the Upper Township Business Association, various Upper Township Clubs and Organizations, and the Township Departments for their help with the Upper Township Community Guide recently published by the Sentinel Ledger. Mr. Morgan also reported that DPW expects to be done with brush and leaf collection tomorrow.

Barbara Young, Municipal Clerk, reported that the township will observe the National Day of Prayer on Thursday May 2, 2019 at 10:00 a.m. at the Upper Township Municipal Building. Next, she reported that that Township Offices will be closed on Friday April 19, 2019 in observance of Good Friday. If your trash and recycling collection day falls on Friday April 19th, your household trash and recycling will be collected on Monday, April 22nd. Last, she reported that the next Township meeting will be on April 29th.

Daniel Young, Municipal Attorney, reported that there are several items for closed session.

Paul Dietrich, Township Engineer, reported that approximately 200 seedlings were given away at the Township's annual seedling giveaway on Saturday April 6, 2019. Next, he reported that the DOT has awarded the Township a grant in the amount of \$150,000.00 for phase 2 of the roadway improvements on Commonwealth Avenue. He stated that the Township will be awarding a contract for phase one of that project tonight, and once he receives the documentation from the DOT he will be able to consolidate those two projects for funding purposes. Next, he reported that he recently met with the NJ Turnpike Authority on Friday to discuss the repair work to the parkway access road and surrounding areas in Beesley's Point.

TOWNSHIP OF UPPER CALENDAR YEAR 2019 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (<u>N.J.S.A.</u> 40A: 4-45.14)

ORDINANCE NO. <u>004-2019</u>

WHEREAS, the Local Government Cap Law, <u>N.J.S.A.</u> 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, <u>N.J.S.A.</u> 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the

3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Upper in the County of Cape May finds it advisable and necessary to increase its CY 2019 budget by up to **3.5%** over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee of the Township of Upper hereby determines that a 1.0 % increase in the budget for said year, amounting to $\frac{108,932.78}{108,932.78}$ in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Committee of the Township of Upper hereby determines that any amount authorized hereinabove that is not appropriated, as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Upper, in the County of Cape May a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2019 budget year, the final appropriations of the Township of Upper shall, in accordance with this ordinance and <u>N.J.S.A.</u> 40A: 4-45.14, be increased by **3.5 %**, amounting to \$ **\$381,264.73** and that the CY 2019 municipal budget for the Township of Upper be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

- f. Any inclusions of amount required for school purposes

2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met. (Complies with "CAP" law.)

 - b. Items of appropriation are properly set forth.
 - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality.

5. The budget and associated amendments have been introduced, publicly advertised, and

adopted in accordance with the relevant provision of the Local Budget Law, except that failure to meet the

deadlines of N.J.S.A 40A:4-5 shall not prevent such certification.

6. That all other applicable statutory requirements have been fulfilled.

WHEREAS, research shows that the prevalence of food allergies is increasing among children and adults; and

WHEREAS, eight foods cause the majority of all food allergy reactions in the U.S.: shellfish, fish,

milk, eggs, tree nuts, peanuts, soy and wheat; and

WHEREAS, there is no cure for food allergies, and symptoms of a food allergic reaction can range from mild to severe, such as anaphylaxis; and

WHEREAS, anaphylaxis is a serious allergic reaction that is rapid in onset and may cause death; and

WHEREAS, food allergies result in more than 200,000 Emergency Department visits each year. Reactions typically occur when an individual unknowingly eats a food containing an ingredient to which they are allergic; and

WHEREAS, the number of food allergy reactions requiring emergency treatment is up sharply over the past decade, with a 377 percent rise in medical procedures associated with diagnoses of anaphylactic food reactions between 2007 and 2016; and

WHEREAS, Food Allergy Research & Education (FARE) is a national, non-profit organization dedicated to improving the quality of life and health of individuals with food allergies and to provide them hope through the promise of new treatments.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.

2. Scott Morgan, Township Administrator, is hereby authorized to carry a handgun while

acting on behalf of the Township on Township business. This authorization is subject to Mr. Morgan complying with any and all required state and federal laws and regulations with respect to carrying firearms.

3. The job description of the township administrator is amended to authorize the current Township Administrator, as part of his job duties, to carry a firearm pursuant to and subject to state, federal and other governmental laws and regulations.

4. To the extent the authorizations contained in this resolution conflict with existing Township policies, those policies are hereby amended in accordance with this resolution.

5. This Resolution shall be effective as of adoption.
