**ORDINANCE NO. 010-2019**

**RE: AN ORDINANCE AMENDING REVISED GENERAL ORDINANCE CHAPTER VII OF  
THE CODE OF UPPER TOWNSHIP**

**BE IT ORDAINED** by the Township Committee, in the Township of Upper,  
County of Cape May and State of New Jersey, as follows:

**SECTION 1:** Chapter 7, Schedule I (entitled "No Parking") of the Revised  
General Ordinances of the Township of Upper, also known as the Code of Upper Township,  
shall be supplemented as hereinafter provided:

**SCHEDULE I - NO PARKING**

*Add to include the following:*

<b>Name of Street</b>	<b>Direction</b>
Commonwealth Avenue (CR 619)*	West shoulder beginning at the boundary line of Upper Township and Sea Isle City to Putnam Avenue

*\* No Parking designation was approved and authorized by the Cape May County Board of  
Chosen Freeholders pursuant to Resolution No. 459-19 and may be enforced by this Township  
ordinance.*

**SECTION 2: REPEALER:** All Ordinances or parts of Ordinances which are in  
conflict or inconsistent herewith are hereby repealed to the extent of such inconsistency or  
conflict only.

**SECTION 3: SEVERABILITY:** If any section, paragraph, subdivision,  
subsection, clause or provision of this Ordinance shall be adjudged invalid, such  
adjudication shall apply only to the section, paragraph, subdivision, subsection, clause or  
provision declared invalid and the remainder of this Ordinance shall remain in full force  
and effect and shall be enforceable.

**SECTION 4: EFFECTIVE DATE:** This Ordinance shall take effect upon final  
adoption and publication as required by law.

**SECTION 5: CODIFICATION:** This Ordinance shall be codified in the Upper  
Township Code at the section referred to above.
