APPROVAL OF MINUTES – August 12, 2019 Regular and Closed Session Minutes

Motion by Hobie Young, second by Edward Barr, to approve the August 12, 2019 Regular Meeting and Closed Session Minutes as submitted. During roll call vote four Committeemen voted in the affirmative. Mayor Palombo abstained.

REPORT OF GOVERNING BODY MEMBERS

Hobie Young, Committeeman, inquired into the status of repairing the Beesley's Point boat ramp. Mr. Dietrich stated that he is working on a preparing a proposal for quotes for surveyors. Committeeman Young stated that repair of the ramp should be completed simultaneously with the proposed bike path project. He next reported that there are certain businesses in the Township that are not maintaining their properties and are in violation of their site plan approvals. It was stated that the zoning officer is empowered to enforce property maintenance and there are steps to enforce compliance pursuant to the Township Ordinance. Next, he reported that plans are underway for the Pumpkin Classic Car Show and Fall Fest. Volunteers, vendors, and participants are still needed. Lastly, he reported that there was another incident of vandalism at Caldwell Park.

Edward Barr, Committeeman, wished everyone an enjoyable and safe Labor Day weekend.

Richard Palombo, Mayor, reported that the Planning Board has been discussing proposed zoning changes for Strathmere and he would like to hold a public information meeting on Saturday September 7th at 9:00 a.m. at the Strathmere Fire Hall to go over the proposed revisions with Strathmere residents. He requested that the appropriate notices be sent out.

OTHER REPORTS

Scott Morgan, Township Administrator, reported that the Township website has a new page called Senior Living. The informational page has links and resources for seniors including educational and recreational activities available in the Township and County. He next reported that the National Weather Service has approved the Township's application for designation as a StormReady Community. StormReady helps communities develop plans to handle all types of extreme weather, and encourages communities to take a new, proactive approach to improving local hazardous weather operations by providing emergency managers with clear-cut guidelines on how to improve their hazardous weather operations. Lastly, Mr. Morgan recognized Lt. Henry, Commander of the NJSP Woodbine Barracks. Mayor Palombo and the Committee thanked Lt. Henry for the excellent work the State Police are doing in the Township.

Daniel Young, Municipal Attorney, reported that there are a few items for closed session.

Paul Dietrich, Township Engineer, reported that he has received the DEP permit for the reconstruction of the Putnam Avenue Bulkhead. He will finalize the construction plans and prepare the bid specifications to go out to bid soon. He next reported that Orstead will be giving a public information presentation regarding offshore wind energy on Tuesday August 27th from 6:00 to 8:00 pm at the Senior Center Library in Ocean City.

RESOLUTION NO. 253-2019

RE: IN SUPPORT OF A FULL INTERCHANGE AT EXIT 20 OF THE GARDEN STATE PARKWAY, UPPER TOWNSHIP, CAPE MAY COUNTY, NEW JERSEY

WHEREAS, Exit 20 of the Garden State Parkway, located near the very busy intersection

of Route 9 and Route 50 in the Seaville section of Upper Township, Cape May County, is severely limited in that it provides only an exit for Northbound traffic and an entrance for Southbound traffic; and

WHEREAS, with an increase in population of over 591% in Cape May County during the summer months, and with tourism being the economic lifeblood of this region, an efficient and sensible traffic management system is essential for the safety, convenience, and enjoyment of our residents and visitors; and

WHEREAS, in a 2018 survey conducted by the Upper Township Economic Development Advisory Commission, Ninety percent of participants responded in favor of Exit 20 being developed into a full interchange with access from Garden State Parkway South and access to Garden State Parkway North; and

WHEREAS, in the South Jersey Transportation Planning Organization's 2016 Regional Transportation Plan, a full interchange at Exit 20 was identified as a critical need for the safety of the region in the event of an evacuation; and

WHEREAS, as far back as 2004, the South Jersey Transportation Planning
Organization's U.S. 9/Garden State Parkway Corridor Study estimated that a full interchange would
divert approximately 128 Northbound and 122 Southbound vehicles from Route 9 to the Garden State
Parkway during the summer Saturday peak hour in 2025, and concluded that the benefits of upgrading
this interchange to accommodate all directions of access would improve regional access and mobility,
reduce regional vehicle miles traveled (VMT), reduce vehicle hours traveled (VHT), reduce emergency
vehicle response time, improve level of service and reduce congestion on the Roosevelt Boulevard
mainline and intersections between Route 9 and the Garden State Parkway, and improve level of service
and reduce congestion on the Route 9 mainline and intersections between Route 50 and Roosevelt
Boulevard; and

WHEREAS, in study after study, the data has clearly established that a full interchange at Exit 20 is vital to the safety and economic well-being of Upper Township and Cape May County; and NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.

2. The Township Committee does hereby once again formally endorse and urge the construction of a full interchange at Exit 20 of the Garden State Parkway in Upper Township, Cape May County, New Jersey without further delay and without further public inconvenience.

WHEREAS, the Upper Township Board of Education and the Township of Upper have indicated a desire to enter into a Shared Services Agreement for maintenance, repairs and use of facilities; and

- 1. SHARED SERVICES AGREEMENT. Pursuant to the provisions of the Uniformed Shared Services Act, N.J.S.A. 40A:65-1, et seq., the Township of Upper is hereby authorized and empowered to enter into a Shared Services Agreement with the Upper Township Board of Education for maintenance, repairs and use of facilities.
- 2. SERVICES TO BE PROVIDED; CONTRACT. The Shared Services Agreement authorized in paragraph 1 hereof shall cover those services, which are enumerated in said Agreement, a copy of which is attached hereto as Exhibit "A".
- 3. AUTHORIZATION TO MUNICIPAL OFFICIALS. The appropriate Township officers and officials are hereby authorized to take any action necessary or advisable to carry out the intent and purpose of this Resolution. Specifically, the Mayor and Township Clerk are hereby authorized and directed to execute such Shared Services Agreement on behalf of the Township of Upper pursuant to the authority conferred by this Resolution. The Township Clerk is further authorized and directed to seal said Agreement with the official seal of the Township of Upper.
- 4. COMPLIANCE WITH STATUTORY REQUIREMENTS. The Shared Services Agreement between the Upper Township Board of Education and the Township of Upper shall meet and satisfy the requirements of N.J.S.A. 40A:65-1, et seq., as same may be amended and supplemented.
- 5. CONTRACT TERM. The term of this Agreement shall be for a period of six (6) years, commencing September 1, 2019 and expiring on August 31, 2025.
- 6. SEVERABILITY. If any section, subsection, paragraph, sentence or other part of this Resolution is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Resolution, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Resolution directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Resolution shall remain in full force and effect.
- 7. REPEALER. All Resolutions or parts of Resolutions inconsistent herewith are hereby repealed to the extent of such inconsistency only.

8. EFFECTIVE DATE. This Resolution shall take effect immediately upon final adoption and publication in the manner provided by law.

WHEREAS, the Township has previously determined to extend that policy to all employees working in hazardous or safety sensitive areas and also to public safety employees including the Division of EMS and Township lifeguards; and

WHEREAS, to administer such a program in accordance with the Federal rules, regulations and guidelines, it is necessary to employ the services of a firm possessing such specialized skill and training; and

WHEREAS, Atlantic Investigations, LLC has the required expertise to provide such services; and

WHEREAS, the Township Committee intends to engage the services of Atlantic Investigations, LLC as a Professional Services Contract; and

WHEREAS, Atlantic Investigations, LLC has completed and submitted a Business Entity Disclosure Certification which certifies that the contractor has not made any contributions to a political or candidate committee in the Township that would bar the award of this contract and that the contract will prohibit the contractor from making any contributions through the term of the contract; and

WHEREAS, the Chief Financial Officer has certified the availability of funds to permit said Contract to be entered into;

 - (D) The services are such that their relative work must be judged by subjective considerations that are not susceptible of valuation by competitive bidding; and

(E) The individual who will provide these services has demonstrated his competence and particular expertise in the services required.

4. This contract shall have a term of one (1) year commencing upon full execution.
