#### REPORT OF GOVERNING BODY MEMBERS

**Hobie Young, Committeeman**, thanked the many township employees and volunteers that worked during the Fall Fest. He also gave special recognition to Cape Regional for becoming a corporate sponsor for the event. He also thanked the Cape May County Prosecutors Office for their assistance and the Upper Township Business Association for their help in putting together the kid zone. Lastly, he recognized the Department of Public Works for the fall décor in front of town hall and for preparing Caldwell Park for Breast Cancer Awareness month.

**Edward Barr, Committeeman,** thanked the Department of Public Works for their quick response with the storm clean up after the recent storm.

**Curtis Corson, Committeeman,** reported that the Upper Township Rescue Squad will hold a Trunk or Treat event on October 22, 2019 (rain date October 23<sup>rd</sup>) from 6:00 p.m. to 8:00 p.m. at Amanda's Field, everyone is invited to attend and have a good time. Next, he reported that a Free Rabies Clinic

will be held on Saturday October 19, 2019 from 1:00 to 3:00 p.m. at Shore Veterinarians. Lastly, he thanked the DPW employees for the cleanup at the Route 49 and 50 intersection.

#### **OTHER REPORTS**

**Scott Morgan, Township Administrator**, reported that the township received the 2018 EMMA (Emergency Management Assistance) fiscal year funding in the amount of \$10,000 and expect to receive the 2019 funds in the amount of \$10,000 in the first quarter of 2020. Lastly, he thanked Paul Dietrich for his efforts regarding the CRS (Community Rating System) program. He explained how EMMA program ties in with the CRS program to give us the points needed to reduce our National Flood Insurance rates.

**Barbara Young, Municipal Clerk**, reported that the Upper Township Health Fair was a big success with many vendors and over 120 flu shots given. She thanked the Upper Township employees for their help and especially thanked Janet McBride, Upper Township Health and Wellness Coordinator for coordinating the health fair. She next reported that Trick or Treating in Upper Township will be held on October 31, 2019 from 5:00 to 8:00 p.m. and lastly, she reminded everyone that the General election will be held on November 5th from 6:00 a.m. to 8:00 p.m., for general questions about the election or information on polling locations feel free to contact the Municipal Clerks office.

**Daniel Young, Municipal Attorney**, reported that there are a number of items for closed session this evening.

**Paul Dietrich, Municipal Engineer**, reported that he received notice from the County that they anticipate construction on Hope Corson road to begin next week. He reminded everyone that the road will be closed to thru traffic although they will allow School buses and emergency vehicles through. Lastly, he reported that this Thursday the Upper Township Planning Board will be discussing the townships Municipal Public Access Plan.

**Barbara Ludy, Chief Financial Officer**, reported that she and the engineer held a round table discussion earlier this evening with the Upper Township Business Association to review the township's procurement process. Next, she reported that the township received a \$2,100 award for meeting our JIF safety goals. The Fund Commissioner Teri Smuz has requested that we use the safety award for the purchase of gift cards for township employees as a thank you for being safe. WHEREAS, Sheriff Nolan determined that the 287(g) program does not infringe upon

civil rights and/or liberties and has safeguards in place to protect against racial or ethnic profiling; and

WHEREAS, Sheriff Nolan entered into an agreement with ICE to extend the 287(g)

program for another 10 years; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the

Township of Upper, in the County of Cape May and State of New Jersey, that the Township of Upper

hereby supports Sheriff Robert Nolan's commitment to public safety and security in Cape May County

**WHEREAS**, the street abutting the subject property has been resurfaced less than three years; and

**WHEREAS**, the subject property is in need of public water and/or gas and the need for those utility services was not known before the road was resurfaced; and

**NOW THEREFORE BE IT RESOLVED**, by the Governing Body of Township of Upper in the County of Cape May, and the State of New Jersey as follows:

- 1. The appeal of the three year street opening moratorium shall be approved for the following property: Block 492, Lot 26.
- 2. Enhanced road restoration shall be completed in accordance with attached Exhibit "A".
- 3. An additional Performance and Maintenance Bond for the property in the amount of \$3,000 shall be submitted at time of permit for the required work beyond the Ordinance requirements of Section 13-1.7.
- 4. The Township Engineer or the Public Works Road Supervisor shall be present during all work operations and shall be notified 48 hours in advance of any work.

#### EXHIBIT A

Infrared restoration for repair of asphalt that have been opened for utility work shall be utilized after a minimum four (4) month settlement period has elapsed following initial backfill.

- (1) After completion of permanent restoration as required by the Ordinance, the permittee shall provide infrared restoration.
- (2) The area shall be swept clean of dirt, loose aggregate, or standing water.
- (3) A chalk line shall be drawn six to twelve (6"-12") inches back from the seam of the original opening to use as a guide raking.
- (4) The infrared chamber shall be lowered over the repair being sure to allow at least twelve to eighteen (12"–18") inches of heated area beyond the perimeter of the original opening.
- (5) To insure the proper heating time, the contractor shall check the surface temperature of the asphalt at seven (7) minutes and every minute thereafter using an infrared thermometer so as not to allow the surface temperature to exceed three hundred fifty (350°) degrees Fahrenheit. This is required since the ambient temperature, the color of the pavement, the size of the aggregate, and the moisture content influence the heating time.
- (6) After the appropriate heating time (typically eight to ten (8-10) minutes), the asphalt surface will be softened to a depth of two to two and one-half  $(2"-2 \ 1/2")$  inches.
- (7) The infrared chamber shall be then removed from the heated area.
- (8) The backside of a steel rake shall be used to neatly square off the repair, cutting six to twelve (6"-12") inches back from the original excavation along the chalk line.
- (9) The area inside the repair shall be deeply scarified, taking special care to eliminate the original seam between the repair and the road.
- (10) Approximately one-half to one (1/2"-1") inch of existing three-fourths (3/4") inch stones shall be raked out and removed from the patch.
- (11) Maltenes rejuvenator shall be applied to the repair and surrounding heated asphalt surface. Emulsified maltenes recycling agent (rejuvenator) shall be applied in a ratio of 1:1 with water. This solution shall be well dispersed with a commercial grade sprayer at a rate of eight (8) ounces per square yard of heated area. This application area shall

include both the area under repair as well as the area heated by left undisturbed around the perimeter of the repair. The application shall take place after the area has been scarified and just prior to the addition of new asphalt. The rejuvenator replaces the light oil component of asphalt, which has oxidized out over time.

- (12) HMA 4.5M64 Surface Course shall be added to the area to bring it up to proper grade and luted smooth.
- (13) The area shall be compacted. The edges shall be rolled first to fuse the hot repair to the heated but untouched surrounding pavement.
- (14) Light coating of stone dust can then be spread over the repair to remove the tackiness. The road can then be opened to traffic.

## 13. Public hearing and final adoption of Ordinance No. 012-2019 RE: AUTHORIZING THE TRANSFER OF TOWNSHIP OWNED LAND TO HABITAT FOR HUMANITY.

Prior to the Public Hearing Mayor Palombo stated that Sarah Matthews, Director of Habitat for Humanity is here to address any concerns regarding the Habitat for Humanity program. He next stated that there were several concerns brought up at the last meeting regarding road width and safety.

Township Engineer Paul Dietrich then explained that he and the Superintendent of Public Works Craig Reeves inspected and measured the road width edge to edge and the road is thirty

feet wide which more than exceeds the township and state standards. Mr. Dietrich stated that he also verified with Public Safety that they have no concerns with the addition of the two new homes on the street, that there will be no decrease in emergency services. He next reported that he also confirmed with the Superintendent of Public Works that there are no concerns with the Department of Public Works and their ability to service the homes on the street.

The Township Committee then discussed alternative locations for the homes including fronting the homes on Ocean Avenue instead of Pacific Avenue. The Township Attorney stated that this would require the introduction of a new Ordinance with the new lots and any conditions Committee wishes to include stated in the Ordinance.

Mayor Palombo then opened the Public Hearing.

#### The following speakers spoke during the public portion of the Ordinance:

Joe Fenton, 102 Pacific Avenue, stated that he lives directly across the street from one of the subject properties and spoke in opposition to the Ordinance. He inquired into several issues including the process of selecting the parcels. He next questioned if there would be a need for sidewalks. Mr. Dietrich explained that under the residential site improvement standards curbs and sidewalks are not required unless you are within two miles of a school and this property is not within two miles of a school therefore curbs and sidewalks are not required. Lastly, Mr. Fenton stated that he would prefer that the homes face Ocean Avenue.

**Shawn Piper**, **Pacific Avenue**, stated that he lives across from the subject properties and spoke in opposition to the Ordinance because of concerns to wildlife. He stated that he spoke with the NJDEP and per his conversation an LOI (letter of interpretation) is required to determine if the property falls within a vernal habitat. The Engineer explained that a LOI is not required.

Sarah Matthews, Executive Director, Cape May County Habitat for Humanity, explained the selection process and qualifications for applying for a Habitat for Humanity home. She explained that the home Habitat is currently building is the 19<sup>th</sup> habitat home to be built in Cape May County. She next explained that applicants are selected based on three criteria, their ability to repay a Habitat Mortgage, their need and their willingness to partner with Habitat. They must have an outstanding employment history, a low debt to income ratio and a strong rental record.

The Public Hearing was then closed.

Municipal Attorney, Dan Young, recommended that if the Committee is not going to move forward with the Ordinance that they vote to rescind the Ordinance to review alternative parcels for the Habitat for Humanity homes based on the discussions this evening.
