CALL TO ORDER

APPROVAL OF MINUTES - December 16, 2019 Regular and Closed Session Minutes - Motion by Edward Barr, second by John Coggins, to approve the December 16, 2019 Regular Meeting and Closed Session Minutes as submitted. During roll call vote all Committeemen present voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

John Coggins, Committeeman, requested that budget workshops be scheduled for January 27th and February 10th at 6:00 pm, and on February 24th at 6:30 pm.

Hobie Young, Committeeman, reported that the Challenger Hockey team won the bronze medal in the Special Olympics at Stockton. He made a motion to prepare an honoring Resolution. The motion was seconded by Edward Barr. During roll call vote all five Committeemen voted in the affirmative. A resolution for formal action will be placed on a future agenda.

Edward Barr, Committeeman, inquired into the status of leaf collection. Mr. Morgan reported that it should be completed within the next two or three weeks.

Curtis Corson, Committeeman, reported that free rabies clinics will be held on January 25th and February 22nd at Shore Veterinarians from 1:00 to 3:00 pm.

OTHER REPORTS

Scott Morgan, Township Administrator, reminded everyone that the Township Offices will be closed on January 20th in observance of Martin Luther King Day. Normal services will resume on Tuesday. He next requested approval for himself and his three Office of Emergency Management Deputies to attend a New Jersey Emergency Preparedness Association conference at a cost of \$125.00 per person. Motion by Edward Barr, second by Curtis Corson, to approve the request. During roll call vote all five Committeemen voted in the affirmative. Last, he requested approval to prepare the FY19 Emergency Management Grant Award package. Motion by John Coggins, second by Edward Barr, to approve the request. During roll call vote all five Committeeman voted in the affirmative. A resolution accepting the grant award will be placed on the next agenda for formal action;

Daniel Young, Municipal Attorney, reported that there are a number of items for closed session.

Paul Dietrich, Township Engineer, gave a brief update on the reconstruction of Commonwealth Avenue project. He stated that the contractor should complete the curb and sidewalk this week, with the grading and paving to start next week. Next, he gave an update on the replacement of Putnam and Sumner Ave bulkheads. The contractor anticipates having the material on site in February with an anticipated start date in late February or March. Next, he reported that the Planning Board is scheduled to review the draft zoning revisions for Strathmere as part of the Master Plan reexamination. Once the review is complete they will submit their recommendations to the Township Committee. Last, he gave an update on the Army Corps of Engineers back bay study.

**RE: AFFIRMING THE TOWNSHIP OF UPPER'S
CIVIL RIGHTS POLICY WITH RESPECT TO ALL OFFICIALS,
APPOINTEES, EMPLOYEES, PROSPECTIVE EMPLOYEES, VOLUNTEERS,
INDEPENDENT CONTRACTORS, AND MEMBERS OF THE PUBLIC THAT COME INTO
CONTACT WITH MUNICIPAL EMPLOYEES,
OFFICIALS AND VOLUNTEERS**

WHEREAS, it is the policy of the Township of Upper to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

WHEREAS, the governing body of the of the Township of Upper has determined that certain procedures need to be established to accomplish this policy; and

NOW, THEREFORE BE IT RESOLVED to affirm and adopt the Township of Upper's civil rights policy as follows:

Section 1: No official, employee, appointee or volunteer of the Township of Upper by whatever title known, or any entity that is in any way a part of the Township of Upper shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Township of Upper's business or using the facilities or property of the Township of Upper.

Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Township of Upper to provide services that otherwise could be performed by the Township of Upper.

Section 3: Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.

Section 4: The Township Committee shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

Section 5: No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

Section 6: The Personnel Officer shall establish written procedures that require all officials, employees, appointees and volunteers of the Township of Upper as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

Section 7: The Personnel Officer shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.

Section 8: At least annually, the Municipal Clerk shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Township of Upper. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Township of Upper's web site.

Section 9: This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Township of Upper in order for the public to be made aware of this policy and the Township of Upper's commitment to the implementation and enforcement of this policy.
