TOWNSHIP OF UPPER CAPE MAY COUNTY RESOLUTION

RESOLUTION NO. 59-2020

RE: DECLARING THE TOWNSHIP OF UPPER A SECOND AMENDMENT AND LAWFUL GUN OWNER SANCTUARY

WHEREAS, the Second Amendment of the United States Constitution reads: "A well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed," an individual right affirmed by the United States Supreme Court; and

WHEREAS, the State of New Jersey was the first state to ratify the Bill of Rights, including the right to keep and bear Arms, and the New Jersey Supreme Court has recognized it as a fundamental right of its citizens; and

WHEREAS, certain legislation introduced in the State Legislature, and certain legislation introduced in the current session of the United States Congress could have the effect of infringing on the rights of law abiding citizens to keep and bear Arms, as guaranteed by the Second Amendment of the United States Constitution; and

WHEREAS, the Upper Township Committee is concerned about the passage of any bill containing language which could be interpreted as infringing on the rights of the citizens of Upper Township to keep and bear Arms, or could begin a slippery slope of restrictions on the Second Amendment rights of the citizens of Upper Township; and

WHEREAS, the Upper Township Committee desires to express its deep commitment to the rights of the citizens of Upper Township to keep and bear Arms; and

WHEREAS, the Upper Township Committee desires to express opposition to any law that would unconstitutionally restrict the rights under the Second Amendment of the citizens of Upper Township, such as Assembly Bill 6003 proposed before the New Jersey General Assembly; and

WHEREAS, the Upper Township Committee desires to express its intent to stand as a Sanctuary Township for Second Amendment rights and to oppose within the limits of the Constitution of the United States any efforts to unconstitutionally restrict such rights; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, to hereby express its intent: 1) to uphold the Second Amendment rights of the citizens of Upper Township; 2) to oppose any unconstitutional restrictions on the right of its citizens to keep and bear Arms; and 3) that public funds of the Township not be used to restrict Second Amendment rights or to aid in the unnecessary and unconstitutional restriction of the rights under the Second Amendment of the citizens of Upper Township to bear arms; and

BE IT FURTHER RESOLVED that the Upper Township Committee hereby declares the Township of Upper a "Second Amendment and Lawful Gun Owner Sanctuary"; and

BE IT FURTHER RESOLVED that a certified copy of this Resolution be filed with the appropriate New Jersey State Officials.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

- 1. The allegations of the preamble are incorporated herein by this reference.
- 2. The Township Committee does hereby grant approval to Kathryn M. Wright and B & K Enterprises, jointly, severally and in the alternative, to hold a "Spring in Tuckahoe Craftsmen and Home Event" on April 4th and 5th, 2020 as specified in this Resolution and in the accompanying Exhibits subject to and conditioned upon the following:
 - (A) The event described in this Resolution is carried out by Kathryn M. Wright and B & K Enterprises, jointly, severally and in the alternative (Sponsors). These Sponsors have no connection, direct or indirect, with the Township of Upper or any of its officials or employees. These Sponsors shall not, in any way, directly or indirectly, represent that the event is, in any way, associated with or affiliated with the Township of Upper and shall make clear that the event is carried out with all appropriate governmental and other approvals. Although the Township of Upper has given permission, subject to the terms of this Resolution, to these event Sponsors to conduct the proposed event, it must be made

- clear that the event is not and shall not be considered a Township of Upper sponsored or sanctioned event.
- (B) The Sponsors will provide general comprehensive liability insurance coverage to the Township at least thirty (30) days prior to the event. Said insurance coverage will be in form and substance satisfactory to the Township of Upper's Risk Management Consultant and will name the Township of Upper, its officials, officers, and employees as an additional insured.
- (C) The Sponsors have obtained or will obtain written approval from and comply with all conditions imposed by the following entities:
 - (i) the Risk Management Consultant of the Township of Upper.
 - (ii) the New Jersey State Police.
 - (iii) the Upper Township Division of Emergency Management Services.

The Sponsors have provided written authorization from the above entities, including any conditions required of said entities.

- (D) The Sponsors shall remit to the Township the appropriate fee in accordance with Chapter XXVI of the Code of Upper Township at least thirty (30) days prior to the event. This fee shall include the hourly fee for use of the Upper Township Community Center.
- (E) The approval granted herein is subject to all conditions and stipulations as may be recommended or imposed by the Township's Risk

 Management Consultant or Insurance Representatives. The Township may revoke this approval if the Event Sponsors fail to comply with any said condition or recommendation or any other condition of this Resolution.
- 3. All Township officials and officers are hereby authorized and empowered to take all action deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.

WHEREAS, the Township of Upper requires legal counsel to provide legal assistance with respect to the Township's affordable housing obligations, and on December 9, 2019 appointed the firm Jeffrey R. Surenian and Associates, LLC; and

WHEREAS, due to a reorganization of said firm, a resolution is needed to authorize the appointment of the firm now known as Surenian, Edwards & Nolan, LLC; and

WHEREAS, the Township has decided to acquire the services of Surenian, Edwards & Nolan, LLC as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and
