REPORT OF GOVERNING BODY MEMBERS

Hobie Young, Committeeman, reported that the Easter Egg Hunt is scheduled for Saturday April 4th, rain date April 5th, at Amanda's Field from 12:00 pm to 3:00 pm. He next reported that the Challenger Sports program is looking for baseball coaches for the spring season.

Richard Palombo, Mayor, reported that he received an email from Upper Township resident Isabella Freund. Isabella is Miss New Jersey Outstanding Teen, and her platform is Make A Wish. She has requested a way to partner with the Township Committee to promote her fundraiser and

platform for the Make A Wish Foundation. After a brief discussion it was decided to invite Isabella to attend the next meeting and give a presentation.

OTHER REPORTS

Scott Morgan, Township Administrator, reported that the Upper Township Office of Emergency Management has been working in conjunction with the Cape May County Office of Emergency Management to stay informed of the latest developments of COVID-19 Virus. CMC OEM has been working closely with the NJ Office of Emergency Management, NJ Department of Health, and the Centers for Disease Control through conference calls to learn and disseminate the latest information and precautionary measures to lessen the community spread of the COVID-19 Virus. ORDINANCE NO. 003-2020

WHEREAS, the Local Government Cap Law, <u>N.J.S.A.</u> 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to **2.5%** unless authorized by ordinance to increase it to **3.5%** over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the **3.5%** percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Upper in the County of Cape May finds it advisable and necessary to increase its CY 2020 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee of the Township of Upper hereby determines that a 1.0 % increase in the budget for said year, amounting to \$115,017.80 in excess of the increase in

final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Committee of the Township of Upper hereby determines that any amount authorized hereinabove that is not appropriated, as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Upper, in the County of Cape May a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2020 budget year, the final appropriations of the Township of Upper shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by **3.5 %**, amounting to \$ \$402,562.31 and that the CY 2020 municipal budget for the Township of Upper be approved and adopted in accordance with this ordinance; and,

WHEREAS, the subject property is in need of public water and/or gas and the need for those utility services was not known before the road was resurfaced; and

NOW THEREFORE BE IT RESOLVED, by the Governing Body of Township of Upper in the County of Cape May, and the State of New Jersey as follows:

- 1. The appeal of the three-year street opening moratorium shall be approved for the following property: Block 485, Lot 1.
- 2. Enhanced road restoration shall be completed in accordance with attached Exhibit "A".
- An additional Performance and Maintenance Bond for the property in the amount of \$3,000 shall be submitted at time of permit for the required work beyond the Ordinance requirements of Section 13-1.7.
- 4. The Township Engineer or the Public Works Road Supervisor shall be present during all work operations and shall be notified 48 hours in advance of any work.
- 5. All Township officials and officers are hereby authorized and empowered to take all action deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.

EXHIBIT A

Infrared restoration for repair of asphalt that have been opened for utility work shall be utilized after a minimum four (4) month settlement period has elapsed following initial backfill.

- (1) After completion of permanent restoration as required by the Ordinance, the permittee shall provide infrared restoration.
- (2) The area shall be swept clean of dirt, loose aggregate, or standing water.
- (3) A chalk line shall be drawn six to twelve (6"-12") inches back from the seam of the original opening to use as a guide raking.
- (4) The infrared chamber shall be lowered over the repair being sure to allow at least twelve to eighteen (12"–18") inches of heated area beyond the perimeter of the original opening.
- (5) To insure the proper heating time, the contractor shall check the surface temperature of the asphalt at seven (7) minutes and every minute thereafter using an infrared thermometer so as not to allow the surface temperature to exceed three hundred fifty (350°) degrees Fahrenheit. This is required since the ambient temperature, the color of the pavement, the size of the aggregate, and the moisture content influence the heating time.
- After the appropriate heating time (typically eight to ten (8-10) minutes), the asphalt surface will be softened to a depth of two to two and one-half (2''-21/2'') inches.
- (7) The infrared chamber shall be then removed from the heated area.
- (8) The backside of a steel rake shall be used to neatly square off the repair, cutting six to twelve (6"-12") inches back from the original excavation along the chalk line.
- (9) The area inside the repair shall be deeply scarified, taking special care to eliminate the original seam between the repair and the road.
- (10) Approximately one-half to one (1/2"-1") inch of existing three-fourths (3/4") inch stones shall be raked out and removed from the patch.
- (11) Maltenes rejuvenator shall be applied to the repair and surrounding heated asphalt surface. Emulsified maltenes recycling agent (rejuvenator) shall be applied in a ratio of 1:1 with water. This solution shall be well dispersed with a commercial grade sprayer at a rate of eight (8) ounces per square yard of heated area. This application area shall include both the area under repair as well as the area heated by left undisturbed around the perimeter of the repair. The application shall take place after the area has been scarified and just prior to the addition of new asphalt. The rejuvenator replaces the light oil component of asphalt, which has oxidized out over time.
- (12) HMA 4.5M64 Surface Course shall be added to the area to bring it up to proper grade and luted smooth.
- (13) The area shall be compacted. The edges shall be rolled first to fuse the hot repair to the heated but untouched surrounding pavement.
- (14) Light coating of stone dust can then be spread over the repair to remove the tackiness. The road can then be opened to traffic.
- 7. Authorizing an Affiliation and Medical Direction Agreement with AtlantiCare Regional Medical Center for Basic Life Support and Ambulance Services.

- 1. The allegations of the preamble are incorporated herein by this reference.

- 3. The Township Clerk shall cause a Notice of Award of this contract to be published in the official newspaper of the Township as required by N.J.S.A 40A:11-5.
- 4. This Contract is a Professional Services Contract and has been awarded without competitive bidding for the following reasons:

- (A) The services required are highly specialized or technical in nature;
- (B) The services require peculiar ability or skill, and demand a high degree of specialized knowledge or expertise;
- (C) The services required are professional services and/or unspecified extraordinary services within the meaning of N.J.S.A. 40A:11-5(a);
- (D) The individual who will provide these services has demonstrated his competence and particular expertise in the services required; and
- (E) The services to be provided are such that their nature, scope and duration are not capable of precise measurement, but rather require a flexibility and discretion that render competitive bidding impractical and inefficient.
- 5. All Township officials and officers are hereby authorized and empowered to take all action deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.

WHEREAS, Resolution 320-2019, adopted November 12, 2019, authorized the execution of a subcontract with the county of Cape May for the State Fiscal Year 2021 Municipal Alliance Program; and

WHEREAS, Resolution No. 351-2019, adopted December 9, 2019, amended Resolution 320-2019 in order to adjust the Township of Upper's Cash Match portion to an amount in accordance with the agreement between the Township of Upper and Ocean City for the Municipal Alliance Program; and

ORDINANCE NO. 004-2020

AN ORDINANCE AMENDING CHAPTER XXI (USE OF TOWNSHIP FACILITIES) OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF UPPER

BE IT ORDAINED by the Township Committee in the Township of Upper, County of Cape May and State of New Jersey as follows:

SECTION 1: Chapter XXVI of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended and supplemented as hereinafter provided:

26-3 Requirements for Use of Facilities

Revise and replace the following in Section 26-3.1

26-3.1 Application Required.

Any individual or organization requesting the use of a Township facility for an organized or scheduled event must submit an application and required documentation to the Department of Public Works Recreation Leader at least thirty (30) days prior to the proposed event. The applicant must provide a full detailed explanation of the proposed event, including but not limited to, the number of participants and spectators, the amount of any fee charged to a participant or spectator, the activities anticipated, whether or not food or beverages will be consumed at the site, the time and duration of the event and any other information requested by the Township in order to ascertain the nature and scope of the proposed event. Ongoing approved Upper Township sports or recreation programs shall not be required to submit an application for such ongoing activities. The Township Committee or the Department of Sports and Recreation Programs shall from time to time adopt rules and regulations governing such ongoing activities and approving the use of facilities for these programs. Unless otherwise exempted in this Chapter, an application for use of Township facilities is required for any organized or scheduled event which is not part of the approved ongoing activities of the sports or recreation programs.

Revise and replace the following in Section 26-3.3

26-3.3 State Police.

The Township must receive written confirmation from the State Police as to any requirements, suggestions or concerns the State Police may have with respect to the proposed event prior to Township approval.

Revise and replace the following in Section 26-3.4

26-3.4 Emergency Management Services.

The Township must receive written confirmation from the Upper Township Division of Emergency Management Services as to any requirements, suggestions or concerns the Division may have with respect to the proposed event prior to Township approval.

Revise and replace the following in Section 26-3.8

26-3.8 Township Administrator and Township Committee Approval.

The Superintendent of Public Works is authorized to issue the approval upon confirmation of compliance with the requirements of this Chapter; provided, however, for an event where more than one hundred (100) participants and spectators are expected, final approval of the Township Committee is required. If an application for use of facilities is denied by the Superintendent of Public Works the applicant may request a review of the decision by the Township Committee.

Revise and replace the following in Section 26-3.11

26-3.11 Park Pavilions.

Park pavilions may be utilized by groups of seventy-five (75) persons or less without prior approval on a first come first served basis. Township residents may reserve the use of a pavilion in advance by scheduling same with the Department of Public Works Recreation Leader. For use of the pavilion by groups of more than seventy-five (75) persons, an

application for use of facilities must be submitted and the applicant must comply with the other provisions of this Chapter with respect to use of facility requirements and fees.

SECTION 2: REPEALER: All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.

SECTION 3: SEVERABILITY: If any section, paragraph, subdivision, subsection, clause or provision of the Ordinance shall be adjudged invalid, such adjudication shall only apply to the section, paragraph, subdivision, subsection, clause or provision declared invalid and the remainder of the Ordinance shall remain in full force and effect and shall be enforceable.

SECTION 4: EFFECTIVE DATE: This Ordinance shall take effect immediately upon final adoption and publication as required by law.

SECTION 5: CODIFICATION: This Ordinance shall be codified in Chapter XXVI of the Upper Township Code commencing at Section 26-3.
