# CALL TO ORDER

# **SUNSHINE ANNOUNCEMENT**

Mayor Palombo read the following announcement. Tonight's meeting is being audio recorded up until the closed session portion of this meeting and will be available on the Upper Township website. # APPROVAL OF MINUTES - March 23, 2020 Regular Session Minutes

Motion by Edward Barr, second by John Coggins, to approve the March 23, 2020 Regular Session Minutes as submitted. During roll call vote all five Committeemen voted in the affirmative.

# **REPORT OF GOVERNING BODY MEMBERS**

**Hobie Young, Committeeman,** spoke regarding the Coronavirus Pandemic and complimented the Township employees for doing an excellent job while working under difficult conditions. He next reported on a growing issue of people not heeding the closed signs posted at the parks and playgrounds. It was stated that in addition to the signs which have been posted at the parks and playgrounds, notices have been posted on the Township website and social media sites regarding the Coronavirus. Mayor Palombo urged all residents to visit the Township's website for information and resources which are updated daily regarding COVID-19.

**Edward Barr, Committeeman**, thanked the Township employees for their hard work during the pandemic, and especially thanked EMS Chief Michelle Sampson and the Division of EMS. He also thanked the members of the Upper Township Rescue Squad and the Township's Fire Departments for their efforts.

**Curtis Corson, Committeeman**, also thanked the Division of EMS and all first responders for their efforts during the pandemic.

**Richard Palombo, Mayor**, stated that although he knows there is deep concern regarding the COVID-19 virus and increased cases in the County, he stressed that the Township will not release the names or addresses of anyone that tests positive. He also again stressed the importance for all residents to visit the Township's website for up to date information and guidance on the COVID-19 virus. Last, he stated that although he has received multiple requests from area churches to hold outdoor services, he strongly recommends against any public gatherings, and suggests that churches utilize the online streaming services instead. It was suggested that links for the area churches be placed on the Township's websites.

# **OTHER REPORTS**

**Scott Morgan, Township Administrator**, gave an update on the COVID-19 cases in New Jersey and Cape May County and stated that unfortunately one Upper Township resident has died from complications associated with the virus. He stated that our prayers go out to the family and friends of this resident. He reported that cases in Cape May County continue to increase and reminded everyone to follow the CDC guidelines to protect yourself, family members and co-workers from this very serious virus pandemic. He also reminded residents that the Township recreation areas, playgrounds, and beaches remain closed. He urged all residents to continue to stay home as mandated by Governor Murphy, and to please continue to follow all federal, state, county, and local guidelines and orders. Additional information on mitigation, preparedness and response can be found as usual on the Township's website with information updated on a daily basis. Lastly, he reported that Atlantic City Electric has completed the installation of the LED lights at Caldwell Park.

**Barbara Young, Municipal Clerk**, reported that the Cape May County election poll worker training classes previously scheduled to be held in Upper Township have been cancelled until further notice. She next reported that Municipal offices will be closed on Friday April 10<sup>th</sup> in observance of Good Friday.

**Daniel Young, Municipal Attorney**, reported that there are a number of contract negotiation items and a personnel item for closed session.

**Paul Dietrich, Township Engineer**, reported that work on the construction of the Sumner Avenue bulkhead has started and should be completed by the end of this week. The contractor will then begin the construction of the Putnam Avenue bulkhead. He next reported that the Township has received a request from a Strathmere resident for the Township to co-sign a DEP permit application and possible license to work in the Township's right-of-way for a dredging project. The Municipal Attorney stated that because the project is occurring on the Township's right-of-way, he recommends requesting an indemnification agreement and insurance from the property owner to make sure if there's any issues or accidents that, from a liability standpoint, the township is covered. He stated that normally if the township prepares an agreement for property access rights, we ask the other party to cover the costs and legal fees associated with the preparation of the agreement. In this case, if the dredge can be used towards beach fill, he would recommend waiving those costs in exchange for the dredge material. Motion by Curtis Corson, second by Edward Barr, to present the Municipal Attorney's recommendations of the request to the property owners and move forward with a resolution as

recommended. During roll call vote all five Committeemen voted in the affirmative. Mayor Palombo then inquired into the status of the pedestrian safety grant for Neptune Avenue. Mr. Dietrich stated that he has notified the NJDOT that the Township would like to cancel the local aid agreement and release the funds back to the NJDOT.
