CALL TO ORDER

SUNSHINE ANNOUNCEMENT

Mayor Palombo read the following announcement. "In compliance with the Open Public Meetings Law, I wish to state that on May 8, 2020, the notice of this meeting of the Upper Township Committee was posted on the official Township Bulletin Board, the Upper Township Website, and the Town Hall Foyer, mailed to the Cape May County Gazette, the Atlantic City Press, the Ocean City Sentinel-Ledger, the Herald Times and filed with the Township Clerk. Tonight's meeting is being audio recorded up until the closed session portion of this meeting and will be available on the Upper Township website. I hereby direct that this announcement be made a part of the minutes of this meeting."

Also present were Municipal Clerk Barbara Young, Municipal Attorney Daniel Young, Township Administrator Scott Morgan, Township Engineer Paul Dietrich, and Chief Financial Officer Barbara Ludy.

APPROVAL OF MINUTES - April 27, 2020 Regular and Closed Session Minutes

Motion by Edward Barr, second by Hobie Young, to approve the April 27, 2020 Regular Session Minutes as submitted. During roll call vote all five Committeemen voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

John Coggins, Committeeman, requested that Department Heads be mindful of reduced revenues and postpone any nonemergent expenditures towards the end of the year. He stated that the Township's auditor and CFO predict that State Aid will be delayed by a few months. He next requested that the CFO prepare a report summarizing budget expenditures and revenues year to date. He next thanked Mayor Palombo for working with the Mayors of Ocean City and Sea Isle to open the beaches. He stated that he along with many residents are ready for businesses and services to open up, and suggested that the Township hold their next meeting at Town Hall. It was stated that the Governors stay at home order is still in effect until June 5th, and a public hearing of Ordinance 005-2020 has been advertised and noticed for May 26th as an electronic meeting. If changed, the public hearing will need to be re-noticed, which will postpone the hearing. Mayor Palombo suggested that the first meeting in June potentially be held at Town Hall, and requested the Township Administrator to prepare for ways to enable social distancing in the meeting room.

Hobie Young, Committeeman, requested that the tennis courts be opened up at Caldwell Park. He next reported that people are still jumping the fence at the Amanda's Field Skate Park, and suggested that it also be opened in a limited capacity. After a lengthy discussion there was a motion by Hobie Young, second by Edward Barr, to open the tennis and pickle ball courts at Caldwell Park and the pickle ball courts in Tuckahoe, contingent upon compliance with social distancing guidelines. During roll call vote all five Committeemen voted in the affirmative. It was decided to keep the Skate Park closed for now with a request for an increased patrol from NJSP. Committeeman Young next reported that preliminary plans are underway for the 4th of July. He stated that he would like to incorporate the cancelled egg hunt into the 4th of July event. There was then a lengthy discussion at which time it was decided to revisit the matter at the first meeting in June. He next stated that he received great feedback from the last Mayor's message and suggested that, with the County's proposed plans and dates to reopen, it may be a good idea to do another message to the public just to give people some hope. Mayor Palombo stated that the County is waiting for a response from the Governor approving the proposed plan.

Richard Palombo, Mayor, reported that the County has unfortunately cancelled the Memorial Day ceremonies, and asked that residents remember those that sacrificed their lives for this country. He stated that the VFW will ensure that flags are placed on the gravesites. He next reported that in conjunction with Ocean City and Sea Isle, the Township instituted a soft opening of the beaches this past weekend. He stated that as long as visitors comply with the social distancing guideline he hopes to have a full opening of the beaches by Memorial Day. Mayor Palombo then requested the Committee to consider, once retail business are allowed to open, allowing restaurants to utilize sidewalk and parking lot space for outdoor seating in order to help alleviate some of the capacity restrictions. The Municipal Attorney stated that ordinarily this would require a site plan amendment and an application to the planning board to allow them to do that. He stated that another issue is businesses requesting the use of the Township's right of way for outdoor seating. However, due to the emergency, these issues can be addressed through an emergency order issued by the Township's Emergency Management Coordinator. Mayor Palombo directed the Township Engineer, in conjunction with the Municipal Attorney and Township Administrator, to prepare a plan to address these issues, allowing for an internal administrative review, and giving guidance to businesses.

OTHER REPORTS

Scott Morgan, Township Administrator, gave a brief status report on the total Covid-19 cases in New Jersey, Cape May County, and Upper Township. He next thanked the NJSP for their response to several recent ATV issues at Amanda's Field and Caldwell Park. He next reported that Public Works has completed the brush and leaf collection. The next brush collection is scheduled for October. Later in the meeting, Mr. Morgan reported that an emergency order has been prepared to extend the 2020 period of operation for residential campgrounds to December 1, 2020. After a brief discussion, there was a motion by John Coggins second by Hobie Young to recommend an emergency order extending the 2020 campground operation period to December 1, 2020. During roll call vote, four Committeemen voted in the affirmative. Committeeman Corson abstained.

Barbara Young, Municipal Clerk, reported that due to Coivd-19 the opening of the Beesley's Point boat ramp has been delayed. She stated that per the Ordinance, permits to use the boat ramp purchased before May 31st cost \$50.00 for residents and \$100.00 for nonresidents. Permits purchased after May 31st increase to \$75.00 and \$150.00 respectively. She requested that the Township consider amending the cost of the permits to remain at the pre May 31st costs for the whole season. The Municipal Attorney stated again that normally this would require an Ordinance amendment. However, due to the state of emergency, the Township's Emergency Management Coordinator can effectuate this request by emergency order. He recommended a motion supporting this action. Motion by John Coggins, second by Edward Barr, supporting an emergency order for the 2020 boat ramp permit fees to remain at the preseason rate. During roll call vote all five Committeemen voted in the affirmative. Mrs. Young then encouraged all residents to complete the 2020 Census.

Daniel Young, Municipal Attorney, reported that there are a few items for closed session.

Paul Dietrich, Township Engineer, reported that there are some areas closed on the Strathmere beach because of nesting birds. He requested that all visitors be mindful of the protected areas. He next reminded everyone that after March 31st dogs are not permitted on the beach.

Barbara Ludy, Chief Financial Officer, requested authorization to participate in the South Jersey Power Cooperative for electric supply. Motion by Curtis Corson, second by John Coggins, to approve the request. During roll call vote all five Committeemen voted in the affirmative. Mrs. Ludy next reported that, due to Covid-19, revenues were down for the month of April and she expect revenues will be down for the month of May. She stated that the decrease in revenues will affect the budget next year, and cautioned everyone to be mindful with spending. Mayor Palombo requested that an inventory be kept of all expenditures due to Covid-19 for possible reimbursement. The CFO assured the Mayor that her office is doing so. The Township Administrator also stated that an application for public assistance has been submitted.

WHEREAS, R.S. 54:4-66 provides that real estate taxes are payable in quarterly installments on February 1st, May 1st, August 1st and November 1st in each year; and

WHEREAS, under NJSA 54:4-66(a), second-quarter property taxes are due May 1, 2020 for municipalities on a calendar year budget cycle; and

WHEREAS, R.S. 54:4-67 authorizes municipalities to provide a grace period not exceeding ten (10) days without a charge for interest; and

WHEREAS, the Township of Upper has heretofore adopted a resolution that no interest may be charged if any installment of taxes or payment of an assessment is made within the tenth calendar day following the date on which same shall become due and payable; and

WHEREAS, as a result of the declared state of emergency by the Governor due to COVID 19, many businesses, residents and taxpayers of the Township of Upper have suffered a loss of income which has created a financial hardship making it difficult to meet May 1, 2020 due date for timely payment of real property taxes; and

WHEREAS, the Governor has issued Executive Order 130 (2020) which provides that any governing body of a municipality with a calendar year budget cycle adopt a resolution instituting a grace period concluding on a date no later than June 1, 2020 for the payment of second-quarter property taxes, and

WHEREAS, the Township Committee finds that it would be in the best interest of the residents and taxpayers of the Township of Upper to extend the grace period for the payment of the second quarter taxes until June 1, 2020.

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Upper, Cape May County, hereby authorizes that the grace period for the payment of the second quarter property taxes is hereby extended until June 1, 2020, as authorized pursuant to Executive Order 130 (2020); and be it

FURTHER RESOLVED that the Township Clerk shall notify the Director of the Division of Local Government Services in the Department of Community Affairs of the within resolution instituting an extended grace period adopted under authority of Executive Order 130 (2020) not later than the third business day next following the Township Committee's adoption of the within resolution; and be it

FURTHER RESOLVED that nothing contained herein shall provide an additional extension of the installment date or grace period for the payment of property taxes, or otherwise temporarily fix, reduce, or retroactively modify the rate of interest charged for failure to make timely

- 10. **Karen Galle request a portion of Belcroft Avenue be designated as "No Parking".** After a lengthy discussion it was decided to canvas the affected property owners about the request and bring the matter back for review at a future meeting.
- 11. Annual Stormwater Report and Supplemental Questionnaire. Municipal Engineer Paul Dietrich stated that the annual stormwater report is a summary of all the Township does to maintain our stormwater management system. He stated that the report demonstrates all the hard work that the Public Works department does to keep our stormwater system clear and keep the pollutants from entering into the drainage way. She stated the overriding concern is that the Township opens smartly and slowly while protecting the health and safety of employees, families, and customers.
