### \*\*\*\*\*BUDGET WORKSHOP MEETING - 6:30 P.M.

In preparation of the 2021 Municipal Budget a budget workshop meeting was called to order this evening at 6:30 PM.

Mayor Palombo read the following Open Public meeting notice into the record.

Tonight's meeting is being audio recorded and will be available on the Upper Township website. I hereby direct that this announcement be made a part of the minutes of this meeting."

Also present were Municipal Clerk Barbara Young, Township Administrator Scott Morgan, Personnel Officer Sharon Taggart, Township Engineer Paul Dietrich and Chief Financial Officer Barbara Ludy.

Mayor Palombo stated we will forgo the salute to the flag until the regular meeting at 7:30. Committeeman Coggins then began the meeting by explaining that the intention of tonight's workshop meeting is to go over the proposed appropriations for 2021 in comparison to the actual expenditures in 2020. He explained that the proposed 2021 budget is 14,800,000.00 with salaries and wages and healthcare and benefits equal to an increase of \$528,000. He then explained that based on our proposed budget we have a potential revenue shortfall of \$560,000., combined with expenses that need to be reduced by \$400,000. There was then a general review and discussion of the variance reports and line items in each department's proposed budget compared to the departments actual 2020 spend.

Lastly, Committeeman Coggins requested that a second budget workshop meeting be scheduled for February 8, 2020 at 6:00 pm. Motion by Richard Palombo, second by Edward Barr, to adjourn the budget workshop meeting. During roll call vote all five Committee members voted in the affirmative. The next budget workshop will be held on February 8, 2021 at 6:00 P.M.

The Committee then took a short recess prior to the start of the regular meeting at 7:30 PM.

Motion by Edward Barr, second by Kimberly Hayes, to approve the January 8, 2021 Reorganization Minutes and January 11, 2021 Regular Meeting and Closed Session Minutes as submitted. During roll call vote five Committee members voted in the affirmative.

### REPORT OF GOVERNING BODY MEMBERS

**Kimberly Hayes, Committeewoman,** encouraged everyone to go onto the website to register for the Covid-19 vaccine.

**Curtis Corson, Committeeman,** reported that the recent rabies clinic held On January 16th was a success with 113 dogs and 49 cats vaccinated. The next rabies clinic will be held on February 13th at 1:00 pm at Shore Veterinarians. Committeeman Corson next reported that the contractor who recently paved Corson Tavern Road left asphalt millings behind on his property. He stated that the contractor used his property a staging area. He then requested permission to donate the millings to the township's public works department. Municipal Attorney Dan Young explained that township has accepted private donations in the past, and his only recommendation would be that the donation be subject to the approval of the townships Risk Management Consultant. Motion by Ed Barr, second by John Coggins to accept the millings subject to the approval of the townships Risk Management Consultant. During roll call vote four Committee members voted in the affirmative. Committeeman Corson abstained. Next, Mr. Corson reported that there is a meeting scheduled for Monday February 1st with the township's Parking Consultant and the subcommittee to discuss parking and beach tags for Strathmere. He stated that he will have a full report for everyone at the next Township Committee meeting on February 8th. Lastly, he reported that the Upper Township Rescue Squad will be selling roses for Valentine's Day on February 12th, 13th and 14th.

**Richard Palombo, Mayor,** encouraged everyone to register for the Covid-19 vaccine.

### **OTHER REPORTS**

**Scott Morgan, Township Administrator,** gave an update on the CMC Health Department report for Covid-19 cases in Upper Township and Cape May County. He stated that for questions and the latest information on the Covid-19 vaccine and availability to contact the Cape May County Department of

Health at <a href="www.capemaycountynj.gov">www.capemaycountynj.gov</a>. He next reported that the new Cape May County Health Department Call Center is now open. He stated that the information for the call center along with the information to pre-register for the Covid-19 vaccine is posted on the Upper Township website. Mr. Morgan then reported on an EMS request for EMS employee Johnathan Carter to attend a Telecommunicator Certification Course Monday March 15, 2021 to Friday March 19, 2021 and to attend a separate New Jersey Dispatch Certification Course March 22, 2021 to March 25, 2021. He stated that there is an opportunity for Mr. Carter to host the class at our EMS building which would reduce the cost of each course by half, normally the cost of each course is \$400.00 per person for each course. Motion by Curtis Corson, second by Edward Barr to approve the EMS request. During roll call vote all five Committee members voted in the affirmative. Lastly, Mr. Barr questioned if there will be an opportunity to host a vaccination center in Upper Township. Mayor Palombo responded that although preliminary, Mr. Morgan and he are currently reviewing the possibility of a vaccine center in the northern end of County with the Cape May County Department of Health. He explained that currently there is a vaccine center in Avalon.

**Paul Dietrich, Township Engineer**, reported that the NJDOT is constructing variable message signs in the right of way along NJSH Route 50 in the vicinity of Deerfield Trail in Upper Township. Lastly, Mr. Dietrich reported that the township was recently notified of the New Jersey Transportation Authority Bulkhead replacement on Harbor Road.

**Joe Halpin, Upper Township,** questioned if the township has condemned the property. The Municipal Attorney stated that the township has not taken any steps to condemn the property.

**WHEREAS**, pursuant to <u>N.J.S.A.</u> 40A:12A-7, a Governing Body may adopt, revise or amend a redevelopment plan for an "area in need of redevelopment"; and

**WHEREAS**, in order to facilitate the redevelopment and rehabilitation of the Township, the Township has prepared the redevelopment plan entitled "Beesley's Point Redevelopment Plan Block 479, Lot 76, 76.01, 94.01, 106.02, 107, 107.01, 108, and 108.01" (the "Redevelopment Plan"), dated January 2021, for the Redevelopment Area; and

**WHEREAS**, the Redevelopment Plan provides a broad overview for the planning, development, redevelopment and rehabilitation of the Redevelopment Area for purposes of improving conditions within the Township; and

WHEREAS, the Township Committee has determined that it is in the best interest of the Township to adopt the Redevelopment Plan to effectuate redevelopment and rehabilitation of the Redevelopment Area; and

**WHEREAS**, pursuant to N.J.S.A. 40A:12A-7, the Township Committee adopted a Resolution referring the Redevelopment Plan to the Township of Upper Planning Board (the "Planning Board") for review, comment and a finding of consistency with the Township Master Plan following introduction and first reading; and

**WHEREAS**, the Planning Board held a public hearing on January 21, 2021, and, finding the Redevelopment Plan to be consistent with the Township Master Plan, recommended that the Redevelopment Plan be adopted, via Resolution No. 01-2021, which shall be considered the report of the Planning Board to the Township Committee as required by N.J.S.A. 40A:12A-7(e); and

**WHEREAS**, the Redevelopment Plan for the Redevelopment Area meets the requirements of N.J.S.A. 40A:12A-1, et seq., and is consistent with the Township's Master Plan.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee, in the Township of Upper, County of Cape May and State of New Jersey, as follows:

**SECTION 1.** The Township hereby adopts the Redevelopment Plan for the Township of Upper.

**SECTION 2.** The Mayor and Township Committee declare and determine that said Redevelopment Plan meets the criteria, guidelines and conditions set forth in N.J.S.A. 40A:12A-7, provides realistic opportunities for the redevelopment and rehabilitation of the Township and is otherwise in conformance with N.J.S.A. 40A-12A-1, et seq.

**SECTION 3.** The Governing Body of the Township of Upper shall have, be entitled to, and is hereby vested all power and authority granted by the aforementioned statutory provisions to effectuate the Redevelopment Plan.

**SECTION 4.** The Redevelopment Plan shall supersede any other local development regulation to the extent set forth in the Redevelopment Plan and the Township of Upper Zoning Map is hereby amended to conform with the provisions of the Redevelopment Plan.

**SECTION 5.** All ordinances or parts of ordinances which are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 6.** In the event any clause section or paragraph of this Ordinance is deemed invalid or unenforceable for any reason, it is the intent of the Township Committee that the balance of this Ordinance remains in full force and effect to the extent it allows the Township to meet the goals of the Ordinance.

**SECTION 7.** This Ordinance shall take effect after final adoption and publication according to law.
