CALL TO ORDER

Tonight's meeting is being audio recorded up until the closed session portion of this meeting and will be available on the Upper Township website. APPROVAL OF MINUTES - February 22, 2021 Regular and Closed Session Minutes

Motion by Edward Barr, second by John Coggins, to approve the February 22, 2021 Regular Meeting and Closed Session Minutes as submitted. During roll call vote five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

John Coggins, Committeeman, reminded everyone that the budget will be introduced at the next meeting on March 22nd. He further advised that the Township will not need to institute beach fees this year to balance the budget, however, due to the loss in ratables from the decommissioning of the BL England property, he urged the Committee to adopt the fees for 2022. He next spoke about the pending marijuana regulations and stated that the Township should adopt an Ordinance prohibiting marijuana dispensaries to operate in the Township. After a lengthy discussion, Committeewoman Hayes requested the matter be listed on the next agenda under Unfinished Business for further discussion.

Kimberly Hayes, Committeewoman, stated that she was recently invited to meet with the Upper Township Rescue Squad, and was privileged to swear in the new officers. She congratulated President John Britton, Treasurer Mary Lyons, and Secretary Linwood Chatten.

Edward Barr, Committeeman, inquired into the status of the County's plans to reconstruct New Bridge Road. The Township Engineer stated that the project was initially delayed due to the need to obtain construction easements from property owners and is now delayed until at least next year due to the lack of funding. He stated that the County Engineer is hoping to address the project in 2022. After a brief discussion there was a motion by Curtis Corson, second by Edward Barr, to prepare a resolution urging the County to fund the reconstruction of New Bridge Road. During roll call vote all five Committee members voted in the affirmative. A resolution for formal action will be placed on the next agenda.

Curtis Corson, Committeeman, stated that Daylight Savings time is next Sunday March 14th and reminded everyone to change their smoke detector batteries when changing the clocks. He next reported that he, the Township Administrator, the Township Engineer, and others recently met with representative from the DEP regarding the issues at Corson's Inlet State Park, during which several items were addressed.

Richard Palombo, Mayor, inquired into the status of the Township's paving project. The Township Engineer stated that Iroquois Trail is the last street to be paved, and work will commence in the next

week. There are a few other punch list items for the contractor to complete and the project will be finished.

OTHER REPORTS

Scott Morgan, Township Administrator, gave a brief update on the latest information from the CMC Health Department regarding Covid-19. He next requested permission for Division of EMS employee Johnathan Carter to attend a basic life support instructor course on April 17th at a cost of \$420.00. Motion by Curtis Corson, second by Kimberly Hayes, to approve the request. During roll call vote all five Committee members voted in the affirmative.

Paul Dietrich, Township Engineer, reported that several towns have been adopting Resolutions asking the legislature to pass a law to increase shore protection funds, and requested that the Township do the same. After a brief discussion, the Committee approved the request. A Resolution for formal action will be placed on the next agenda.

WHEREAS, the Township of Upper has determined that it is in the best interest of the Township to enter into a Shared Services Agreement with the County of Cape May; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee, the governing body of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

- 1. SHARED SERVICES AGREEMENT. Pursuant to the provisions of the Uniform Shared Services Act, (N.J.S.A. 40A:65-1, et seq., the Township of Upper is hereby authorized and empowered to enter into a Shared Services Agreement with the County of Cape May for the funding of the project known as "Beesley's Point Gateway".
- 2. SERVICES TO BE PROVIDED; CONTRACT. The Shared Services Agreement authorized in paragraph 1 hereof shall cover those services, which shall be enumerated in said Agreement.
- 3. AUTHORIZATION TO MUNICIPAL OFFICIALS. The appropriate Township officers and officials are hereby authorized to take any action necessary or advisable to carry out the intent and purpose of this Resolution. Specifically, the Mayor and Township Clerk are hereby authorized and directed to execute such Shared Services Agreement on behalf of the Township of Upper pursuant to the authority conferred by this Resolution. The Township Clerk is further authorized and directed to seal said Agreement with the official seal of the Township of Upper.

4. COMPLIANCE WITH STATUTORY REQUIREMENTS. The Shared Services Agreement between the County of Cape May and the Township of Upper shall meet and satisfy the requirements of N.J.S.A. 40A:65-1, et seq., as same may be amended and supplemented.

5. CONTRACT TERM. The term of this Agreement is for the period as stipulated in the Shared Service Agreement from the date of full execution of the Shared Services Agreement. 6. SEVERABILITY. If any section, subsection, paragraph, sentence or other part of this Resolution is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Resolution, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Resolution directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Resolution shall remain in full force and effect.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF UPPER, IN THE COUNTY OF CAPE MAY, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. The second and third subsections of Section 3(c) of Bond Ordinance numbered 010-2020 ("Bond Ordinance #010-2020") of the Township of Upper, in the County of Cape May, New Jersey (the "Township"), finally adopted November 9, 2020 is hereby amended to amend the appropriations and authorizations of the projects to read as follows:

Section Two. Section 6(b) of Bond Ordinance #010-2020 of the Township is hereby amended to amend the average useful life to read as follows:

"The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 6.905 years."

Section Three. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Four. All other details of Bond Ordinance #010-2020 shall remain the same.

Section Five. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

ORDINANCE NO. 005-2021

AN ORDINANCE AMENDING REVISED GENERAL ORDINANCE CHAPTER IV OF THE CODE OF UPPER TOWNSHIP TO REGULATE THE TOWING AND STORAGE OF MOTOR VEHICLES BY THE TOWNSHIP

BE IT ORDAINED by the Township Committee in the Township of Upper, County of Cape May and State of new Jersey as follows:

SECTION 1: Chapter IV of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, is hereby amended and supplemented to add the following Section 4-4:

4-4 TOWING AND STORAGE

4-4.1 Purpose

The purpose of this ordinance is to establish procedures and standards for the award of a contract for the towing and storage of motor vehicles by the Township.

4-4.2 Award of Contract to Towing Contractor.

The contract to provide towing, lockout and storage services to the Township of Upper must be submitted in accordance with the terms of the Towing, Storage and Lockout Services Bid Specifications and Proposal Form. The terms and quotes provided by the prospective contractor in the Bid Specifications and Proposal Form are binding, and contracts will be based upon these terms.

From all submissions that are provided to the Township in accordance with the bid specifications and proposal form, the Township of Upper will award the contract to the lowest responsible bidder who is determined to be a qualified and reputable towing, storage and lockout contractor. Lowest responsible bidder does not indicate that the Township will merely choose the bidder with the lowest price quote, but instead the bidder determined to be qualified and reputable with the lowest price quote.

4-4.3 Term of Towing Contract.

- a. Initial Contract. The initial contract between the Township and the successful bidder will be for 12 months.
- b. Renewal of Initial Contract. The Township may, at their option, renew the contract for a twenty-four-month extension, to continue at identical terms to the initial contract.

c. Maximum Duration of Contract. The total term of the contract cannot exceed 36 months, in accordance with N.J.S.A. 40A:11-15(22). After the 36 months, the contract is ended, and a new bidding process and acceptance must occur.

4-4.4 Services Provided by the Towing Contractor.

- a. Towing. The towing contractor will be responsible, at the discretion and request of the State Police, Township Administrator or the Township Parking Enforcement Officer, for the towing of:
 - 1. Abandoned vehicles;
 - 2. Disabled vehicles;
 - 3. Illegally parked vehicles;
 - 4. Stolen vehicles:
 - 5. Vehicles involved in accidents within the Township of Upper;
 - 6. Those vehicles whose owners are suspected of being involved in criminal activity within the Township of Upper;
 - 7. Any other vehicle identified and requested by the State Police, Township Administrator or Township Parking Enforcement Officer.
- b. Storage. The towing contractor will be responsible for the storage of any vehicles towed from the Township of Upper.
- c. Lockout Services. The towing contractor will be responsible, at the discretion and request of the State Police, the Township Administrator or Township Parking Enforcement Officer, for providing a lockout service for motorist's whose vehicles are located within the Township of Upper.

4-4.5 Qualifications of the Towing Contractor.

- a. The towing contractor must be able to demonstrate, to the satisfaction of the Township:
 - 1. That they are qualified and experienced in the business of towing, storage, and lockout services;
 - 2. That they are qualified and experienced in the removal of vehicles of all types;
 - 3. That they have the required and specified facilities and storage areas;
 - 4. That they have the required and specified equipment, expertise, and licensing; and
 - 5. That they have the required and specified personnel.
- b. Each bidder must submit, with their bid, a criminal background check for each employee, either from the New Jersey State Police or another reputable provider. This criminal background check must have been conducted within one calendar year of the submission of the bid to be deemed valid for bidding purposes. Any conviction for a felony shall be a sufficient reason to disqualify any bidder, at the discretion of the Township.

Each bidder must also submit, with their bid, a copy of all current and valid driver's licenses for the operators of service equipment who are employed by the contractor and who will be directly involved in the fulfillment of the contract.

- c. The towing contractor shall submit, with their bid, a copy of their written Drug-Free Workplace Policy. This policy shall include, but is not limited to: pre-employment testing, on-going testing, employee assistance, and consequences of policy violation.
- d. The towing contractor shall submit, with their bid, the name of other municipalities and/or businesses to which they have previously and/or are currently providing contract towing, storage and lockout services.

Additionally, the towing contractor shall submit, with their bid, a list of towing, storage and lockout service contracts that they have held within the past three years that are similar in scope and nature to that offered by the Township of Upper. The Township reserves the right to use these references and/or their performance on any municipal/business towing, storage, and lockout service contracts in making its award determination.

4-4.6 Standby and Emergency Services.

- a. Equipment Necessary. The towing contractor will be required to furnish extra towing equipment and service during storms, snow emergencies, traffic emergencies, special events, disasters, any acts of God, or for any other reason so designated by the Township. During such periods, hereinafter "standby periods," the towing contractor will be required to provide adequate equipment and service, held ready to remove passenger vehicles and light trucks under 1 1/2 tons.
- b. Duration of Standby Services. Standby service will begin when Upper Township contacts the towing contractor. Standby service will end when Upper Township contacts the towing contractor to inform him of the termination.
- c. Additional Storage Locations. The Township reserves the right to, during any emergency, designate a temporary storage location on a property owned or leased by the Township. These temporary storage locations would be used to house vehicles at the direction of the Emergency Management Coordinator or his designee from the Township. Any transportation of vehicle to or from these temporary storage locations will carry with them the same charges as would transportation to the official storage facility.

4-4.7 Insurance Requirements.

- a. The contractor providing towing services must be insured by an insurance company authorized to do business in the State of New Jersey. In addition to providing the minimum insurance coverage required by N.J.A.C. 13:45A-31.3, the contractor shall provide such additional insurance as recommended by the Township Risk Management Consultant as set forth in the bid request.
- b. Insurance coverage must indemnify the Township of Upper, the general public including all elected and appointed officials, all employees and volunteers, or boards, commissions and or authorities and their board members, employees and volunteers against any loss due to injuries, accidents or damages of any kind where this damage is the result of an act or omission by the towing contractor or his agents, in or due to the fulfillment of the Towing Contract.

4-4.8 Rights of Vehicle Owners.

- a. The owner of any vehicle that is towed has the right to remove property belonging to them from the stored vehicle, unless the vehicle is marked "Police Hold" on the towing form. Any items must be removed during the scheduled release hours, or as otherwise determined by the State Police.
- b. The vehicle owner or his representative retains the right to take photographs of their stored vehicle for insurance claim purposes.
- c. All complaints arising from the towing and storage of motor vehicles shall be submitted to the Township Administrator. The Township Administrator shall review and investigate any such complaint and make a determination as to the appropriate action, if any, or otherwise resolve the complaint.

4-4.9 Compliance with Other Laws and Regulations.

The contractor shall comply with all other laws and regulations, including but not limited to N.J.S.A. 56:13-7 et seq. and N.J.A.C. 13:45A-31.1 et seq.

SECTION 2: EFFECTIVE DATE: All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

SECTION 3: REPEALER: This Ordinance shall take effect immediately upon final adoption and publication as required by law.

Such materials will be collected by set schedule set forth by Township Committee. The Township may limit the amount of tree trimmings a resident may place at the curb by resolution of the Township Committee adopting such rule or regulation.
