#### REPORT OF GOVERNING BODY MEMBERS

Kimberly Hayes, Committeewoman, reported that spring sports have started with no issues. She thanked the Public Works department for the excellent work maintaining the facilities. She next reported that the Ocean City Upper Township Rotary Club has offered to donate a bench for the Golden Oak Lane park. She stated that she has reached out to the Township Engineer to guide them through the process and Public Works will assist with the installation. She next reported about a group of cyclists who have extended an invitation to any that would like to join their group. They stage at Caldwell park and ride on Tuesdays at 5:30 pm and Saturdays and Sundays at 10:00 am. She requested all residents to be aware and careful of bike riders. Last, she reported that the Atlantic City mega site has numerous vaccines available.

**Curtis Corson, Committeeman**, also spoke about the availability of vaccines at the mega site in Atlantic City. He next reported that the County recently performed an emergency repair of the erosion

on Ocean Drive by the causeway. He thanked the Township Engineer and the County for moving quickly to address the issue.

WHEREAS, suffragists wrote, marched, were arrested, and ultimately succeeded in achieving the enactment of:

- the 19th Amendment to the Constitution of the United States, section 1 of which provides that "The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any state on account of sex"; and
- 2) the Voting Rights Act of 1965 (52 U.S.C. 10301 et seq.), which extended the protection of the right to vote to women of color and language minorities; and

WHEREAS, women have been and continue to be leaders in the forefront of social change efforts, business, science, government, math, art, literature, music, film, athletics, and more; and

WHEREAS, American women have served our country courageously in the military; and
WHEREAS, women now represent approximately half of the workforce of the United
States; and

WHEREAS, President Jimmy Carter issued the first Presidential Proclamation designating March 2 through 8, 1980, as "National Women's History Week"; and

WHEREAS, in 1987, a bipartisan group of Senators introduced the first joint resolution to pass Congress designating "Women's History Month"; and

#### **RESOLUTION NO. 108-2021**

### RE: RESOLUTION SUPPORTING SENATE NO. 3522, CREATING LOCAL PART OF THE PUBLIC EMPLOYEES' RETIREMENT SYSTEM (PERS)

WHEREAS, county, municipal, and other local governments have met their pension obligations as employers for more than a decade while the State of New Jersey has continued to underfund the pension systems in varying degrees since 1996 and thus creating one of the worst publicly funded retirement systems in the entire nation; and

WHEREAS, despite fulfilling their fiduciary duties in meeting their pension obligations, local governments across the State will experience double digit percentage increases in total employer pension contributions in 2021 as determined in figures recently published by the Division of Pension and Benefits in the State Department of Treasury; and

WHEREAS, even more alarming for local government employers is the fact that the unfunded accrued liability once again increased in 2021 to a staggering \$26.6 billion for PERS alone, causing in part, a decrease in the funded ratio for the Local Part of PERS to 65.4%, the State Part to

31.2%, and the combined rate to a disconcerting 52.2% far below the target funded ratio of 75.0%; and

WHEREAS, S-3522 would divide PERS into two parts: a State Part for state

employees, and a Local Part for all other employees; and

WHEREAS, this legislation creates a seven member board consisting of; three labor

employee representatives, three management representatives, and one determined by the Board, tasked

with operating the retirement system and directing policies and investments to achieve and maintain

full funding; and

WHEREAS, S-3522 would protect local governing bodies from the State of New

Jersey further directing property taxpayer dollars to subsidize its long mismanagement and

underfunding of the pension systems as it would provide the new balanced board of trustees of PERS

with the ability to determine or modify member benefits, direct policies and investments to achieve full

funding, and serve as fiduciary of the system.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the

Township of Upper, in the County of Cape May and State of New Jersey hereby supports S-3522,

which would establish a new board of trustees for the Local Part of the Public Employees' Retirement

System (PERS) to preserve the structure and integrity of the more solvent Local Part.

**WHEREAS**, in 2020 New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, the Act establishes six marketplace classes of licensed businesses, including:

- Class 1 Cannabis Cultivator license, for facilities involved in growing and cultivating cannabis;
- Class 2 Cannabis Manufacturer license, for facilities involved in the manufacturing, preparation, and packaging of cannabis items;
- Class 3 Cannabis Wholesaler license, for facilities involved in obtaining and selling cannabis items for later resale by other licensees;
- Class 4 Cannabis Distributer license, for businesses involved in transporting cannabis plants in bulk from on licensed cultivator to another licensed cultivator, or cannabis items in bulk from any type of licensed cannabis business to another;
- Class 5 Cannabis Retailer license, for locations at which cannabis items and related supplies are sold to consumers; and
- Class 6 Cannabis Delivery license, for businesses providing courier services for consumer purchases that are fulfilled by a licensed cannabis retailer in order to make deliveries of the purchased items to a consumer, and which service would include the ability of a consumer to make a purchase directly through the cannabis delivery service which would be presented by the delivery service for fulfillment by a retailer and then delivered to a consumer; and

WHEREAS, section 31a of the Act authorizes municipalities by ordinance to adopt regulations governing the number of cannabis establishments (defined in section 3 of the Act as "a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer"), cannabis distributors or cannabis delivery services allowed to operate within their boundaries, as well as the location manner and times of operation of such establishments, distributors or delivery services, and establishing civil penalties for the violation of any such regulations; and

WHEREAS, section 31b of the Act authorizes municipalities by ordinance to prohibit the operation of any one or more classes of cannabis establishments, distributors, or delivery services anywhere in the municipality; and

**WHEREAS**, section 31b of the Act also stipulates, however, that any municipal regulation or prohibition must be adopted within 180 days of the effective date of the Act (i.e., by August 22, 2021); and

WHEREAS, pursuant to section 31b of the Act, the failure to do so shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling, and reselling of cannabis and cannabis items shall be permitted uses in all industrial zones, and the retail selling of cannabis items to consumers shall be a conditional use in all commercial and retail zones; and

WHEREAS, at the conclusion of the initial and any subsequent five-year period following a failure to enact local regulations or prohibitions, the municipality shall again have 180 days to adopt an ordinance regulating or prohibiting cannabis businesses, but any such ordinance would be prospective only and would not apply to any cannabis business already operating within the municipality; and

WHEREAS, the Township Committee of the Township of Upper has determined that, due to present uncertainties regarding the potential future impacts that allowing one or more classes of cannabis business might have on New Jersey municipalities in general, and on the Township of Upper in particular, it is at this time necessary and appropriate, and in the best interest of the health, safety and welfare of the Township of Upper's residents and members of the public who visit, travel, or conduct business in the Township of Upper, to amend the Township of Upper's zoning regulations to prohibit all manner of marijuana-related land use and development within the geographic boundaries of the Township of Upper; and

WHEREAS, officials from two prominent non-profit organizations that have been established for the purpose of advising New Jersey municipalities on legal matters such as have been presented by the Act (those organizations being the New Jersey State League of Municipalities and the New Jersey Institute of Local Government Attorneys) have strongly urged that, due to the complexity and novelty of the Act; the many areas of municipal law that are or may be implicated in decisions as to whether or to what extent cannabis or medical cannabis should be permitted for land use purposes or otherwise regulated in any particular municipality; and the relatively short duration in which the Act would allow such decisions to be made before imposing an automatic authorization of such uses in specified zoning districts subject to unspecified conditions, the most prudent course of action for all municipalities, whether or not generally in favor of cannabis or medical cannabis land development and uses, would be to prohibit all such uses within the Act's 180-day period in order to ensure sufficient time to carefully review all aspects of the Act and its impacts; and

WHEREAS, pursuant to N.J.S.A. 40:55D-89 the Upper Township Planning Board undertook reexamination of its Master Plan in August 2018, November 2018 and March 2020 to determine the major problems and objectives relating to land development within the Township; and

**WHEREAS**, the Planning Board's Master Plan Reexamination identified the need to provide and create the appropriate land use controls if the sale and production of marijuana is legalized, including the prohibition of same in the Township; and

**WHEREAS**, this amendment to the Upper Township Zoning Ordinance prohibiting marijuana – related land use and development was recommended in the periodic reexamination of the Master Plan by the Planning Board; and

**WHEREAS**, pursuant to N.J.S.A. 40:55D-64 and N.J.S.A. 40:55D-26, this ordinance was referred by the Township Committee to the Upper Township Planning Board to determine the consistency of this ordinance with the Master Plan; and

**NOW THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Upper, in the County of Cape May, State of New Jersey, as follows:

<u>SECTION 1</u>: Pursuant to section 31b of the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (P.L. 2021, c. 16), all cannabis establishments, cannabis distributors or cannabis delivery services are hereby prohibited from operating anywhere in the Township of Upper, except for the delivery of cannabis items and related supplies by a delivery service.

**SECTION 2:** Chapter 20, Section 1.5, entitled "Prohibited Uses", of the Revised General Ordinances of the Township of Upper, is hereby amended as follows:

#### Add the following in Section 20-1.5(b):

4. All classes of cannabis establishments or cannabis distributors or cannabis delivery services as said terms are defined in section 3 of P.L. 2021, c. 16, but not the delivery of cannabis items and related supplies by a delivery service.

**SECTION 3**: **REPEALER**: All Ordinances or parts of Ordinances which are in conflict or inconsistent herewith are hereby repealed to the extent of such inconsistency or conflict only.

<u>SECTION 4: SEVERABILITY:</u> If any section, paragraph, subdivision, subsection, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause, or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

<u>SECTION 5</u>: <u>EFFECTIVE DATE</u>: This Ordinance shall take effect immediately upon the final publication as required by law. <u>SECTION 6</u>: <u>CODIFICATION</u>: This Ordinance shall be codified in the Upper Township Code at the section referred to above.

#### **ORDINANCE NO. 012-2021**

## AN ORDINANCE AMENDING REVISED GENERAL ORDINANCE CHAPTER III (POLICE REGULATIONS) AND CHAPTER IV (GENERAL LICENSING) OF THE CODE OF UPPER TOWNSHIP

**BE IT ORDAINED** by the Township Committee in the Township of Upper, County of Cape May and State of New Jersey as follows:

**SECTION 1:** Chapter III, Section 3-12, of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended as follows:

#### 3-12 PROHIBITING SMOKING AND THE CONSUMPTION OF CANNABIS IN

#### TOWNSHIP PUBLIC FACILITIES.

#### **Replace in its entirety Section 3-12.1:**

3-12.1 Definitions.

As used in this section, the following terms shall have the meaning indicated:

Cannabis shall mean all parts of the plant Cannabis sativa L., whether growing or not, the seeds thereof, and every compound, manufacture, salt, derivative, mixture, or preparation of the plant or its seeds; but does not include medical cannabis dispensed to registered qualifying patients pursuant to the "Jake Honig Compassionate Use Medical 27 Cannabis Act," P.L.2009, c.307 (C.24:6I-1 et al.).

Cannabis products shall mean cannabis concentrate and products that are composed of cannabis and other ingredients and that are intended for use or consumption, including edible products, ointments, and tinctures.

Certified Coach shall mean a coach of an approved Upper Township Sports Program.

Consume, Consuming, and Consumption shall mean the act of ingesting, inhaling or otherwise introducing cannabis into the human body.

Department Head shall have the meaning of "Supervisor" as defined herein.

*Indoor place* shall mean a structurally enclosed area.

*Public Facility* shall mean any municipally owned or maintained park, beach, building or other property including, but not limited to, athletic fields and maintained paths.

*Smoking* shall mean the inhaling, exhaling, vaping, aerosolizing or burning of a lighted cigar, cigarette, pipe, electronic device, or any other matter or substance containing tobacco or cannabis, whether natural or synthetic.

Supervisor shall mean the person who ultimately controls, governs or directs the activities and conduct of employees within a certain department or division.

#### Replace in its entirety Section 3-12.2:

3-12.2 Smoking or the Consumption of Cannabis and Cannabis Products Prohibited.

Smoking or the consumption of cannabis and cannabis products shall be prohibited at all times at all Township Public Facilities.

#### Replace in its entirety Section 3-12.3:

- 3-12.3 Violation of Prohibition; Request to Comply; Denial of Services.
  - a. Any Certified Coach, Department Head or Supervisor, or their designee, may order any person smoking or consuming cannabis or cannabis products in violation of this section to comply with the provisions hereof. Thereupon, any member of the public who smokes or consumes cannabis or cannabis products in Public Facilities is in violation of this section, shall be subject to a fine as hereinafter provided.
  - b. The supervisor or department head shall have the right to withhold the services of the supervisor's department, division or agency to any member of the public who smokes or consumes cannabis or cannabis products in any public area in which such conduct is prohibited, provided that the supervisor or department head shall first inform that person of this right. Services shall not be denied if the member of the public complies with the rules governing smoking or consuming cannabis or cannabis products after receiving this notice, and the supervisor or department head shall so inform that person.
  - c. Any person waiting for services in a municipal building who leaves the building to smoke or consume cannabis or cannabis products shall, upon re-entering the building, have the right to regain his or her position in the order of persons receiving those services.

#### Replace in its entirety Section 3-12.4:

3-12.4 Posting of Signs.

The Township shall install appropriate signs which shall be posted in conspicuous places throughout Public Facilities affected by this section advising the public and employees that smoking and consuming cannabis or cannabis products is prohibited.

**SECTION 2:** Chapter IV, Section 3.9, of the Revised General Ordinances of the

Township of Upper, also known as the Code of Upper Township, shall be amended as follows:

#### Replace the following in Section 4-3.9a:

- 4-3.9 General Rules.
  - a. There shall be no smoking or consumption of cannabis or cannabis products on jitneys.

**SECTIONS 3: REPEALER:** All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall take effect immediately upon final adoption and publication as required by law.
