Motion by John Coggins, second by Curtis Corson, to approve the April 26, 2021 Regular Meeting and Closed Session Minutes as submitted. During roll call vote all four Committee members present voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Kimberly Hayes, Committeewoman, gave a brief report regarding the playground in Strathmere. She stated that Public Works has fixed the broken pipe, and the mulch has been replaced. More improvements to the area will be coming.

Curtis Corson, Committeeman, reported that the Department of Public Works has begun to paint the curbs for the no parking areas in Strathmere pursuant to the recently adopted Ordinance.

Richard Palombo, Mayor, reported that a Memorial Day Service will be held on May 31st at 10:00 am at the William Godfrey Memorial Park in Osprey Point. He next reported that due to the positive progress with Covid-19 vaccinations and the reduced number of active cases, the Township

Committee meetings will resume normal live operations beginning at the May 24th meeting. Individuals will be able to attend the live meeting, with proper social distancing and adherence to all state regulations. As was done before the pandemic, the meetings will be videotaped and posted on the website afterwards for viewing.

OTHER REPORTS

Scott Morgan, Township Administrator, gave a brief update on the latest information from the CMC Health Department regarding Covid-19. He next reported that the Tax Assessor and Recreation Leader have organized a Blood Drive on June 9th from 10:00 am to 3:00 pm at the Upper Township Community Center, and are requesting permission to offer a contest for one day off with pay to employees that donate blood. Paul Dietrich, Township Engineer, gave a follow up to a prior discussion regarding traffic control issues on Stagecoach Road. 15. Public hearing and final adoption of Ordinance No. 010-2021 RE: AN ORDINANCE AMENDING REVISED GENERAL ORDINANCE CHAPTER X OF THE CODE OF UPPER TOWNSHIP. During the public hearing portion there was the following speaker:

Blanche Adams, Steelmantown, on behalf of the Upper Township Business Association, spoke in opposition to an increase in fees for tents and temporary structures and stated that this will put a burden on businesses who are trying to comply with the State Covid-19 occupancy limits. The Municipal Attorney stated that the Township has already waived the fees for emergency provisions regarding temporary structures during the Covid-19 state of emergency. Mrs. Adams also opposed the increased fee for sign permits. It was stated that the fees are in line with or below area Municipalities.

Mayor Palombo then closed the public hearing. Motion by John Coggins, second by Curtis Corson to adopt Ordinance No. 010-2021. During roll call vote all four Committee members present voted in the affirmative.

TOWNSHIP OF UPPER CAPE MAY COUNTY ORDINANCE

ORDINANCE NO. 010-2021

RE: AN ORDINANCE AMENDING REVISED GENERAL ORDINANCE CHAPTER X OF THE CODE OF UPPER TOWNSHIP

BE IT ORDAINED by the Township Committee, in the Township of Upper, County of Cape May and State of New Jersey, as follows:

SECTION 1. Chapter 10, Section 10-1.3, of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended and supplemented as hereinafter provided:

10-1.3 Fees.

Revise and replace the following in Section 10-1.3a.:

- Demolition Fees. The fee for a demolition or removal permit shall be \$150.00 for a structure of less
 than 5,000 square feet in area and less than 30 feet in height, for one- or two-family residences (use group R-5 of the building subcode), and structures on farms including commercial farm buildings under N.J.A.C. 5:23-3.2(d), and \$200.00 for all other use
- 2. Sign Permits. The fee for a permit to construct a sign shall be in the amount of \$2.50 per square foot of surface area of the sign, computed on one side only for a double faced sign. The minimum permit fee for a sign shall be \$62.00.

Revise and replace the following in Section 10-1.3g.:

2. Fees for renovations, alterations and repairs are based on estimated cost of work:

\$1,000.00 up to \$50,000.00 \$30.00 per \$1,000.00 \$50,001.00 up to \$100,000.00 \$23.00 per \$1,000.00 \$100,001.00 and above \$19.00 per \$1,000.00

For the purpose of determining estimated cost the applicant shall submit to the agency such cost data as may be available, produced by the architect or engineer of record, or by a recognized estimating firm or by the contractor. A bona fide contractor's bid, if available, shall be submitted. The agency shall make the final decision regarding the estimated cost.

Add the following in Section 10-1.3g.:

- 5. Fees for tents and temporary structures shall be \$95.00.
- 6. Fees for trailers/park models shall be \$100.00.

Add the following in Section 10-1.3i.:

12. For each monitor device for solar systems the fee shall be \$62.00.

Revise and replace the following in Section 10-1.3j.:

6. The fee for each kitchen exhaust system shall be \$125.00.

Add the following in Section 10-1.3j.:

- 9. The fee for the installation or demolition of tanks shall be \$65.00.
- 10. The fee for each smoke control system shall be \$65.00.
- 11. The fee for each fire pump shall be \$65.00.
- 12. The fee for each pre-action/dry/alarm valve shall be \$30.00.

13. The fee for each fireplace vent or metal chimney shall be \$65.00.

SECTION 2: **REPEALER**: All Ordinances or parts of Ordinances which are in conflict or inconsistent herewith are hereby repealed to the extent of such inconsistency or conflict only.

SECTION 3: SEVERABILITY: If any section, paragraph, subdivision, subsection, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

SECTION 4: EFFECTIVE DATE: This Ordinance shall take effect upon final adoption and publication as required by law.

SECTION 5: CODIFICATION: This Ordinance shall be codified in the Upper Township Code at the sections referred to above.

Spencer Belz, Marmora, spoke in opposition to this Ordinance.

Blanche Adams, Steelmantown, on behalf of the Upper Township Business Association, stated that the UTBA recently conducted a survey of residents regarding this Ordinance and an overwhelming majority of the survey participants supported allowing cannabis businesses to operate in the Township.

Mayor Palombo then closed the public hearing.

Committeeman Corson stated that the proposed tax revenue of cannabis businesses would not offset the costs of police enforcement capabilities that would be needed.

The Municipal Attorney stated that this Ordinance allows the Township Committee the flexibility to tailor regulations of permitted cannabis uses in the Township. Due to the way

the statute was written, if the Township did not adopt this Ordinance now, there would be no recourse to regulate the use in the Township for five years.

Motion by Kimberly Hayes, second by Curtis Corson to adopt Ordinance No. 011-2021. During roll call vote all four Committee members present voted in the affirmative.

TOWNSHIP OF UPPER CAPE MAY COUNTY ORDINANCE

ORDINANCE NO. 011-2021

RE: AN ORDINANCE PROHIBITING THE OPERATION OF ANY CLASS OF CANNABIS BUSINESSES WITHIN THE TOWNSHIP OF UPPER'S GEOGRAPHICAL BOUNDARIES AND AMENDING CHAPTER 20, SECTION 1.5 OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF UPPER

WHEREAS, in 2020 New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, the Act establishes six marketplace classes of licensed businesses, including:

- Class 1 Cannabis Cultivator license, for facilities involved in growing and cultivating cannabis;
- Class 2 Cannabis Manufacturer license, for facilities involved in the manufacturing, preparation, and packaging of cannabis items;
- Class 3 Cannabis Wholesaler license, for facilities involved in obtaining and selling cannabis items for later resale by other licensees;
- Class 4 Cannabis Distributer license, for businesses involved in transporting cannabis plants in bulk from on licensed cultivator to another licensed cultivator, or cannabis items in bulk from any type of licensed cannabis business to another;
- Class 5 Cannabis Retailer license, for locations at which cannabis items and related supplies are sold to consumers; and
- Class 6 Cannabis Delivery license, for businesses providing courier services for
 consumer purchases that are fulfilled by a licensed cannabis retailer in order to make
 deliveries of the purchased items to a consumer, and which service would include the
 ability of a consumer to make a purchase directly through the cannabis delivery
 service which would be presented by the delivery service for fulfillment by a retailer
 and then delivered to a consumer; and

WHEREAS, section 31a of the Act authorizes municipalities by ordinance to adopt regulations governing the number of cannabis establishments (defined in section 3 of the Act as "a

cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer"), cannabis distributors or cannabis delivery services allowed to operate within their boundaries, as well as the location manner and times of operation of such establishments, distributors or delivery services, and establishing civil penalties for the violation of any such regulations; and

WHEREAS, section 31b of the Act authorizes municipalities by ordinance to prohibit the operation of any one or more classes of cannabis establishments, distributors, or delivery services anywhere in the municipality; and

WHEREAS, section 31b of the Act also stipulates, however, that any municipal regulation or prohibition must be adopted within 180 days of the effective date of the Act (i.e., by August 22, 2021); and

WHEREAS, pursuant to section 31b of the Act, the failure to do so shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling, and reselling of cannabis and cannabis items shall be permitted uses in all industrial zones, and the retail selling of cannabis items to consumers shall be a conditional use in all commercial and retail zones; and

WHEREAS, at the conclusion of the initial and any subsequent five-year period following a failure to enact local regulations or prohibitions, the municipality shall again have 180 days to adopt an ordinance regulating or prohibiting cannabis businesses, but any such ordinance would be prospective only and would not apply to any cannabis business already operating within the municipality; and

WHEREAS, the Township Committee of the Township of Upper has determined that, due to present uncertainties regarding the potential future impacts that allowing one or more classes of cannabis business might have on New Jersey municipalities in general, and on the Township of Upper in particular, it is at this time necessary and appropriate, and in the best interest of the health, safety and welfare of the Township of Upper's residents and members of the public who visit, travel, or conduct business in the Township of Upper, to amend the Township of Upper's zoning regulations to prohibit all manner of marijuana-related land use and development within the geographic boundaries of the Township of Upper; and

WHEREAS, officials from two prominent non-profit organizations that have been established for the purpose of advising New Jersey municipalities on legal matters such as have been presented by the Act (those organizations being the New Jersey State League of Municipalities and the New Jersey Institute of Local Government Attorneys) have strongly urged that, due to the complexity and novelty of the Act; the many areas of municipal law that are or may be implicated in decisions as to whether or to what extent cannabis or medical cannabis should be permitted for land use purposes or otherwise regulated in any particular municipality; and the relatively short duration in which the Act would allow such decisions to be made before imposing an automatic authorization of such uses in specified zoning districts subject to unspecified conditions, the most prudent course of action for all municipalities, whether or not generally in favor of cannabis or medical cannabis land development and uses, would be to prohibit all such uses within the Act's 180-day period in order to ensure sufficient time to carefully review all aspects of the Act and its impacts; and

WHEREAS, pursuant to N.J.S.A. 40:55D-89 the Upper Township Planning Board undertook reexamination of its Master Plan in August 2018, November 2018 and March 2020 to determine the major problems and objectives relating to land development within the Township; and

WHEREAS, the Planning Board's Master Plan Reexamination identified the need to provide and create the appropriate land use controls if the sale and production of marijuana is legalized, including the prohibition of same in the Township; and

WHEREAS, this amendment to the Upper Township Zoning Ordinance prohibiting

marijuana – related land use and development was recommended in the periodic reexamination of the Master Plan by the Planning Board; and

WHEREAS, pursuant to N.J.S.A. 40:55D-64 and N.J.S.A. 40:55D-26, this ordinance was referred by the Township Committee to the Upper Township Planning Board to determine the consistency of this ordinance with the Master Plan; and

NOW THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Upper, in the County of Cape May, State of New Jersey, as follows:

<u>SECTION 1</u>: Pursuant to section 31b of the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (P.L. 2021, c. 16), all cannabis establishments, cannabis distributors or cannabis delivery services are hereby prohibited from operating anywhere in the Township of Upper, except for the delivery of cannabis items and related supplies by a delivery service.

SECTION 2: Chapter 20, Section 1.5, entitled "Prohibited Uses", of the Revised General Ordinances of the Township of Upper, is hereby amended as follows:

Add the following in Section 20-1.5(b):

4. All classes of cannabis establishments or cannabis distributors or cannabis delivery services as said terms are defined in section 3 of P.L. 2021, c. 16, but not the delivery of cannabis items and related supplies by a delivery service.

SECTION 3: **REPEALER**: All Ordinances or parts of Ordinances which are in conflict or inconsistent herewith are hereby repealed to the extent of such inconsistency or conflict only.

SECTION 4: SEVERABILITY: If any section, paragraph, subdivision, subsection, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause, or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

ORDINANCE NO. 012-2021

AN ORDINANCE AMENDING REVISED GENERAL ORDINANCE CHAPTER III (POLICE REGULATIONS) AND CHAPTER IV (GENERAL LICENSING) OF THE CODE OF UPPER TOWNSHIP

BE IT ORDAINED by the Township Committee in the Township of Upper, County of Cape May and State of New Jersey as follows:

SECTION 1: Chapter III, Section 3-12, of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended as follows:

3-12 PROHIBITING SMOKING AND THE CONSUMPTION OF CANNABIS IN TOWNSHIP PUBLIC FACILITIES.

Replace in its entirety Section 3-12.1:

3-12.1 Definitions.

As used in this section, the following terms shall have the meaning indicated:

Cannabis shall mean all parts of the plant Cannabis sativa L., whether growing or not, the seeds thereof, and every compound, manufacture, salt, derivative, mixture, or preparation of the plant or its seeds; but does not include medical cannabis dispensed to registered qualifying patients pursuant to the "Jake Honig Compassionate Use Medical 27 Cannabis Act," P.L.2009, c.307 (C.24:6I-1 et al.).

Cannabis products shall mean cannabis concentrate and products that are composed of cannabis and other ingredients and that are intended for use or consumption, including edible products, ointments, and tinctures.

Certified Coach shall mean a coach of an approved Upper Township Sports Program.

Consume, Consuming, and Consumption shall mean the act of ingesting, inhaling or otherwise introducing cannabis into the human body.

Department Head shall have the meaning of "Supervisor" as defined herein.

Indoor place shall mean a structurally enclosed area.

Public Facility shall mean any municipally owned or maintained park, beach, building or other property including, but not limited to, athletic fields and maintained paths.

Smoking shall mean the inhaling, exhaling, vaping, aerosolizing or burning of a lighted cigar, cigarette, pipe, electronic device, or any other matter or substance containing tobacco or cannabis, whether natural or synthetic.

Supervisor shall mean the person who ultimately controls, governs or directs the activities and conduct of employees within a certain department or division.

Replace in its entirety Section 3-12.2:

3-12.2 Smoking or the Consumption of Cannabis and Cannabis Products Prohibited.

Smoking or the consumption of cannabis and cannabis products shall be prohibited at all times at all Township Public Facilities.

Replace in its entirety Section 3-12.3:

- 3-12.3 Violation of Prohibition; Request to Comply; Denial of Services.
 - a. Any Certified Coach, Department Head or Supervisor, or their designee, may order any person smoking or consuming cannabis or cannabis products in violation of this section to comply with the provisions hereof. Thereupon, any member of the public who smokes or consumes cannabis or cannabis products in Public Facilities is in violation of this section, shall be subject to a fine as hereinafter provided.
 - b. The supervisor or department head shall have the right to withhold the services of the supervisor's department, division or agency to any member of the public who smokes or consumes cannabis or cannabis products in any public area in which such conduct is prohibited, provided that the supervisor or department head shall first inform that person of this right. Services shall not be denied if the member of the public complies with the rules governing smoking or consuming cannabis or cannabis products after receiving this notice, and the supervisor or department head shall so inform that person.
 - c. Any person waiting for services in a municipal building who leaves the building to smoke or consume cannabis or cannabis products shall, upon re-entering the building, have the right to regain his or her position in the order of persons receiving those services.

Replace in its entirety Section 3-12.4:

3-12.4 Posting of Signs.

The Township shall install appropriate signs which shall be posted in conspicuous places throughout Public Facilities affected by this section advising the public and employees that smoking and consuming cannabis or cannabis products is prohibited.

SECTION 2: Chapter IV, Section 3.9, of the Revised General Ordinances of the

Township of Upper, also known as the Code of Upper Township, shall be amended as follows:

Replace the following in Section 4-3.9a:

4-3.9 General Rules.

a. There shall be no smoking or consumption of cannabis or cannabis products on jitneys.

SECTIONS 3: REPEALER: All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

SECTION 3: EFFECTIVE DATE: This Ordinance shall take effect immediately

upon final adoption and publication as required by law.
