Motion by Curtis Corson, second by John Coggins, to approve the May 10, 2021 Regular Meeting and Closed Session Minutes as submitted. During roll call vote four Committee members voted in the affirmative. Committeeman Barr abstained.

REPORT OF GOVERNING BODY MEMBERS

Kimberly Hayes, Committeewoman, reported that the Township will be hosting a Red Cross blood drive on June 9th at the Community Center from 10:00 am to 3:00 pm. She next reported that the Historical Preservation Society will be holding a strawberry sale on May 29th beginning at 10:00 am. She next gave a brief update on the tentative plans for the 4th of July celebration event and stated that more information will be forthcoming.

Edward Barr, Committeeman, praised the Department of Public Works for their efforts in getting the beaches ready for the summer season.

Curtis Corson, Committeeman, also praised the Department of Public Works for their efforts. He next reported on the trash issue at the entrance to Corson's Inlet State Park. He stated that although the state park policy is for visitors to be responsible for carrying trash out of the park and properly disposing of it, as it stands, they are just dumping the trash at the entrance. He stated that it is necessary for the Township to provide trash carts to help curb the issue. After a brief discussion, there was a motion by Edward Barr,

second by Richard Palombo, to provide trash cans at the entrance to the Corson's Inlet State Park, During roll call vote all five Committee members voted in the affirmative. Committeeman Corson next reported that parking enforcement in Strathmere will begin on Friday May 28th and advised residents to call 609-628-7011 to report parking violations.

Richard Palombo, Mayor, reported on the planned Memorial Day services in Upper Township.

OTHER REPORTS

Scott Morgan, Township Administrator, gave a brief update on the latest information from the CMC Health Department regarding Covid-19. He next reported that the Office of Emergency Management has been authorized to move forward with the Emergency Management Performance Grant Application. A resolution for formal action is listed on tonight's agenda.

Barbara Young, Township Clerk, reported that Township Offices will be closed on Monday May 31st for the Memorial Day holiday. Trash and recycling will be collected on Monday.

Paul Dietrich, Township Engineer, gave a brief update on the Beesley's Point Park project. He stated that the boardwalk area is almost complete, and they have started on the bulkhead for the boat ramp, as well as started paving. He next reported that he has been actively working with Scott Morgan, Public Works, and FEMA to submit the reimbursement for Tropical Storm Isaias.

PUBLIC COMMENT
