APPROVAL OF MINUTES - June 14, 2021 Regular and Closed Session Minutes

Motion by Edward Barr, second by John Coggins, to approve the June 14, 2021 Regular Meeting and Closed Session Minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

John Coggins, Committeeman, wished everyone a happy and safe Independence Day.

Kimberly Hayes, Committeewoman, invited everyone to attend the township's 4th of July Celebrations to be held on Sunday July 4th (rain date July 5th) beginning the day at 8:00 a.m. at the Beesley's Point Boat Park for a model yacht demonstration, followed by a Parade in Strathmere at 10:30 a.m. followed by an awards ceremony at the Deauville Inn. Ms. Hayes thanked Strathmere resident Karen Mitchell for spearheading and organizing the parade. She next announced that we will round out the day's festivities with a celebration at Amanda's Field with live music, food vendors, crafts, games and fun for the entire family. Lastly, Ms. Hayes reported that the township will soon launch an arts program for youth and seniors "Upper Township ACT" Arts Culture and Theatre, headed by township resident Dr. Janice Lake Betts. She explained that the nonprofit organization will be similar to the township's sports organizations. The Municipal Attorney explained that once they're up and running a review of the organization by-laws and a resolution to officially authorize the organization as a township program will be required.

Edward Barr, Committeeman, wished everyone a safe and enjoyable 4th of July.

Curtis Corson, Committeeman, reported that there will be Lifeguard tryouts on July 17th with anticipated hires at the August 9, 2021 meeting. He also explained that the stand at Seacliff was moved to Vincent Avenue because of the Piping Plovers at Seacliff. He next reported that Lifeguard races will begin on July 6th starting in Longport, with the first race in Upper Township "Bay Race" on July 20th. Lastly, he gave a brief update on the parking enforcement in Strathmere.

Richard Palombo, Mayor, discussed the need to continue approvals for outdoor dining and requested that language be drafted for review to allow outdoor dining on a permanent basis. Motion by Richard Palombo, second by Edward Barr, to direct that the Municipal Attorney draft language to allow administrative approval of outdoor displays and dining. During roll call vote all five Committee members voted in the affirmative.

OTHER REPORTS

Scott Morgan, Township Administrator, gave an update on the latest information from the CMC Health Department regarding Covid-19. Mr. Morgan next reported that he recently received correspondence from the NJ Department of Law and Public Safety Division of State Police that the Township OEM Emergency Operations Plan meets criteria for approval.

Barbara Young, Township Clerk, reported that Township Offices will be closed on Monday July 5th in observance of Independence Day.

Paul Dietrich, Township Engineer, reported that the paperwork has been submitted to FEMA for reimbursement for Tornado Isaias for 670 ton of debris at approximately \$190,000. He next gave an update on the Beesley's Point Park project. The Committee then discussed opening the Beesly's Point beach on the weekends beginning on July 4th. There was then a discussion on fees for the ramp and the projected date for opening the boat ramp. It was stated that the anticipated date for the opening is July 15th. There was then a motion by Richard Palombo, second by Edward Barr to sell the seasonal boat ramp permits at a reduced rate of \$50.00 and the daily permits at \$12.00. During roll call vote all five Committee members voted in the affirmative.

- 6. All Township officials and officers are hereby authorized and empowered to take all action deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.
