August 18, 2021 Special Meeting Regular and Closed Session Minutes – Motion by Edward Barr, second by John Coggins, to approve the August 18, 2021 Special Meeting Regular and Closed Session Minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

John Coggins, Committeeman, reported that the Township recently received notice that Ocean First Bank will be closing its Upper Township branch in December. He stated that the Township has a contract with Ocean First Bank with one of the services provided being the collection of taxes. He requested the Committee's approval to direct the Municipal Attorney to review the contract and investigate the Township's options.

Kimberly Hayes, Committeewoman, stated that plans are moving forward with the fall event scheduled for October 3rd, however, there have been issues regarding the proposed beer garden. She stated that Misty Meadows is having a similar event on the same day and proposed partnering with Misty Meadows in which the Township will provide transportation between Amanda's Field and Misty Meadows. After a lengthy discussion, the Municipal Attorney was directed to look into the legalities of the proposal.

Curtis Corson, Committeeman, reported that the Township will be holding a free rabies clinic on October 16th from 1:00 pm to 3:00 pm at Shore Veterinarians.

Richard Palombo, Mayor, thanked Osprey Point for their hospitality during the September 11th memorial ceremony.

OTHER REPORTS

Scott Morgan, Township Administrator, gave a brief update on the latest information from the CMC Health Department regarding Covid-19.

Paul Dietrich, Township Engineer, reported that he has spoken with the County Engineer regarding New Bridge Road. The road was temporarily patched this past spring and is slated for reconstruction and paving in the fall of 2022. He next reported that he has obtained quotes for a flagpole to be placed at the Beesley's Point Park and if the Committee wishes to proceed with the purchase, an authorizing resolution will be placed on the next agenda for formal action. He next stated that the September 24th grand opening of the Beesley's Point Park will need to be postponed due to delivery delays of some materials. He also presented a draft change order for alterations to the roof style of the mechanical building as requested by the County. There was a motion by John Coggins, second by Kimberly Hayes, to have a resolution drafted approving the change order for the Beesley's Point Park project. During roll call vote all five Committee members voted in the affirmative. A resolution for formal action will be placed on the next agenda.

WHEREAS, stationed at Fort Benning, GA for basic infantry officer training, Douglass's 8th Regiment of the 1st Cavalry Division completed winter exercises at Mount Fuji, Japan, and he then served nearly 2 years in the Korean War beginning in September 1953 and was a combined 30-year veteran of the active and active reserve Army Corps, retiring with the rank of Major; and

WHEREAS, Douglass was very active as a board member of the Historic Preservation Society of Upper Township and served over the years as president, vice president and trustee, helped with the Gandy Farmstead and Friendship House preservations, and served as Stationmaster at the Tuckahoe Railroad Station for holiday train trips; and

WHEREAS, in addition Douglass also served on the Ocean City Historical Museum Board for 11 years retiring in 2018 as a Trustee Emeritus, on the Cape May County Culture and Heritage Commission as liaison with the aforementioned historical preservation groups, and as a Cape May County poll worker for many years; and

WHEREAS, Douglass was an avid photographer with many of his photos published in local newspapers, and among his other diverse lifelong interests and hobbies were his love of planes, trains, automobiles, the military, history, jazz and big band music, and he was a member of the Patcong Valley Model Railroad club, the New England MGTD Society and the American Legion; and

WHEREAS, Douglass will always be remembered and respected for being a kind and gentle man of character and dedication, and faithful and conscientious in his service to others; and

WHEREAS, it is just and deserving that on behalf of the residents of Upper Township, we honor and celebrate the inspiring life of our fellow citizen and friend Douglass; and

WHEREAS, the Township of Upper's Risk Management Consultant has confirmed that the Upper Township Rescue Squad Trunk or Treat event is covered and insured under the Township of Upper's Join Insurance Fund policy; and

WHEREAS, the Upper Township Rescue Squad has represented that approvals have been or will be obtained from the New Jersey State Police, and any or all other governmental agencies or entities having any jurisdiction or interest in the Trunk or Treat event; and

- 1. The allegations of the preamble are incorporated herein by this reference.
- 2. The Township Committee does hereby grant approval, to the extent that it has jurisdiction to do so, to the Upper Township Rescue Squad for a Trunk or Treat event to be held at Amanda's Field on October 26, 2021 (rain date October 27, 2021), as specified in this Resolution and in the accompanying Exhibits subject to and conditioned upon the following:
 - (A) The event described in this Resolution is carried out by the Upper Township Rescue Squad, hereinafter "event sponsor". The event sponsor shall not, in any way, directly or indirectly, represent that the Trunk or Treat event is, in any way, associated with or affiliated with the Township of Upper and shall make clear that the event is carried out with all appropriate governmental and other approvals. Although the Township of Upper has given permission, subject to the terms of this Resolution, to the event sponsor to conduct the proposed event, it

must be made clear that the event is not and shall not be considered a Township of Upper sponsored or sanctioned event.

- (B) The event sponsor has obtained or will obtain written approval from and comply with all conditions imposed by the following entities:
 - (i) the Risk Management Consultant of the Township of Upper.
 - (ii) the New Jersey State Police.
 - (iii) the Upper Township Division of Emergency Medical Services.

The event sponsor must provide written authorization from the above entities, including any conditions required of said entities, to the Sports and Recreation Office at least seven days prior to the event.

- (C) The event sponsor has provided a Use of Facilities Agreement and Indemnification and Hold Harmless Agreement in favor of the Township of Upper, its officials, officers and employees in the form attached hereto as Exhibit "B".
- (D) The approval granted herein is subject to all conditions and stipulations as may be recommended or imposed by the Township's Risk Management Consultant or Insurance Representatives. The Township may revoke this approval if the Event Sponsors fail to comply with any said condition or recommendation or any other condition of this Resolution.
- 3. All Township officials and officers are hereby authorized and empowered to take all action deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.

WHEREAS, Section 26-2.3 of the Code of Upper Township authorizes the Township to hold and sponsor events at Township facilities and charge fees for vendors or others to participate in the event; and

WHEREAS, the Township of Upper desires to hold the Upper Township Fall Haul on October 3, 2021, with operational hours being 12:00 pm until 5:00 pm, at Amanda's Field; and

WHEREAS, appropriate advice and approvals from the Township's Risk Management Consultant, the New Jersey State Police, and the Division of EMS shall be obtained prior to the event; and

WHEREAS, all funds collected from this event by the Township shall be designated to the Upper Township Recreation Trust Fund; and

- 1. The allegations of the preamble are incorporated herein by this reference.
- 2. The Township Committee does hereby authorize the Upper Township Fall Haul to be held on October 3, 2021, at Amanda's Field.
 - 3. The following fees will be charged for participation in the event:
 - A. Food Vendor Fee \$150, per 50 x 15 space.
 - B. Non Food Vendor Fee \$25, per 20 x 20 space.
 - C. Alcohol Vendor Fee \$150
 - D. Show Vehicle Registration FREE (if registered online before 12:00 pm
 October 1, 2021)
 - Event Parking Fee \$5 per vehicle; no vehicles larger than an SUV; no charge for pedestrians.
- 4. All Vendors will be assigned their spaces prior to arrival and will be required to provide their own canopy/tent, table, chairs, electricity, and any other equipment or supplies they may need for their space.

5. All Food and Alcohol Vendors must submit a Certificate of Insurance naming the Township of

Upper, its officials, officers and employees as additional insureds. If a Non Food Vendor currently has insurance

in place, a Certificate of Insurance shall be requested naming the Township of Upper, its officials, officers, and

employees as additional insureds.

6. All Food Vendors shall submit a Temporary Food Vendor Application to the Cape May

County Department of Health and shall follow the "Guidelines for Compliance with Chapter 24, Subchapter 8

Temporary Retail Food Establishments" as established by the Cape May County Department of Health.

7. Applicable Food Vendors shall obtain a Temporary Cooking Vendor Permit through the New

Jersey Department of Community Affairs, Division of Fire Safety.

8. All Alcohol Vendors shall obtain an Off-Premises Event Permit or Wine Festival Permit from

the State of New Jersey Division of Alcoholic Beverage Control and shall fully abide by all provisions of the New

Jersey Alcoholic Beverage Law, State Rules and Regulations, and Municipal Ordinances and Regulations.

Notwithstanding the forgoing the Township may designate a nonprofit organization to provide alcohol for the

event upon obtaining the required permit and in accordance with all applicable laws and regulations.

8. The Township of Upper reserves the right to limit the size, amount, and type of Vendors that

will participate during the event.

9. The Township Administrator shall have the authority to establish such additional rules, terms

or conditions relating to the event as may be appropriate due to safety, cost or efficiency reasons, including any

such terms or conditions recommended by the New Jersey State Police, the Township Department of EMS or the

Township's Risk Management Consultant.

10. All Township officials and officers are hereby authorized and empowered to take all action

deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.
