**RE: AN ORDINANCE REVISING JOB CLASSIFICATIONS AND TITLES AND  
AMENDING CHAPTER V, ENTITLED “PERSONNEL”  
OF THE CODE OF UPPER TOWNSHIP**

**WHEREAS**, the Township Committee of the Township of Upper, finds it necessary to amend Chapter V, entitled “Personnel” of the Code of Upper Township, Sections 5-6.2 and 5-6.3 to modify certain job classifications or job titles to support the continuity of Township business.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

**SECTION 1:** Chapter V, entitled “Personnel” of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, Section 5-6.2 shall be amended and supplemented as follows:

**Add the Following Positions:**

**Assistant Zoning Officer  
Code Enforcement Officer  
Zoning Officer**

**SECTION 2:** Chapter V, entitled “Personnel” of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, Section 5-6.3 shall be amended and supplemented as follows:

**Delete the Following Positions:**

**Code Enforcement Officer  
Deputy Zoning Officer  
Zoning Officer**

**SECTION 3: REPEALER:** All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.

**SECTION 4: SEVERABILITY:** This Ordinance shall be subject to the severability provisions set forth in Section 5-15 of Chapter V of the Code of Upper Township.

**SECTION 5: EFFECTIVE DATE:** This Ordinance shall take effect immediately upon final adoption and publication as required by law.
